She further noted that there have been no influences from the Board of Supervisors, expanded on how the current map will influence the various communities, and reiterated that the consequences go beyond individual elections.*

*Chair Townsend request DCA Andrew Shen provide a report on the consequences for not complying with the April 15<sup>th</sup> deadline to approve a Final Redistricting Map. Chair Townsend request that a list of possible dates for additional meetings be provided for consideration.*

*At the conclusion of the discussion, Chair Townsend declared the matter heard and filed.*

*Chair Townsend requested that Agenda Item Nos. 3 and 4 be called together.*

### **3. Task Force Final Report**

*Member Pierce moved that Item No. 3 be Tabled and considered on Wednesday, April 13, 2022. It was brought to her attention that the matter is already on the agenda for that day; Member Pierce rescinded this motion.*
