#### 1. Call to Order and Roll Call

The Redistricting Task Force met in special session, in-person with remote access and public comment via telephone and videoconference, on Wednesday, April 6, 2022. Chair Reverend Arnold Townsend called the meeting to order at 5:40 p.m.

On the call of the roll, Chair Townsend, Member Jeremy Lee, Member Hernández Gil, Member Pierce, Member Castillon, Member Ho, Member Cooper, Member Chasel Lee, and Member Reiner were noted present.

A quorum was present.

### 2. Mapping

Member Chasel Lee provided a presentation on mapping and public input, including an overview of the redistricting process, important criteria for redistricting, recognized neighborhoods and communities of interest, compactness, contiguity, census geography, and the next steps for the Task Force. Jaime Clark, Redistricting Consultant (Q2 Data and Research); performed the live line drawing and answered questions raised throughout the discussion.

Chair Townsend recessed the meeting beginning at 8:25 p.m., and reconvened the meeting at 8:43 p.m.

Speakers: Walter Caplan; requested that the Task Force recognize the neighborhoods of Lakeshore Acres and Merced Manor and retain them wholly within District 7.

Naj Daniels; requested that the Task Force recognize the Potrero Hill neighborhood and retain it wholly within District 10.

Jim Warshell; requested that the Task Force retain the central neighborhoods of the existing District 5 together within the new District 5 map.

Allen; shared various concern with the Task Force in regard to the political process and the engagement between voters and elected officials.

Bob Harrer (Barbary Coast Neighborhood Association); endorsed the 4B map and the endorsed the District 3 Neighborhoods United Plan map.

The Task Force directed Q2 Data and Research to explore adjustments to the 4B map as follows:

- Add areas bounded by Harrison Street, 9th Street, and Market Street to District 5:
- Add the area bounded by Post Street, Ellis Street, Gough Street, and Van Ness Avenue to District 2;
- Add the area bounded by Oak Street, Webster Street, Haight Street, Octavia Street, and Gough Street to District 5;
- Add the Yerba Buena Community Benefit District to District 6;
- Add the Cole Valley neighborhood to District 8;
- Add the area around Kezar Stadium within Golden Gate Park to District 8; and
- Add portions of the HOPE SF sites in Potrero Hill to District 10.

Member Hernández Gil, seconded by Member Pierce, moved that the Japantown Cultural District be included wholly within District 5. The motion failed by the following vote:

- Ayes: 4 Jeremy Lee, Hernández Gil, Pierce, Reiner
- Noes: 5 Castillon, Townsend, Ho, Cooper, Chasel Lee

Member Hernández Gil, seconded by Member Jeremy Lee, moved that areas south of Sloat Boulevard be moved into District 7 and that the District 4 boundaries in the Inner Sunset be moved eastward. The motion failed by the following vote:

- Ayes: 4 Jeremy Lee, Hernández Gil, Pierce, Cooper
- Noes: 5 Castillon, Townsend, Ho, Chasel Lee, Reiner

Member Hernández Gil, seconded by Member Pierce, moved that Potrero Hill be included wholly within District 10 with a boundary at 16th Street. The motion carried by the following vote:

- Ayes: 5 Jeremy Lee, Hernández Gil, Pierce, Townsend, Cooper
- Noes: 4 Castillon, Ho, Chasel Lee, Reiner

Member Castillon, seconded by Member Chasel Lee, moved that the Yerba Buena Community Benefit District be included wholly within District 6, and that areas bounded by Carolina Street, 22nd Street, and Interstate 280 be added to District 10. Due to the fact that the previous motion prevailed, the portion of this motion which pertains to areas within Potrero Hill are mooted. The motion carried by the following vote:

- Ayes: 5 Castillon, Townsend, Ho, Chasel Lee, Reiner
- Noes: 4 Jeremy Lee, Hernández Gil, Pierce, Cooper

Member Pierce, seconded by Member Jeremy Lee, moved that Treasure Island be included in District 3. The motion failed by the following vote:

- Ayes: 3 Jeremy Lee, Hernández Gil, Pierce
- Noes: 6 Castillon, Townsend, Ho, Cooper, Chasel Lee, Reiner



The motion failed by the following vote:

- Ayes: 3 Jeremy Lee, Hernández Gil, Pierce
- Noes: 6 Castillon, Townsend, Ho, Cooper, Chasel Lee, Reiner

Member Castillon reported that he recently met with the A. Philip Randolph Institute. Member Chasel Lee reported that he recently met with San Francisco Rising, the Barbary Coast Neighborhood Association, the Pacific Avenue Neighborhood Association, and the Russian Hill Neighborhood Association. Member Pierce reported that she recently met with San Francisco Rising, advocates from Russian Hill and Districts 1, 7 10, and 11. Vice Chair Reiner reported that she recently met with community advocates from Japantown, the Russian Hill Neighborhood Association, and the Valencia Merchants Association. Chair Townsend reported that he recently met with advocates Districts 10 and 5, San Francisco Rising, and SOMA Pilipinas.

### 6. Approval of Minutes from the Special Meeting of March 26, 2022

### 7. General Public Comment

David Pilpel; requested that the Task Force retain the Tenderloin and Central SOMA neighborhoods together in District 6. Speaker; shared concerns regarding transparency in the redistricting process.
