#### 1. Call to Order and Roll Call

*The Redistricting Task Force met in special session, in-person with remote access and public comment via telephone and videoconference, on Thursday, April 7, 2022. Vice Chair Ditka Reiner called the meeting to order at 3:11 p.m.*

*On the call of the roll, Chair Townsend, Member Jeremy Lee, Member Hernández Gil, Member Pierce, Member Castillon, Member Ho, Member Cooper, Member Chasel Lee, and Member Reiner were noted present. Chair Townsend was noted not present.*

*A quorum was present.*

*Chair Townsend was noted present at 3:43 p.m.*

#### 2. Mapping

*Member Chasel Lee provided a presentation on mapping and public input, including an overview of the redistricting process, important criteria for redistricting, recognized neighborhoods and communities of interest, compactness, contiguity, census geography, and the next steps for the Task Force. Andrew Shen, Deputy City Attorney (Office of the City Attorney); Jaime Clark, Redistricting Consultant (Q2 Data and Research); answered questions raised throughout the discussion.*

- **Add part of Mint Hill east of Guerrero Street to District 9;**
- **Add the area bounded by Fredrick Street, Buena Vista West around the north side of Buena Vista Park, Waller Street, Steiner Street, Hermann Street, Buchanan Street, Haight, Street, and Octavia Street to District 5;**
- **Add the Dogpatch south of Mariposa Street to District 10;**
- **Move the District 3 southern boundary to Market Street toward the Ferry Building; and**
- **Add the area bounded by Market Street, 8th Street, Mason Street, and Geary Boulevard to District 6.**

*Member Pierce, seconded by Member Ho, moved to adopt the changes to the 4BA map proposed by Member Chasel Lee above, and send the map as adjusted to the Task Force for further consideration on April 8, 2022. Prior to the roll call on the motion, Member Pierce withdrew the motion, and a vote was not taken.*

*Member Castillon, seconded by Member Ho, moved that the 4BA map be adjusted to include the Dogpatch neighborhood and the southern waterfront south to Islais Creek in District 6. Prior to the roll call on the motion, Member Castillon withdrew the motion, and a vote was not taken.*



**Member Pierce, seconded by Member Ho, moved to adopt the changes to the 4BA map proposed by Member Chasel Lee on Page 8 above, and send the map as adjusted to the Task Force for further consideration on April 8, 2022. Member Hernández Gil offered a friendly amendment to this motion to add the Western Addition and Panhandle neighborhoods to District 5. The motion failed by the following vote:**

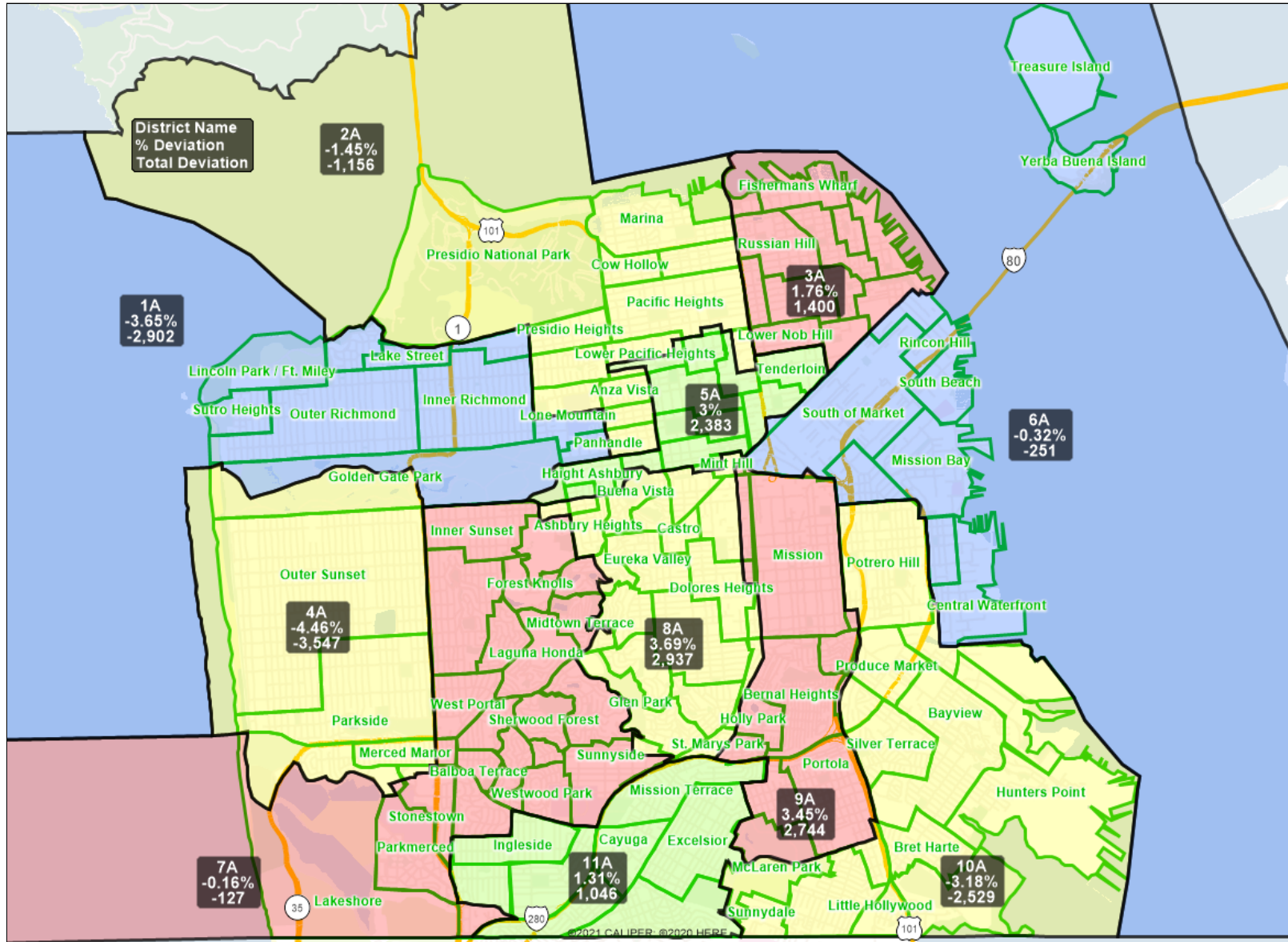

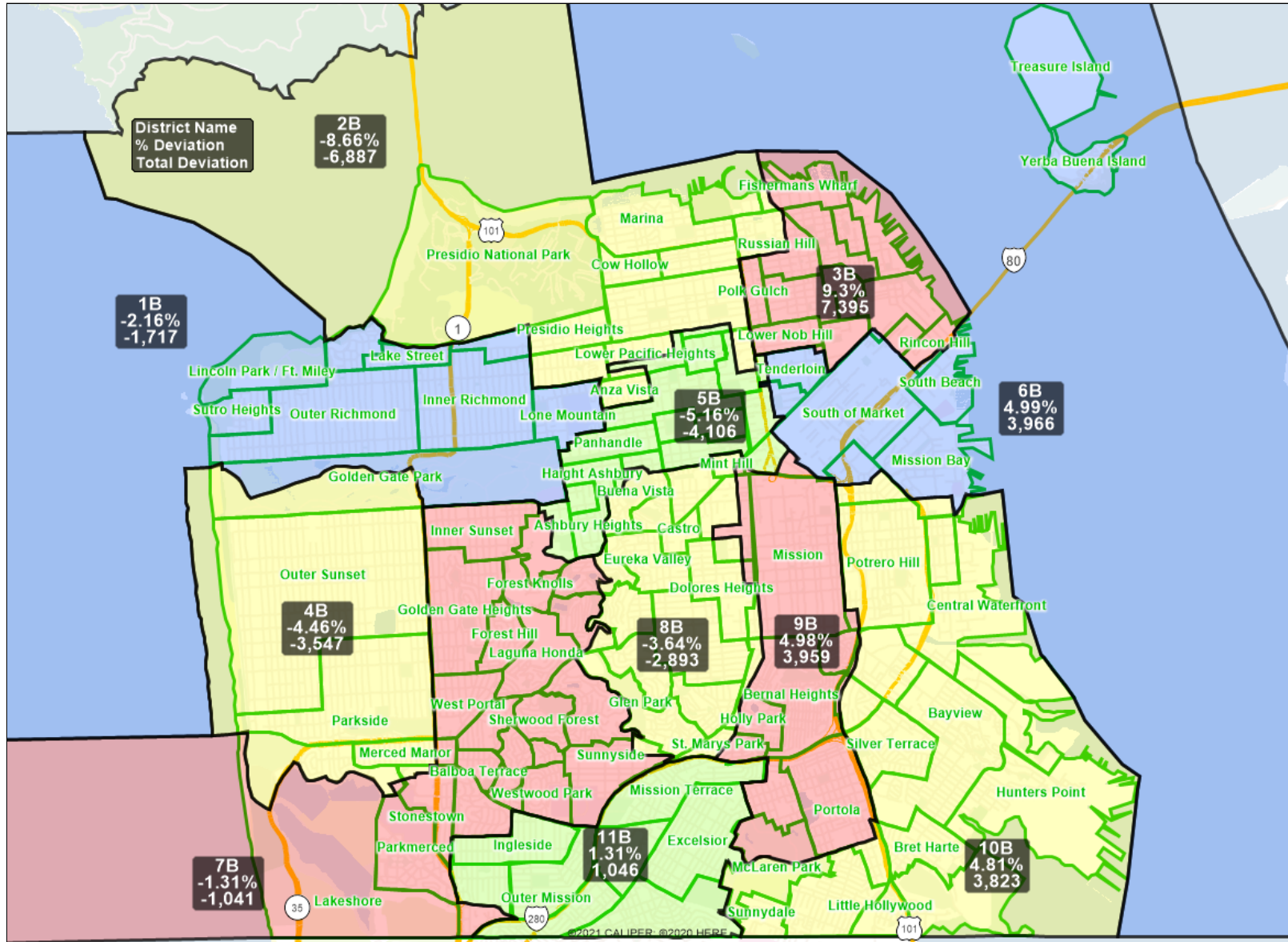

### 3. General Public Comment

*Speakers: Jaime Deloria; shared concerns about the tone and intensity of public comment to the Task Force and offered thanks to the Task Force and the staff for their work. William Walker; shared observations about the map he has prepared for the Task Force's consideration and encouraged the Task Force to continue line drawing. David Elliott Lewis; shared various concerns about transparency in the redistricting process and concerns that the Task Force is not responding to the public input. Elanor Cox; shared various observations about the language diversity of the city, and requested that the Task Force include the Inner Sunset neighborhood in District 4 rather than District 7. J. R. Eppler; offered thanks for the work of the Task Force and shared an observation that the Dogpatch Green Benefit District community of interest layer isn't displaying on the map viewer. Gloria Berry; shared concerns about the accessibility of the redistricting map drawing tools and requested that the Task Force include the Chase Center in District 10. Erick Arguello (Calle 24 Latino Cultural District); requested that the Task Force set a western boundary for District 9 at Guerrero Street. Richard Cardillo (Russian Hill Neighbors); requested that the Task Force include the Russian Hill neighborhood in District 3. Speaker; shared various concerns with the Task Force. Majeid Crawford; shared concerns about the impacts of retaining the neighborhoods of eastern SOMA together in one supervisorial district. Speaker; requested that the Task Force consider future growth of the district populations throughout the city when finalizing the new maps. Leilani; recommended that the District 3 boundaries be moved westward. DeAnthony Jones; shared various concerns about the Voting Rights Act and the redevelopment process throughout the city. Kevin Ortiz; requested that the Task Force set a western boundary for District 9 at Guerrero Street and requested that the Task Force not divide communities of interest as defined by the communities. Francisco Herrera; requested that the Task Force set a western boundary for District 9 at Guerrero Street and endorsed the Community Unity map submitted by the SF Unity Map Coalition. Larissa Pedroncelli (United to Save the Mission); requested that the Task Force set a western boundary for District 9 at Guerrero Street and requested that the Task Force recognize the Latinx cultural roots of the Mission District. Alyssa Jones-Garner; requested that the Task Force consider the priorities of the established communities of the city during the redistricting process.*

*At the conclusion of the discussion, Chair Townsend declared the matter heard and filed.*
