1. Call to Order and Roll Call

The Redistricting Task Force met in special session, in-person with remote access and public comment via telephone and videoconference, on Friday, April 8, 2022. Chair Reverend Arnold Townsend called the meeting to order at 3:47 p.m.

On the call of the roll, Chair Townsend, Member Jeremy Lee, Member Hernández Gil, Member Pierce, Member Castillon, Member Ho, Member Cooper, Member Chasel Lee, and Member Reiner were noted present.

A quorum was present.

At the request of Chair Townsend, Vice Chair Reiner assumed the Chair pro tem at 3:48 p.m.

Chair Townsend was noted not present at 3:48 p.m.

Chair Townsend was noted present at 5:15 p.m.

2. Mapping

Andrew Shen, Deputy City Attorney (Office of the City Attorney); provided a brief summary of the deadlines impacting the drafting and approval of the Final Draft map. Jaime Clark, Redistricting Consultant (Q2 Data and Research); conducted the live line drawing and answered questions raised throughout the discussion.

Erick Arguello; requested that the Task Force retain the Tenderloin and Central SOMA neighborhoods together in one supervisorial district and establish a western boundary for District 9 at Guerrero Street.

Mr. Mendoza (Calle 24 Latino Cultural District); requested that the Task Force establish a western boundary for District 9 at Guerrero Street and retain the American Indian Cultural District wholly within one supervisorial district.

Speaker; shared concerns regarding transparency in the redistricting process.

Michael Smith; endorsed the 4D map as pertains to the Tenderloin and Central SOMA neighborhoods.

Speaker; requested that the Task Force retain the Tenderloin, Central SOMA, and Treasure Island neighborhoods together in one supervisorial district with a western boundary at Polk Street, and shared concerns regarding transparency in the redistricting process.

Speaker; requested that the Task Force retain the Potrero Hill neighborhood wholly within District 10.

Speaker; requested that the Task Force retain the Potrero Hill neighborhood wholly within District 10.

Speaker; shared various concerns with the Task Force.

Pat Smith; requested that the Task Force retain the central neighborhoods of the existing District 5 together within the new District 5 map and shared concerns regarding transparency in the redistricting process.

Raquel Redondiez (SOMA Pilipinas); requested that the Task Force retain the Tenderloin and Central SOMA neighborhoods together in one supervisorial district.

David Woo (SOMA Pilipinas); requested that the Task Force retain the Tenderloin and Central SOMA neighborhoods together in one supervisorial district and shared various concerns about the emerging communities of eastern SOMA.

Curtis Bradford, Co-Chair (Tenderloin Peoples Congress); endorsed the 5B map, requested that the Task Force retain the Tenderloin and Central SOMA neighborhoods together in District 6, and shared concerns regarding transparency in the redistricting process.

Rosaria Cervantes; endorsed the 4D and 5B maps, and requested that the Task Force include the Oceanview, Merced Heights, and Ingleside (OMI) neighborhoods in District 11.

Francisco Herrera; endorsed the 5B map with adjustments to the western boundary of District 9 requested that the Task Force include the Seacliff neighborhood and Lake Street corridor in District 2 rather than District 1.

Jaime Deloria; requested that the Task Force retain the Tenderloin and Central SOMA neighborhoods together in one supervisorial district and shared various concerns about the emerging communities of eastern SOMA.

Speaker; requested that the Task Force recognize the Visitacion Valley and Portola neighborhoods and retain them wholly within on supervisorial district.

Alice Mosley; shared concerns regarding transparency in the redistricting process.

Brian Quan; requested that the Task Force draw district lines to equalize the voting power among supervisorial districts and requested that the Task Force include the Seacliff, Presidio Terrace, and Jordan Park neighborhoods in District 1 rather than District 2.

Steve Leeds; endorsed the 4D and 5B maps and offered opposition to the 4B map, shared concerns regarding transparency in the redistricting process, requested that the Task Force include the Seacliff neighborhood in District 2 rather than District 1, requested that the Task Force retain the central neighborhoods of the existing District 5 together within the new District 5 map.

Walter Caplan; requested that the Task Force retain the Lakeshore Acres and Merced Manor neighborhoods and retain them within District 7 rather than District 4, and requested that the Task Force consider future population growth during the redistricting process.

Joseph Smooke (Richmond District Rising); suggested that the District 1 boundaries should expand toward the east toward the Anza Vista neighborhood, and requested that the Task Force include the Seacliff and Presidio Heights neighborhoods in District 2 rather than District 1, with the Lone Mountain neighborhood in District 1.

Cynthia (Chinese Progressive Association); endorsed the 5B map as pertains to the District 3 boundaries, and requested that the Task Force include the Russian Hill neighborhood in District 2 rather than District 3.

Sophia Andary; requested that the Task Force include the Seacliff and Presidio Terrace neighborhoods in District 2 rather than District 1, and suggested that the Lone Mountain neighborhood be included in District 1.

Lori Yamauchi (Japantown Task Force); requested that the Task Force recognize the Japantown community and retain it wholly within District 5 along with the Western Addition with a northern boundary of California Street.

Denise; offered opposition to the 5A map as pertains to the District 5 boundaries, and endorsed the 5B map.

Susan Vaughn; endorsed the 5B map and requested that the Task Force include the Seacliff and Presidio Terrace neighborhoods in District 2 rather than District 1.

John DeCastro; endorsed the 5B map and requested that the Task Force recognize the Showplace Square, Dogpatch, and Potrero Hill neighborhoods and retain them wholly within one supervisorial district.

Julie Pitta; shared various concerns with the Task Force.

Alice; requested that the Task Force recognize the Dogpatch and Potrero Hill neighborhoods and retain them wholly within one supervisorial district.

Susan; endorsed the 5B map and requested that the Task Force retain the central neighborhoods of the existing District 5 together within the new District 5 map.

Philippe Sonne; endorsed 5A map and the District 3 Neighborhoods United Plan map, and offered opposition to the 5B map as pertains to the District 3 boundaries.

Oliver Saria; endorsed the 5B map.

Speaker; requested that the Task Force retain the central neighborhoods of the existing District 5, including the Panhandle, together within the new District 5 map.

Peter Warfield; offered opposition to the 5A and 5B maps as pertain to the southern boundaries of District 5.

William Owen; shared various concerns with the Task Force.

Chair Townsend recessed the meeting beginning at 8:13 p.m., and reconvened the meeting at 9:16 p.m.

Member Hernández Gil proposed an informal, non-binding straw poll of the Task Force to determine which map—5A or 5B—should be the subject of the live line drawing exercise. By a show of hands, the Task Force selected the 5A map, with members Reiner, Townsend, Castillon, Ho, Cooper, and Chasel Lee raising their hands.

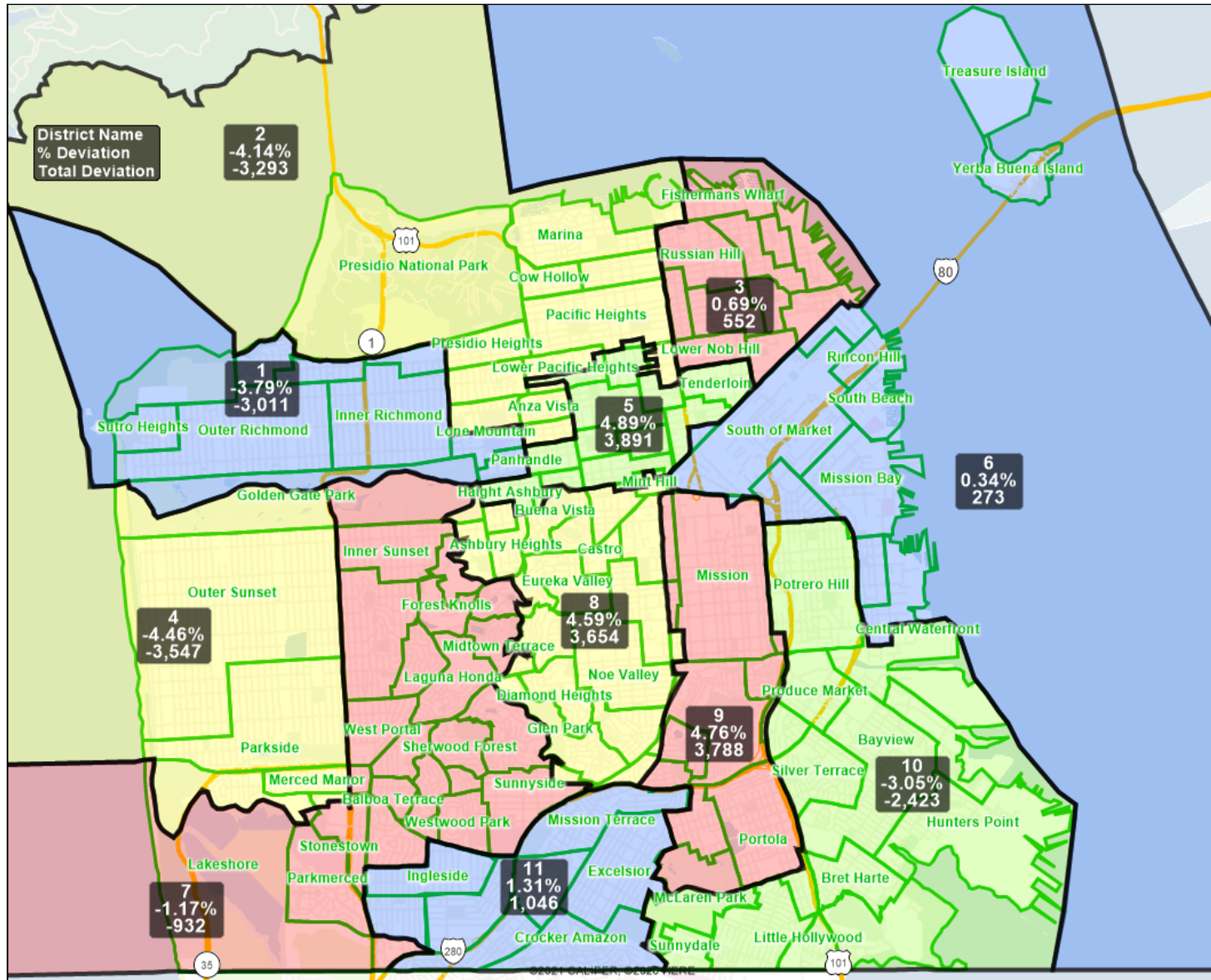
The Task Force requested Q2 Data and Research to make the following adjustments to the 5A map, in order:

- **Add the area bounded by Fulton Street, Divisadero Street, Oak Street, and Masonic Avenue to District 5;**
- **Add the area bounded by Geary Boulevard, Gough Street, Post Street, and Laguna Street to District 2;**
- **Add the area bounded by Sutter Street, Octavia Boulevard, Bush Street, and Gough Street to District 2;**
- **Add the Farallon Islands to District 4;**
- **Add the Aquatic Park and Fort Mason north of Bay Street to District 2;**
- **Add the area bounded by Market Street, Grove Street, and Van Ness Avenue to District 6;**
- **Add the southern Dogpatch neighborhood to District 10, with a boundary at 22nd Street;**
- **Add the Cole Valley neighborhood and Kezar Stadium within Golden Gate Park to District 8, with a boundary at Waller Street;**
- **Add the Bernal Heights neighborhood wholly to District 9, using the boundaries in the city’s definition of the neighborhood;**
- **Add Mint Hill north of Duboce Street and west of Valencia Street to District 8;**
- **Add part of Golden Gate Park north to JFK Drive to District 7;**
- **Add the Lakeside Presbyterian Church to District 4;**
- **Add areas in northeast Parnassus Heights to District 8;**

- **Add areas bounded by 24th Street, Valencia Street, and Guerrero Street to District 9;**
- **Add Mission Dolores to District 8—the area bounded by Duboce Street, Valencia Street, Clinton Park, and Guerrero Street;**
- **Add the area bounded by Laguna Street, Waller Street, Octavia Boulevard, and Haight Street to District 5;**
- **Add the area bounded by San Jose Avenue and Tiffany Avenue south of Duncan Street to District 8;**
- **Add the area bounded by 11th Street, Harrison Street, Alameda Street, Treat Avenue, and Division Street to District 6;**
- **Add a small wedge of land west of Interstate 280 and north of Mariposa Street to District 10; and**
- **Add the Dogpatch neighborhood to District 6, with boundaries on Interstate 280, Iowa Street, 25th Street, Indiana Street, Cesar Chavez, Illinois Street, and 25th Street to the water.**

Jaime Clark, Redistricting Consultant (Q2 Data and Research); offered that she would save the changes made to the 5A map and that the result would be titled Map 6. Map 6 appears on the following page of these minutes.

4. General Public Comment

Jason Lee; requested that the Task Force include the Russian Hill neighborhood in District 2, Glen Park in District 8, Cole Valley within District 5, the Inner Sunset west of 14th Avenue in District 4, and retain the Tenderloin neighborhood within District 6. Bob Goldfarb, Executive Director (Leather LGBTQ Cultural District); requested that the Task Force include the Transgender Cultural District in District 6. Majeid Crawford; requested that the Task Force include the Tenderloin and SOMA neighborhoods together in District 6 and suggested that the Task Force consider taking a bit out of the emerging neighborhoods of eastern SOMA. J.R. Eppler; requested that the Task Force retain the Potrero Hill, Dogpatch, and Showplace Square neighborhoods together in District 10. William Walker; requested that the Task Force consider the map he submitted to the Task Force on April 8, 2022 and suggested that the Black communities of interest live in Districts 5, 6 10, and 11. Speaker; requested that the Task Force include a tally for the comments in support of the various maps. David Pilpel; supported the changes to the 5A map and suggested that there is still time to make improvements to the map. Jupiter Peraza (Transgender Cultural District); requested that the Task Force keep both the Transgender Cultural District and the Tenderloin neighborhood whole. Michael Nulty; shared various concerns with the Task Force in regard to representative government. Josephine; requested that the Task Force include the Inner Sunset neighborhood west of 14th Avenue in District 4, and requested that the Task Force unite the Portola and Visitacion Valley neighborhoods in District 10.

At the conclusion of the discussion, Chair Townsend declared the matter heard and filed.

5. Adjournment

There being no further business, the Redistricting Task Force adjourned at the hour of 11:26 p.m.
