**PUBLIC COMMENT: None** 

Executive Director Grier called attention to the updated remote meeting resolution California Government Code Section 54953(e) also known as AB361 which empowers local policy bodies to convene by teleconferencing technology during a proclaimed state of emergency under the State Emergency Services Act – vote passed unanimously

#### **PUBLIC COMMNT:**

**ITEM 1.0 IMPLEMENTATION COMMITTEE BUSINESS** – Discussion of structure of the Implementation Committee led by Committee Chair Banuelos. He wants develop an implementation plan out of the committee; discussed possible meeting time and date change

**PUBLIC COMMENT:** Wynship stated that staff can work overtime regarding minutes

**1.1** Motion to accept unadopted February 9, 2022 minutes, motioned by Commissioner Jackson-Lane, seconded by Commissioner Parks; vote passed unanimously

**PUBLIC COMMENT:** Wynship stated he did not have time to review minutes

**1.2** Commissioner to review and revote on added section to the resolution originally authored by Co-Chair Vigil and Liza Murawski (a member of the public); motion to move resolution on to executive committee offered by Commissioner Parks, seconded by Commissioner Jackson-Lane

**PUBLIC COMMENT:** Wynship feels that the resolution needs more work and wrote an 8 page response

**1.3** A motion was put forth by Commissioner Jackson-Lane to move the recently revised by-laws on to the executive committee; seconded by Commissioner Parks; vote passed unanimously

**PUBLIC COMMENT:** Wynship stated that these are horrible by-laws; says article IV, item 3 is a bad idea and should be struck as should be item 5 and item 8; he still claims that BHC does not have quorum to pass bylaws
