Dianna C. asked regarding heading budget definitions, discussions at the SFUSD PAC regarding the headline for the breastfeeding to rename to breast/chest lactation to be more equitable. As SDDTAC continues to discuss budget recommendations to put that forward for future consideration.

- 7. SDDT Grantee Presentations [Discussion and Possible Action] 20 minutes
 - a. Bounce Back Generation

Jennifer Dhillon and Shankel McNeal introduce the work of Bounce Back Generation (BBG) help people bounce back from negative effects and toxic trauma by creating and sharing practical tools, training, and media that foster resilience for this generation and next.

In 2019 BBG started out with the Sweet Communities grant in person nutrition classes. In 2020, BBG continued to address mental health challenges and how to build resilience factors. BBG addresses chronic disease through the lens of untreated trauma, toxic stress and chronic stress conditions and can lead to heart disease, diabetes, pulmonary disease, renal failure, some cancers, suicide, STDS, accidents, broken bones, weakened immune response, mental health problems, etc.

BBG uses the 6 building blocks for resilience: protection, relationship, coping skills, can-do attitude, belonging and storytelling. These building blocks support to build resilience for ourselves and others (especially children) to support and prevent effects for the next generation.

BBG's SDDT grant was able to support the creation of BBGTV.org , a curated experience to walk through the building blocks videos and learn more about how to build resilience with the

community. Small Powerful Things Podcast: monthly podcast on how to manage stress, etc. My Journey Journal – focusing on an aspect of building resilience including BBG's 6 Building Blocks for Resilience.

BBG added that their challenges include, not enough income, amplifying their work, especially with youth, BBGTV, and keeping peer staff.

b. Farming Hope

Jamie Stark, Farming Hope's Executive Director provides overview of Farming Hope of providing access to healthy food and managed by community over time. Farming Hope is a culinary job training nonprofit with triple impact of paid job training for adults who have been incarcerated and homeless, free nourishing community meals and food recovery. Its goal is for graduates to obtain full-time employment by graduation to stay on track. In the process, apprentices feed neighbors experiencing food insecurity and recover perfectly good food.

SDDT partnership for 2019 – 2020 data: currently 68 apprentices and 63% employment rate, 74,000 community meals provided. Worked with HSA for free groceries. Three locations: Manny's Restaurant, community meals at Refettorio on Fell Street and training garden in the Western Addition.

Andie Sobrepena, Operations Director shared Farming Hope's grocery program, provided a lot of access to fresh produce and thus built a client choice grocery program rather than providing a prescribed box program. Clients can choose the foods they want instead of what is provided which cause food waste. In the future cooking classes, to help balance out the groceries and learning to cook with those groceries. Currently, there are free weekly meals with Compass Family Services and eventually Refetterio to become a community food hub and drop in meals.

SDDTAC comments and questions:

Abby – thanks both organizations for doing the work around resiliency.

Larry – so much empowerment for both organizations and provides inspiration. BBG - where are you your recordings? Do you have plans to enhance technology, what are the needs? Jennifer, BBG responds that filming is done at Potrero Hill public housing. College students were hired and doing videos and high school kids, someone contributing from South Africa. BBG is using a shared editing suite, pod cast done in the office and technology is our next focus, finding that they are competing with meme world and trying to break through with positive messages. Goal is to lead with supportive space and learning deeper messages.

Definitions for the AliahThink Tool [discussion and possible action] 5 minutes Saeeda notes that staff mentioned earlier of budget category definitions being crystalized when using the AliahThink tool. Need to identify if there will be a character limit and be able to review prior documents for previous definitions. SDDTAC can fill definitions that was used from prior documents and determine how to fill some out in order for it to be better articulated when using the AliahThink tool.

 c. AliahThink Tool Recreation and Parks Physical Activity & Wellness and Food Access subsets Pilot - 30 minutes [discussion, participatory demo and possible action]
 The AliahThink Tool has taken 7 or 8 priorities to divide up how members want to prioritize budget recommendations for the Mayor's Office and Board of Supervisors.

Saeeda facilitates a draft/pilot process of the AliahThink tool for Peace Parks, SVIP (Street Violence Intervention Program) and Requity budget categories. One member of each subcommittee participates in the pilot/draft process.

Linda provides overview of SVIP budget category, the transporting of participants to program sites (Sunnydale, Potrero Hill and Bayview Hunter's Point).

Member notes that SVIP transportation is important to have available in a safe manner to whichever program provided by RPD, outside of the Peace Parks Program. The funding provides safety from individuals interacting or becoming put in situations that violence could occur. Linda clarifies that there is also other means of transportation provided by outside sources, such as CBOs, etc.

Participating members provide their draft quantitative numbers as it relates to the respective budget categories.

AliahThink tool pilot sessions will continue in future SDDTAC meetings.
