BUSINESS DESCRIPTION

PO Plus is a retail shipping, mailbox rental, and business services store opened by JD Larson at 584 Castro Street in 1982. For decades, customers have frequented the store to supplement their home offices, notarize important documents, pick up packages, and buy last minute gifts. As one of the oldest LGBTQ+ owned and operated businesses in the Castro, PO Plus not only provides essential neighborhood services, but also contributes to the sense of community and belonging in the area.

PO Plus is a certified Commercial Mail Receiving Agency of the U.S. Postal Service and receives mail for more than 2.000 private mailbox customers. As work-from-home has become increasingly common during the COVID-19 pandemic, customers have turned to PO Plus' suite of computers, printers, fax machines, scanners, and shredders to help conduct business. In recent years, PO Plus has also expanded its gift offerings and card selections to complement its core mail and shipping services.

Affectionately known as the "Gay Post Office," PO Plus has made significant contributions to San Francisco's LGBTQ+ community over its 40-year history. During its early years, because of the perceived stigma of maintaining a mailing address on Castro Street, PO Plus offered customers the option of sending their mail to a PO box on Bryant Street. Owner JD Larson would make the daily trek to retrieve the mail and bring it back to PO Plus so that customers could conveniently pick it up in the Castro. During the height of the AIDS epidemic, PO Plus offered free notary services to residents of Coming Home Hospice. To date, the business has also notarized more than 2,000 domestic partnerships.

PO Plus is an essential member of the Castro Street business community and a longtime supporter of numerous community-serving organizations, including the AIDS Emergency Fund, Castro Community Benefit District, and the Harvey Milk Civil Rights Academy. The business employs a staff of eight people, provides employment opportunities for local high school and college students, and regularly hires from the Positive Resource Center and Castro Country Club.

CRITERION 2

Has the applicant contributed to the neighborhood's history and/or the identity of a particular neighborhood or community?

Yes, PO Plus has contributed to the history and identity of the Castro neighborhood and San Francisco.

The Historic Preservation Commission recommended the applicant as qualifying, noting the following ways the applicant contributed to the neighborhood's history and/or the identity of a particular neighborhood or community:

- 584 Castro Street is located within the boundaries of the California Register-eligible Castro Street Historic District. The district is significant under criterion A as an intact example of a late 19th century streetcar suburb and for its association with San Francisco's LGBTQ+ community in the 1970s.
- Although 584 Castro Street is not currently listed in historic resource registry, it is located in the California Register-eligible Castro Street Historic District.
- Although PO Plus is not explicitly mentioned in the Citywide Historic Context Statement for LGBTQ+ History, 584 Castro Street is identified as the founding location of BiPol, the first bisexual political organization.
- PO Plus has been featured numerous times in the Bay Area Reporter and has received accolades from politicians and organizations including the US Postal Inspection Service, the San Francisco Board of Supervisors, Merchants of Upper Market and Castro, Sisters of Perpetual Indulgence, AIDs Emergency Fund, and former Mayor Gavin Newsom.

CRITERION 3

Is the applicant committed to maintaining the physical features or traditions that define the business, including craft, culinary, or art forms?

Yes, PO Plus is committed to maintaining the physical features and traditions that define the business.

Dear Director Tang,

I am writing to nominate PO Plus to the Legacy Business Registry. PO Plus has provided private mailbox services, retail shipping, and other business services for 40 years at 584 Castro Street. Since its inception, PO Plus has been affectionately known throughout the Castro community as "The Gay Post Office," and has contributed to the history of the Castro community by providing essential services to the neighborhood.

PO Plus first opened its doors in June 1982 and has operated continuously without interruption to the present day. The business was founded by JD Larson, who operated PO Plus until shortly before his death from AIDS in 1994, and subsequently owned by Paul Moffett, John Downey, and currently Stephen Martel.

In addition to providing exceptional mail, shipping, and business services, PO Plus makes significant culturally important contributions to the Castro by maintaining a historical storefront, where the first bisexual political organization, BiPol, was founded in the 1980s. 584 Castro is classified by the Planning Department as Category A, Historic Resource Present.

PO Plus has supported various community serving organizations over the past four decades including the AIDS Emergency Fund, California Democratic Victory Fund, Castro Community Benefit District, Coming Home Hospice, Harvey Milk Civil Rights Academy, the Castro Merchants Association, Pets are Wonderful Support (PAWS), Positive Resource Center, and RealBad/GRGR West.

Given PO Plus' enduring presence in the Castro and their commitment to providing quality, community oriented services, I strongly believe that they would benefit from being a part of San Francisco's Legacy Business Registry, and I want to thank you for your consideration.

Section 4: Written Historical Narrative

CRITERION 1

a. Provide a short history of the business from the date the business opened in San Francisco to the present day, including the ownership history. For businesses with multiple locations, include the history of the original location in San Francisco (including whether it was the business's founding and or headquartered location) and the opening dates and locations of all other locations.

PO Plus, located at 584 Castro Street in the Castro neighborhood, first opened its doors in June, 1982. The original owner, JD Larson, recognized that residents in the Castro needed a safe and reliable place to receive their mail. Mr. Larson operated the business until shortly before his death from AIDS in 1994.

In 1994, business partners Paul Moffett and John Downey purchased the business from the estate of JD Larson.

In 2002, Paul Moffett bought out his business partner, John Downey, and continued to run PO Plus until selling it to Stephen Martel on November 1, 2016. Stephen Martel is the current owner/operator of PO Plus.

PO Plus offers mailbox rentals, retail shipping services, package receiving, packing services, print services, computer rentals, virtual mail, shipping supplies, office supplies, secure shredding, greeting cards, and gift items. PO Plus is an authorized shipper for FedEx, UPS, DHL, and the U.S. Postal Service, which provides a variety of shipping options for its customers.

b. Describe any circumstances that required the business to cease operations in San Francisco for more than six months?

PO Plus has not ceased operations in San Francisco for more than six months.

c. Is the business a family-owned business? If so, give the generational history of the business.

The business is not family-owned.

d. Describe the ownership history when the business ownership is not the original owner or a family-owned business.

The ownership history of PO Plus is as follows:

1982 to 1994: JD Larson

1994 to 2002: Paul Moffett and John Downey

2002 to 2016: Paul Moffett 2016 to Present: Stephen Martel e. Documentation of the existence of the business verifying it has been in operation for 30+ years is provided in this Legacy Business Registry application.

f. Note any other special features of the business location, such as, if the property associated with the business is listed on a local, state, or federal historic resources registry.

The historic resource status of the building at 584 Castro Street is classified by the Planning Department as Category A, Historic Resource Present. The building is a contributor to the Eligible Castro Street Historic District and has also been identified for its association with LGBTQ history.

The first bisexual political organization, BiPol, was founded here in the 1980s. "In her book *Bisexual Spaces*, Clare Hemmings describes the 1983 founding of the first bisexual political organization, BiPol (584 Castro Street, extant), as reflecting a shift in bisexual organizing away from the "revolutionary power of liberatory (bi) sexuality, and toward a more focused identity politics." Viewing themselves as "the political arm of the community," with an explicitly feminist agenda, BiPol sought to increase bisexual visibility and to challenge stereotypes about bisexuality." ¹

CRITERION 2

a. Describe the business's contribution to the history and/or identity of the neighborhood, community or San Francisco.

Since its inception, PO Plus has been affectionately known throughout the Castro community as "The Gay Post Office," a nickname that has endured for nearly four decades. Some of their other taglines throughout the years include, "THE Address on Castro Street"; "Your Neighborhood Connection to the World," and, most recently, "Handling Your Packages with Pride Since 1982."

In the 1980s and 1990s, PO Plus contributed to the history of San Francisco's Castro community by providing essential services to a neighborhood besieged by the AIDS pandemic <u>while</u> <u>simultaneously</u> leading the charge of the International Gay Rights movement. In the early days of PO Plus, there was a perceived stigma of having a mailing address on Castro Street. As a result, JD Larson, (the original owner of PO Plus) rented a PO Box at the Bryant Street post office and allowed customers to use either 584 Castro Street or the anonymous PO Box as their mailing address. During this time, many PO Plus customers chose the anonymous address, resulting in Mr. Larson driving to the Bryant Street post office every day to retrieve mail for his

PO Plus customers. The business still offers this service to several of their legacy customers, although the vast majority have migrated to their Castro Street mailing address.

PO Plus has been a general member of the Castro Merchants since 1994. Previous owner John Downy was active with the organization through the late 1990s, while previous owner Paul Moffett served on the Castro Merchants board from 2002 to 2008, including two years as President (2005 - 2007). Current owner Stephen Martel maintains an active presence for PO Plus at the Castro Merchants Association.

In a 2016 Certificate of Appreciation to PO Plus, the Castro Merchants Association wrote their appreciation for the "stewardship of one of the oldest LGBT owned and operated businesses in the Castro ... for assuring that we were served by the latest technology ... while retaining the valued traditions ... for prioritizing friendly, personalized customer care and first-name customer relations ... for guiding PO Plus through its current ownership transition, and for continuing community based ownership of the store in the Castro."

b. Is the business (or has been) associated with significant events in the neighborhood, the city, or the business industry?

PO Plus is a member of the Castro Merchants Association and participated in the organizing committee for the Castro Community Benefit District.

c. Has the business ever been referenced in an historical context? Such as in a business trade publication, media, or historical documents?

PO Plus has received a number of accolades from various nonprofit organizations and civic leaders, including the following:

- Certificate of Appreciation from US Postal Inspection Service, 2002;
- Certificate of Recognition from State Senator Mark Leno, 2007 and 2012;
- Grass Roots Gay Rights West Outstanding Sponsor Award;
- Board of Supervisors acknowledgment of dedication, commitment, and service to the community, 2007 and 2012;
- Multiple Certificates of Appreciation from Merchants of Upper Market and Castro;
- Certificate of Appreciation from The Sisters of Perpetual Indulgence;
- "PO Plus Day" in San Francisco June 16, 2007;
- Certificate of Honor from Mayor Gavin Newsom, 2008;
- George Burgess Founders Award from AIDS Emergency Fund, 2008;
- Featured multiple times in the Bay Area Reporter newspaper

d. Is the business associated with a significant or historical person?

The ownership of PO Plus is not associated with a "significant" or historical person. However, the business does have a rich history of serving many noteworthy individuals/organizations involved with the LGBTQ rights movement and the HIV/AIDS political awareness movement.

e. How does the business demonstrate its commitment to the community?

Starting under the leadership of Paul Moffett and John Downey, PO Plus has become involved with many local LGBT and HIV/AIDS organizations within San Francisco. Through sponsorships, fundraising, and in-kind donations, PO Plus has been involved with the following organizations:

- AIDS Emergency Fund
- California Democratic Victory Fund
- Castro Community Benefit District
- Coming Home Hospice
- Harvey Milk Civil Rights Academy
- Merchants of Upper Market and Castro ("Castro Merchants")
- Pets are Wonderful Support (PAWS)
- Positive Resource Center
- RealBad / GRGR West

In addition to direct involvement with several specific organizations, many AIDS advocacy groups and gay rights organizations continue to rely on PO Plus for their mail and package receiving, notary services, and copy & print services.

To date, PO Plus has notarized over 2,000 domestic partnerships for our customers. At the height of the AIDS Pandemic, PO Plus offered free notary service to residents of Coming Home Hospice (located in the Castro).

In March 2020, PO Plus was recognized as an "essential business" and remained open throughout the COVID-19 Pandemic. From March 2020 to June 2022, PO Plus did not charge its annual price increase for mailbox rentals, nor did PO Plus deny mailbox services to any customers who could not afford to pay their mailbox rent.

Since February, 2022, PO Plus has collected more than \$2,000 in donations for LGBTQ rights organizations in Ukraine.

PO Plus regularly hires from the Positive Resource Center and the Castro Country Club. And PO Plus hires high school and college students for both summer and year-round work.

f. Provide a description of the community the business serves.

PO Plus primarily serves current and former residents of the Castro community. They also serve visitors/tourists to the neighborhood, many of whom rely on their domestic and international shipping options for sending souvenirs home. Additionally, to keep up with new technologies, PO Plus now offers "virtual mail," which allows the business to serve customers from around the world.

Customers of PO Plus are as diverse as the city of San Francisco and the Castro neighborhood, many of whom are members of the LGBTQ community. The largest customer base comes from their nearly 2,000 mailbox customers. Within that group, PO Plus serves a broad mix of older

customers (those who opened a mailbox in the early 1980s), recent transplants to San Francisco, many HIV/AIDS and LGBTQ non-profit organizations, and a variety of small businesses. PO Plus' home office products attract a broad range of work-from-home customers who need the resources (fax, print, copy, etc.) that the business provides. The pack and ship customers vary from people sending out that last-minute birthday gift to folks on a business deadline and the package needs to arrive by 8:00 a.m. the next day.

In summary, it is challenging to give a general demographic of PO Plus' customer base. Over the past four decades, the demographics, needs, and habits of the Castro neighborhood have changed, and PO Plus has continually risen to meet those changing needs.

g. Is the business associated with a culturally significant building/structure/site/object/interior?

The structure that houses PO Plus is a turn of the century Victorian building that survived the 1906 earthquake. The building exterior currently features a large hand-painted mural commemorating the U.S. Postal Service Harvey Milk stamp.

h. How would the community be diminished if the business were to be sold, relocated, shut down, etc.?

If PO Plus were to close, their staff of eight would be without work, and many of their customers would be left without a safe, secure location to receive packages and mail. The neighborhood would have reduced options for retail shipping, and very limited options for local "work-from-home" support. The loss of their walk-in notary service would provide a challenge for Castro residents who need to have important documents notarized (e.g., civil unions, real estate transactions, estate planning, medical directives, etc.). Residents would also lose out on their carefully curated greeting card and gift selection.

Beyond the practical inconveniences mentioned above, PO Plus is considered by many to be similar to a bar without the alcohol, with their staff acting as bartenders. Just like the popular sitcom, "Cheers!", sometimes you want go where everybody knows your name ... and for many of their customers, PO Plus is that place. For some, PO Plus is just a business where they receive services; for many, however, PO Plus is a place where they come to see a friendly face to chat with about their day. Many of the "regular" customers incorporate a visit to PO Plus into their workday as a simple way to get out of the office for a few minutes to see familiar people (employees and customers) and catch up on the latest news. PO Plus also has plenty of customers who get dragged in by their eager dogs who know where they keep their dog treats, or their child drags them in to see what treasure awaits them in their "children's mailbox."

In short, PO Plus is more than just another mailbox store – its absence from the Castro community would be a significant loss in many ways.

CRITERION 3

a. Describe the business and the essential features that define its character.

Since its inception, PO Plus has been a Commercial Mail Receiving Agency of the U.S. Postal Service, which authorizes PO Plus to receive U.S. mail for its private mailbox (PMB) customers. PO Plus also receives documents and packages for its PMB customers through private carriers, including UPS, FedEx, DHL, Amazon, and other local couriers. As online shopping has gained in popularity, so too has their private mailbox services. Currently, PO Plus receives mail and packages for approximately 2,000 customers in the Castro neighborhood. As mail and package theft continues to rise in San Francisco, their PMB customers rely on PO Plus to provide a safe, trusted, and reliable location to receive important items.

In addition to their popular PMB service, PO Plus offers retail shipping services provided by the U.S. Postal Service, UPS, DHL, and UPS. Their customers appreciate the ability to select among a variety of shipping options to fit their personal and professional needs. PO Plus also offers pack and ship services, making it easy for customers to bring in unique items for their staff to safely pack for shipping or storage. PO Plus also serves as a convenient drop-off location for customers wishing to return items with pre-paid shipping labels from UPS, DHL, FedEx, Amazon, and the US Postal Service.

As the "work from home" movement continues to gain momentum during the COVID-19 pandemic, many Castro residents have come to reply upon PO Plus for the business services that they offer. Their self-serve computers, photocopiers, scanners, secure document shredders, and fax machine all help to supplement the home office needs for their neighbors who no longer travel to an office for work.

As one of the few businesses offering notary services in the neighborhood, their notaries are knowledgeable and busy. Prior to the legalization of same-sex marriage, PO Plus was the go-to location for members of the community to have their civil unions notarized. To date, more than 2,000 couples have used the notary service at PO Plus to finalize their civil union paperwork!

With the closing of several specialty greeting card stores in the Castro, PO Plus has expanded its greeting card selection and small gift offering. With an emphasis on unique and locally sourced products, PO Plus has become a go-to destination in the neighborhood for distinctive and quirky gifts for that hard-to-buy-for friend.

b. How does the business demonstrate a commitment to maintaining the historical traditions that define the business, and which of these traditions should not be changed in order to retain the businesses historical character? (e.g., business model, goods and services, craft, culinary, or art forms)

PO Plus is committed to maintaining its historical tradition as a retail shipping and mailbox rental store.



Castro's P.O. Plus Has Officially Changed Hands

Back in early October, Paul Moffett of Castro Street's <u>P.O. Plus</u> informed us that he was in the process of selling his shipping and mailing store to a new owner. As of this afternoon, the

building's landlord has signed off, finalizing the transfer.

Originally opened in 1982, P.O. Plus is one of the neighborhood's oldest gay-owned and operated businesses. Moffett, who's owned it since 1994, says that legacy will continue under new owner Steve Martel.

Previously a medical sales rep, Martel has been a P.O. Plus customer for more than 12 years.

"I still remember how friendly everyone was," he says of his first visit to the store. "The guys who were working here, were very nice, and held my hand with whatever I needed. And that was the case every time I came back."



Moffett made the decision to sell P.O. Plus so that he can eventually be closer to his partner, who lives in Chicago. "I thought I'd test the waters, and see if there was any interest in having someone buy the store," he said.

Within a week, he'd received multiple offers. "My biggest desire was that we would keep the store in the community," he said, and as a longtime customer, Martel was an ideal fit.



Martel admits that he still has some learning to do when it comes to shipping and packaging. "The first thing I need to do is to learn our back-of-house operations," said Martel. "I'll slowly get behind the counter."

But Moffett, as well as the store's employees, will be there to help bridge the gap. "I'm not going anywhere for

some time," said Moffett. "I'll be working closely with Steve to ensure that customer experience remains at the high level that customers expect. Everything will stay the same, except someone different will be signing the paychecks."

"Coming in here has always been a pleasant experience, no matter how short or long, that experience lasted in my day," said Martel, who says he'll work hard to maintain P.O. Plus' reputation for strong customer service.

"It's a huge responsibility to step into this position," he added. "P.O. Plus is a successful, well-known businesses that people use as a touchstone in their lives here in the Castro. To carry on the legacy that Paul has created is really exciting."

Business Description

PO Plus is a retail shipping, mailbox rental, and business services store opened by JD Larson at 584 Castro Street in 1982. For decades, customers have frequented the store to supplement their home offices, notarize important documents, pick up packages, and buy last minute gifts. As one of the oldest LGBTQ+ owned and operated businesses in the Castro, PO Plus not only provides essential neighborhood services, but also contributes to the sense of community and belonging in the area.

PO Plus is a certified Commercial Mail Receiving Agency of the U.S Postal Service and receives mail for more than 2,000 private mailbox customers. As work-from-home has become increasingly common during the COVID-19 pandemic, customers have turned to PO Plus's suite of computers, printers, fax machines, scanners, and shredders to help conduct business. In recent years, PO Plus has also expanded its gift offerings and card selections to complement its core mail and shipping services.

Affectionately known as the "Gay Post Office," PO Plus has made significant contributions to San Francisco's LGBTQ+ community over its forty-year history. During its early years, because of the perceived stigma of maintaining a mailing address on Castro Street, PO Plus offered customers the option of sending their mail to a PO box on Bryant Street. Owner JD Larson would make the daily trek to retrieve the mail and bring it back to PO Plus so that customers could conveniently pick it up in the Castro. During the height of the AIDS epidemic, PO Plus offered free notary services to residents of Coming Home Hospice. To date, the business has also notarized more than 2,000 domestic partnerships.

PO Plus is an essential member of the Castro Street business community and a longtime supporter of numerous community-serving organizations, including the AIDS Emergency Fund, Castro Community Benefit District, and the Harvey Milk Civil Rights Academy. The business employs a staff of eight people, provides employment opportunities for local high school and college students, and regularly hires from the Positive Resource Center and Castro Country Club.

The business is located at 584 Castro Street in a Category A (Historic Resource Present) structure on the west side of Castro Street between 18th and 19th streets in the Castro/Upper Market neighborhood. It is within the NCD (Castro Street Neighborhood Commercial) Zoning District, a 40-X Height and Bulk District, the Castro Cultural District, and the California Register-eligible Castro Street Historic District.

Staff Analysis

Review Criteria

1. When was business founded?

The business was founded in 1982.

2. Does the business qualify for listing on the Legacy Business Registry? If so, how?

Yes. PO Plus qualifies for listing on the Legacy Business Registry because it meets all of the eligibility Criteria:

- a. PO Plus has operated continuously in San Francisco for 40 years.
- b. Po Plus has contributed to the history and identity of the Castro neighborhood and San Francisco.
- c. PO Plus is committed to maintaining the physical features and traditions that define the organization.
- 3. Is the business associated with a culturally significant art/craft/cuisine/tradition?

No.

4. Is the business or its building associated with significant events, persons, and/or architecture?

Yes. 584 Castro Street is located within the boundaries of the California Register-eligible Castro Street Historic District. The district is significant under criterion A as an intact example of a late 19th century streetcar suburb and for its association with San Francisco's LGBTQ+ community in the 1970s.



5. Is the property associated with the business listed on a local, state, or federal historic resource registry?

No. Although 584 Castro Street is not currently listed in historic resource registry, it is located in the California Register-eligible Castro Street Historic District.

6. Is the business mentioned in a local historic context statement?

Although PO Plus is not explicitly mentioned in the Citywide Historic Context Statement for LGBTQ+ History, 584 Castro Street is identified as the founding location of BiPol, the first bisexual political organization.

7. Has the business been cited in published literature, newspapers, journals, etc.?

Yes. PO Plus has been featured numerous times in the Bay Area Reporter and has received accolades from politicians and organizations including the US Postal Inspection Service, the San Francisco Board of Supervisors, Merchants of Upper Market and Castro, Sisters of Perpetual Indulgence, AIDs Emergency Fund, and former Mayor Gavin Newsom.
