BUSINESS DESCRIPTION

Hotel Bohème is a boutique hotel located in the heart of the North Beach neighborhood. Prominently situated on Columbus Avenue, the hotel offers a welcoming respite for travelers with thoughtfully designed suites that pay homage to San Francisco's Beat Movement.

Hotel Bohème is steeped in San Francisco history. The original structure was built in the 1880s by an Italian immigrant family, the Capurros. The building offered lodgings and rooms on the upper floors and retail on the ground level. The 1906 earthquake and subsequent fires unfortunately destroyed most of North Beach including the Capurro's property. That same year, the Capurro family was able to rebuild with the assistance of Mooser and Milwain, Architects. The exterior of the hotel was reconstructed to align with the Italianate architectural style. After construction was complete, the building continued to operate as lodgings. The Capurro heirs own the building to this day and lease the property to the owner of Hotel Bohème, Joel Morgenstern.

Hotel Bohème was established by Joel Morgenstern in 1991. Inspired by the writers and artists of the Beat Generation, Mr. Morgenstern envisioned the interior of Hotel Bohème as a stylized recreation of the late 1950s. He hired a local design firm, Candra Scott & Anderson Interior Design, to craft the interior of the hotel.

The rooms in Hotel Bohème are thoughtfully arranged with cast iron beds, large mirrored armoires and memorabilia recalling the Beat Generation. The hotel highlights this unique San Francisco epoch through design details including the display of 35 museum quality photographs taken in North Beach by Jerry Stoll. These photographs beautifully and poetically depict the Beat era in North Beach during the 1950s and 1960s. Members of the public are welcome to come into the hotel to see the magnificent collection of Jerry Stoll photographs documenting life in North Beach.

CRITERION 2

Has the applicant contributed to the neighborhood's history and/or the identity of a particular neighborhood or community?

Yes, Hotel Bohème has contributed to the history and identity of the North Beach neighborhood and San Francisco.

The Historic Preservation Commission recommended the applicant as qualifying, noting the following ways the applicant contributed to the neighborhood's history and/or the identity of a particular neighborhood or community:

- The interior design of the hotel is stylized from the Beat Generation. Elements that reflect this culturally significant period include: color scheme, furniture and décor.
- The business's location, 444 Columbus Avenue, is a Category A (Historic Resource Present) building constructed in 1906. The building is an example of the Italianate architectural style that is observed throughout the North Beach Neighborhood. The property is not formally listed on a historic registry; however, the structure is eligible for both the California and National Registries.
- Over the years, Hotel Bohème has been mentioned in travel articles and city guides, such as: Travel & Leisure, Condé Nast, Bon Appétit, Elle Décor, The Washington Post, Fodor's Guide, The Los Angeles Times and more.

CRITERION 3

Is the applicant committed to maintaining the physical features or traditions that define the business, including craft, culinary, or art forms?

Written Historical Narrative

INTRODUCTION

a. Describe the business. What does it sell or provide?

Hotel Bohème is a unique, boutique hotel at 444 Columbus Avenue in the heart of the North Beach neighborhood. The theme of the hotel is an homage to the Beat Generation/era which shaped American culture in the post-war era peaking in the 1950s. It was in San Francisco, and more particularly North Beach, where most of its most influential writers and poets lived. The Hotel Bohème, from its beautifully appointed rooms, its vibrant neighborhood, and its gracious staff, is the perfect place to stay in San Francisco to experience the city and this memorable time in history. Hotel Bohème is the heartbeat of North Beach.

The hotel has 15 specially appointed rooms, each with an en suite bathroom. There are rooms with a view of Columbus Avenue, and others that are set in the interior of the hotel for added quiet. The hotel features an eclectic mix of literary and visual motifs reflective of the Beat era, with a majestic staircase and strong, inviting colors and patterns. Sherry is served every afternoon in the hotel lobby, and the hallways are lined with photographer Jerry Stoll's renowned street photographs of life in North Beach in the 1950s and early '60s.

b. Describe who the business serves.

The hotel serves a world-wide cross section of guests. Roughly 35% of the guests are from outside the United States, with a majority of that group coming from Europe. Most of the guests are tourists, but there is also a fair share of business travelers who are looking for a more intimate experience in one of San Francisco's best neighborhoods.

c. In about 2-5 words (15-30 characters), describe what the business is known for.

A wonderful homage to the Beat era in San Francisco.

CRITERION 1: The business has operated in San Francisco for 30 or more years, with no break in San Francisco operations exceeding two years

a. Provide a short history of the business, including locations and owners.

Hotel Bohème is a unique hotel in a special neighborhood. It opened at 444 Columbus Avenue in North Beach on June 14, 1991, and has operated at that location uninterrupted to the present time.

Located at the foot of Telegraph Hill in the heart of San Francisco's North Beach, the building was constructed in the 1880s by an Italian immigrant family, Capurro. The original hotel was a typical three-story building with lodging on the upper floors and retail stores on the ground floor. The 1906 earthquake and fires unfortunately destroyed most of North Beach, but the Capurro family was able to rebuild the building. The Capurro heirs own the building to this day and lease the property to the owner of Hotel Bohème.

From the time after the building was rebuilt following the earthquake until the present, there has been a hotel there.

b. Provide the ownership history of the business in a consolidated year-to-year format.

1991 to Present: Joel Morgenstern

c. Describe any circumstances that required the business to cease operations in San Francisco for any significant length of time.

Hotel Bohème has operated continuously from 1991 until the present time except for a roughly 6-month period in 2020 when it temporarily closed due to the COVID pandemic.

CRITERION 2: The business has contributed to the neighborhood's history and/or the identity of a particular neighborhood or community

a. Describe the business' contribution to the history and/or identity of the neighborhood, community, business sector, or San Francisco as a whole.

Hotel Bohème is a unique historical marker of the Beat generation and era in San Francisco. Often, the first stop of hotel guests is to City Lights Books, founded by the famous Beat poet and publisher Lawrence Ferlighetti.

b. Is the business associated with significant people or events, either now or in the past?

The theme of Hotel Bohème is an homage to the Beat era in North Beach in the 1950s. The hotel highlights this unique San Francisco epoch through its design details including the display of 35 museum quality street photographs taken in North Beach at that time by Jerry Stoll, which beautifully and poetically capture this unique period of North Beach history. The hotel's room styles are named after three of the most famous Beat authors and poets: Jack Kerouac, Allen Ginsberg, and William Burroughs.

c. How does the business demonstrate its commitment to the community?

People are welcome to come into the hotel to see the magnificent collection of Jerry Stoll photographs documenting life in North Beach in the Beat era.

d. Has the business ever been referenced in the media, business trade publication, and/or historical documents?

Through the years, Hotel Bohème has been written up in uncountable newspapers and magazines such as Travel & Leisure, Elle Décor, Washington Post, Fodor's Guide, Metropolitan Home, and more.

e. Has the business ever received any awards, recognition, or political commendations?

No, other than extensive press coverage reviewing the hotel.

f. How would the community be diminished if the business were to be sold, relocated, shut down, etc.?

If Hotel Bohème were to close, North Beach would lose one of its most iconic businesses that is located in the neighborhood precisely because it reflects the history of that very neighborhood. Seven people would lose their jobs.

CRITERION 3: The business is committed to maintaining the physical features or traditions that define the business

a. Is the business associated with a culturally significant building, structure, object, signage, mural, architectural detail, neon sign, or any other special physical feature that defines the business?

Hotel Bohème's interiors were designed by renowned historic hotel designers Candra Scott & Anderson, who are also located in San Francisco. The hotel is a colorful reincarnation of the San Francisco of the late 1950s North Beach Beat Generation. The display of 35 street photographs by Jerry Stoll are a special feature that defines the hotel.

Another one of Hotel Bohème's most notable features is its congenial and knowledgeable staff, many of whom live in the city and have been with the property for years. Visitors return for the warmth, hospitality, intimate experience, and personal attention they receive.

b. In a few words, describe the main business activity you commit to maintaining.

Operating a unique and neighborhood specific boutique hotel.

c. What challenges is the business facing today?

Many of Hotel Bohème's guests say that they were not so sure about coming to San Francisco due to the seemingly never-ending depressing articles in the press and news about the social

decline of the city, highlighting extensive coverage of the serious homeless issue, drug use, and crime. There is no doubt that if the city showed real progress in these areas that more people would visit.

The business's primary location at 444 Columbus Avenue is a Category A (Historic Resource Present) building on the east side of Columbus Avenue between Vallejo and Green Streets in the North Beach neighborhood. The business is within the North Beach NCD (Neighborhood Commercial District), a 40-X Height and Bulk District and within the North Beach Special Use District.

Staff Analysis

Review Criteria

1. When was business founded?

The business was founded in 1991.

2. Does the business qualify for listing on the Legacy Business Registry? If so, how?

Yes. Hotel Bohème qualifies for listing on the Legacy Business Registry because it meets all of the eligibility Criteria:

- a. Hotel Bohème has operated continuously in San Francisco for 31 years.
- b. Hotel Bohème has contributed to the history and identity of the North Beach neighborhood and San Francisco.
- c. Hotel Bohème is committed to maintaining the physical features and traditions that define the organization.

3. *Is the business associated with a culturally significant art/craft/cuisine/tradition?*

Yes. The interior design of the hotel is stylized from the Beat Generation. Elements that reflect this culturally significant period include: color scheme, furniture and décor.

4. Is the business or its building associated with significant events, persons, and/or architecture?

Yes. The business's location, 444 Columbus Avenue, is a Category A (Historic Resource Present) building constructed in 1906. The building is an example of the Italianate architectural style that is observed throughout the North Beach Neighborhood.



5. Is the property associated with the business listed on a local, state, or federal historic resource registry?

No, the property is not formally listed; however, 444 Columbus Avenue has a Planning Department Historic Resource status code of "A" (Historic Resource Present). This classification was assigned during the 1984 North Beach Historic Survey, which identified the structure as eligible for both the California and National Registries.

6. Is the business mentioned in a local historic context statement?

No, not as of the date of this Executive Summary.

7. Has the business been cited in published literature, newspaper, journals, etc.?

Yes. Over the years, Hotel Bohème has been mentioned in travel articles and city guides, such as: Travel & Leisure, Condé Nast, Bon Appétit, Elle Décor, The Washington Post, Fodor's Guide, The Los Angeles Times and more.
