Chief's Report

- **Weekly crime trends**
- **Major/Significant Incidents**

Chief Scott reported on crime trends YTD: Violent Crime up 8 percent; homicide down 7 percent; rape up 11 percent; robbery up 5 percent; assault up 11 percent; human trafficking down 50 percent. Property Crimes up 8 percent; burglary down 22 percent; motor vehicle theft up 4 percent; arson down 14 percent; larceny theft up 17 percent. Gun violence is down 4 percent compared to 2021; Five shooting incidents for the week ending on 10/2/22; total 142 incidents resulting in 164 victims YTD. One homicide for the week ending 10/2/22; there are a total of 40 homicides YTD with 27 resulting from a firearm; 55% overall clearance. Guns seized 805; ghost guns seized 163 YTD.

Significant Incident: 5 injury shootings this week. No arrests, investigation ongoing. CHP and SFPD collaborating regarding a sideshow/stunt cars possibly crossing over the bridge. Fatal collision collided with tree.

Significant arrest: Three homicide arrests made. Robbery arrest. Mission District multiple arrests.

Strategies: Regarding shootings and homicides, collaborating with Oakland. Shotspotter.

DPA Director's Report

Executive Director Henderson reported the following: In the year 2022: 526 cases opened; 566 closed; 236 pending; 49 cases sustained; 23 cases past 270-day; 17 cases mediated. Cases received in the past week: 9 new cases; 1 (Central) excessive force, failure to respond to multiple call for service and making racist jokes. 1 (Southern) failing to respond to a call for service, arresting a person without cause, and failing to write an incident report. 1 (Bayview) Forcing entry into a home without an explanation, threatening a person, and failing to investigate a crime. 2 (Northern) Referral DEM. 1 (Park) Referral to Sheriff's Office. 1 (Richmond) Driving recklessly. 2 (Tenderloin) Arresting a person without cause, failing to properly investigate, and writing an incident report.
