4.1 developing follow up research, presenters to the committee and action items

Following up on the recent site visit with Citywide Case management, Fumi Mitsuishi, MD, MS, Director of Citywide Case Management Services provided an overview of both the site visit and the effects of the Pandemic on a specific population. The Commissioner was able to ask questions.

Fumi Mitsuishi, MD, MS, Director of Citywide Case Management Services highlighted important items that affected their clients during the pandemic. Technology and digital literacy, isolation and lack of support were some of the items discussed. Citywide Case Management plans to create a better sense of digital belonging so their clients a clear understanding of their own individual needs.

Citywide case Management, UCSF was on site with a 4-1 ratio - some of the staff worked 5 days out of the week during the pandemic. It was difficult for them to work remotely and the established protocols were not practical.

The presentation covered the overdose and Covid 19 related deaths. Citywide provides primary care and preventative care to their clients. Their services are excelling client centered and effective.

There were some discussions about the mission of the BHC. It was noted that the BHC is charged with identifying service delivery gaps in DPH funded agencies. The Behavioral Health Commission provides a voice for consumers and providers of mental health services.
