REMOTE MEETING VIA VIDEOCONFERENCE

The Police Commission of the City and County of San Francisco met via videoconference at 5:34 p.m.

He passed this week, he was a long-time champion of police reform, a beloved community mentor and advocate and someone who would constantly provide the Police Commission with very detailed thorough and informative emails regarding issues that were being dealt with or being faced with.

GENERAL PUBLIC COMMENT

David Aaronson, Wealth & Disparities, stated quote. Discussed 9.01 Working groups, community members involvement in working groups/DGO review process.

Paulette Brown – regarding son's unsolved murder. Asking for help regarding unsolved homicides.

Chief's Report

- **Weekly crime trends**
- **Major/Significant Incidents**

Chief Scott reported on crime trends YTD: Violent Crime up 8 percent; homicide down 9 percent; rape up 10 percent; robbery up 5 percent; assault up 12 percent; human trafficking down 53 percent. Property Crimes up 7 percent; burglary down 21 percent; motor vehicle theft up 5 percent; arson down 11 percent; larceny theft up 15 percent. Gun violence is down 2 percent compared to 2021; Two shooting incidents for the week ending on 10/9/22; total 145 incidents resulting in 167 victims YTD. No homicides for the week ending 10/9/22; there are a total of 40 homicides YTD with 27 resulting from a firearm; 61% overall clearance. Guns seized 814; ghost guns seized 163 YTD.

Significant Incident: Homicide on 10/11/22, near Market and Church Safeway, victim stabbed, succumbed to injuries, investigation ongoing. Bayview, a 9/4/22 incident, 1st victim died on 10/11, 1000 block on Griffith, 2nd victim died 10/10, investigation on going. Two non-fatal shootings, Santos St., Ingleside 10/6, parties in dating relationship(s), victims transported to local hospital. Shooting 10/9 11:15 p.m. at Jefferson and Embarcadero (Central), victim with gunshot wound, transported, investigations ongoing.

Significant arrest: 8/22/22 Homicide arrest, Incident: body found in a tent with fatal gunshot wound (Bayview), on 10/7/22 suspect taken into custody and residence searched, charges are pending with

DA. Residential robbery- on 9/14/22, Onondaga Ave. Battery/Criminal Threats 10/8/22 – suspect located and arrested, Golden Gate and Larkin, narcotics seized, multiple charges. Stunt driving responses, 10/9/22, 75-100 vehicles and large crowd, South Van Ness and 13th, investigations ongoing, seizures after incidents occur.

Chief Scott mentioned Fleet Week, uneventful in terms of major incidents, thanked members of the department and all the other city departments who had a part in making Fleet Week a great event.

Strategies: Officially engaged with 30x30 initiative. Discussed CHP, other agencies' involvement regarding stunt driving responses. SFDA and SFPD working on MOU, answered Commissioner Benedicto's questions.

Commissioner Yanez requested to Agendize Trends of youth being arrested and detained, training regarding juveniles.

Executive Director Henderson reported the following: In the year 2022: 538 cases opened; 567 closed; 248 pending; 50 cases sustained; 22 cases past 270-day; 18 cases mediated. Cases received in the past week: 7 new cases; 1 (Bayview) Acting inappropriately during a traffic stop. 1 (Ingleside) Compromising an investigation. 1 (Taraval) Failing to investigate a report of domestic terrorism. 2 (Tenderloin) Acting inappropriately during a traffic stop. 1 (Airport) Acting inappropriately when asking a person to move their vehicle. 1 (N/A) Not within DPA's jurisdiction.

Audits: DPA Interim Reports, releasing parts of report in stages. Focuses on compliance and requirements. Effectiveness of reports and informing the Police Commission and stakeholders.

Outreach: Presented at Bayview station on 10/4. Tabling at Phoenix Day Block Party 10/16 organized by Glide, in conjunctions with St. Anthony's and Tenderloin Neighborhood Corporation. 
