# **3. BAYS Memorial Garden – Small Project Review** (10:49)

The project team presented a proposal to construct a memorial garden dedicated to individuals that are 45 years old or younger, whom have been affected by breast cancer. The BAYS Memorial Garden project design was conceptualized by About Inside Out, and through the guidance of Recreation and Parks.

The BAYS Memorial Garden is a landscape improvement memorial that will provide a new accessible seating area for the public to reflect and connect with community in nature at Golden Gate Park.

Commissioners shared feedback about seating design. They suggested that the project team remove bench dividers. Commissioners advised the team to replace the wood for stone and to remove the stone bench to enhance the circular pattern in the ground. Also, they recommended the removal of the metal monument sign in the center and then add a few more inscriptions in the paving for more context.

Lastly, commissioners encouraged the project team to incorporate vibrant colors like yellow with the grey color scheme and into the pathway.
