BUSINESS DESCRIPTION

Mary Elizabeth Inn is a 92-unit Single-Room Occupancy (SRO) residential hotel in Nob Hill, which was founded in 1914 by Methodist philanthropist, Mrs. Elizabeth (Lizzie) Snyder Glide and designed by the famous architect Julia Morgan. The Mary Elizabeth Inn has been one of San Francisco's unsung heroes, providing permanent housing, supportive services, and free meals to women who are homeless, low-income, and, in many instances, survivors of domestic violence.

Lizzie Glide had lived her entire adult life dedicated to helping others. A wealthy widow at the time and residing in the Sacramento area, Mrs. Glide became aware of the need for safe and affordable housing for young working women in San Francisco. Mrs. Glide proceeded to use her personal resources to buy the land and erect The Mary Elizabeth Inn, naming if after her two daughters.

In 1915, shortly after building The Mary Elizabeth Inn, Lizzie Glide donated it to an iteration of the National Office of the United Methodist Women (UMW). From 1915 through 1932, per records, The Inn was managed by the religious women leaders. In April 1932, Mrs. Glide created a nonprofit organization, Mary Elizabeth Inn, to operate and administer The Mary Elizabeth Inn.

In November 2021, ownership of The Mary Elizabeth Inn was transferred to the nonprofit organization, Mary Elizabeth Inn, that Mrs. Glide created in 1932, and has since continuously operated and administered the programs at the historic building. This was a generous gift by UMW (which recently changed their name and branding to United Women in Faith).

Since 1914, The Mary Elizabeth Inn has served San Francisco's vulnerable female population. Originally, the target population was "young working girls" who arrived in San Francisco seeking an affordable and safe place to live. All residents in those early years were required to have jobs and pay rent. Over time, the organization saw the growing need for housing and supportive services to women who were homeless and at risk of being homeless. To this day, women served are homeless and low income, and many have co-occurring disorders and histories of sexual violence.

CRITERION 2

Has the applicant contributed to the neighborhood's history and/or the identity of a particular neighborhood or community?

Yes, Mary Elizabeth Inn has contributed to the history and identity of the Nob Hill neighborhood and San Francisco.

The Historic Preservation Commission recommended the applicant as qualifying, noting the following ways the applicant contributed to the neighborhood's history and/or the identity of a particular neighborhood or community:

- The Mary Elizabeth Inn is located within the boundaries of the Lower Nob Hill Apartment Hotel Historic District, which is a dense area primarily comprised of three- to seven-story multi-unit residential buildings. Most of the structures were built between 1906 and 1925, leading to a stylistically consistent district. Buildings often exhibit Art Deco or Spanish/Mission/Mediterranean influences. The building was constructed by architect of merit Julia Morgan, who has designed more than 700 buildings in California throughout her career. She is best known for her work on Hearst Castle in San Simeon, California. The Mary Elizabeth Inn is a four-story structure built in an Edwardian style of architecture with Tudor Revival ornaments which is contributing to the period and character of its surrounding neighborhood.
- The Mary Elizabeth Inn has hosted and homed numerous significant and famous people throughout its history. An event in 2006 featured guest panelist then-San Francisco District Attorney now Vice President Kamala Harris. Another event featured Dr. Melba Beals, one of the Little Rock Nine and Congressional Medal holder. She lived at The Mary Elizabeth Inn while a student at San Francisco State University.
- Over the years, The Mary Elizabeth Inn has been featured in local newspapers and other religious publications. A January 2013 article in the San Francisco Examiner by journalist Andrea Koskey featured one
- of their residents, and the story was promoted to highlight the centennial celebration in 2014.:

It is my honor and privilege to nominate Mary Elizabeth Inn at 1040 Bush Street for inclusion on the Legacy Business Registry.

Mary Elizabeth Inn, a 92-unit Single-Room Occupancy (SRO) residential hotel in lower Nob Hill, was founded in 1914 by Methodist philanthropist, Mrs. Elizabeth Snyder Glide and designed by the famous architect Julia Morgan. Operating continuously since its founding over 100 years ago, Mary Elizabeth Inn got its start providing affordable and independent dorm-style living for low-income single women in transition. Today, Mary Elizabeth Inn provides safe and affordable permanent supportive housing for women recovering from homelessness and sexual abuse. In 1932, Mrs. Glide incorporated a separate nonprofit public benefit corporation, Mary Elizabeth Inn, creating the organizational body that administers the housing program to this day.

It is the mission of Mary Elizabeth Inn to end the cycle of poverty and homelessness for San Francisco's most vulnerable female population, and its long history of service has helped shape a community institution. While San Francisco explores permanent solutions to homelessness and housing insecurity, Mary Elizabeth Inn continues to build on the legacy of historic women's residential hotels across the country by providing vital supportive housing to women struggling without a safety net locally.

THE MARY ELIZABETH INN Section 4: Written Historical Narrative

CRITERION 1

a. Provide a short history of the business from the date the business opened in San Francisco to the present day, including the ownership history. For more than a century, The Mary Elizabeth Inn, a historic single room occupancy (SRO) hotel located at 1040 Bush Street in the Nob Hill neighborhood, has been one of San Francisco's unsung heroes, providing permanent housing, supportive services, and free meals to women who are homeless, low-income, and, in many instances, survivors of domestic violence.

The Mary Elizabeth Inn was founded in 1914 by Mrs. Lizzie Glide, who had lived her entire adult life dedicated to helping others. A wealthy widow at the time and residing in the Sacramento area, Mrs. Glide became aware of the need for safe and affordable housing for young working women in San Francisco. Mrs. Glide proceeded to use her personal resources to buy the land and erect The Mary Elizabeth Inn, naming if after her two daughters.

In 1915, shortly after building The Mary Elizabeth Inn, Lizzie Glide donated it to an iteration of the National Office of the United Methodist Women. From 1915 through 1932, per records, The Inn was managed by the religious women leaders.

In April 1932, Mrs. Glide created a nonprofit organization, Mary Elizabeth Inn, to operate and administer The Mary Elizabeth Inn.

The National Office of the United Methodist Women (UMW) held title of the building until 2021. Since the 1800s, UMW, a separate entity of the United Methodist Church, had accumulated buildings across the country where they operated "missions" helping the needy. Fast forward to the current period, UMW found themselves owning about 100 buildings across the country and decided to transfer ownership of the buildings to the nonprofits who had long been operating the programs, referred to as National Missions Institutions: National Mission Institutions Roster by State (uwfaith.org).

In November 2021, ownership of the Mary Elizabeth Inn was transferred to the nonprofit organization, Mary Elizabeth Inn, that Mrs. Glide created in 1932, and has since continuously operated and administered the programs at the historic building. This was an extremely generous gift by UMW (which recently changed their name and branding to United Women in Faith). Mary Elizabeth Inn and United Women in Faith maintain a close relationship.

b. Describe any circumstances that required the business to cease operations in San Francisco for more than six months?

The historic SRO, The Mary Elizabeth Inn, has operated continuously since 1914. The nonprofit organization, Mary Elizabeth Inn, has operated continuously since it was formed in 1932.

c. Is the business a family-owned business? If so, give the generational history of the business.

Neither The Mary Elizabeth Inn (the business) nor Mary Elizabeth Inn (the nonprofit organization) are family-owned businesses.

d. Describe the ownership history when the business ownership is not the original owner or a family-owned business.

The historic building and business, The Mary Elizabeth Inn, was originally owned by Mrs. Lizzie Glide. She donated the building to the National Office of the United Methodist Women in the 1930s. In 1932, Mrs. Glide created the public benefit nonprofit to continue administering the housing programs out of The Mary Elizabeth Inn. From that time until 2021, the National Office of the United Methodist Women held title to The Mary Elizabeth Inn. Recently, in November 2021, the National Office of the United Methodist Women transferred ownership of the historic SRO to the nonprofit organization, Mary Elizabeth Inn.

The ownership history of The Mary Elizabeth Inn is as follows:

1914 to 1915: Lizzie Glide

1915 to 2021 United Methodist Women

2021 to Present: Mary Elizabeth Inn (nonprofit organization)

e. The historic resource status of the building at 1040 Bush Street is classified by the Planning Department as Category A, Historic Resource Present, with regard to the California Environmental Quality Act. The building is a contributor to the Lower Nob Hill Apartment Hotel Historic District, a dense area primarily comprised of 3- to 7-story multi-until residential buildings. Most of the structures were built between 1906 and 1925, leading to a stylistic consistent district. Buildings often exhibit Art Deco or Spanish/Mission/Mediterranean influences. The district is significant for both its architecture as well as its association with its residents, often white-collar workers.

CRITERION 2

a. Describe the business's contribution to the history and/or identity of the neighborhood, community or San Francisco.

When Mrs. Glide solicited famed architect and engineer Julia Morgan to design The Mary Elizabeth Inn, she wanted the building to have a "home-away-from-home" appeal to the young women who had left their families behind to relocate to San Francisco. The building has a beautiful Edwardian design and contributes to the period architecture of the neighborhood.

b. Is the business (or has been) associated with significant events in the neighborhood, the city, or the business industry?

The year 1914 was a period of growth in San Francisco, as only eight years earlier the city had suffered a devastating earthquake that had leveled a good part of the community. There was a burst of enthusiasm to rebuild and beautify San Francisco. Job opportunities brought young women to San Francisco seeking employment despite the many dangers that still existed in the notorious Barbary Coast. California granted women the right to vote in 1911, and by 1914 California had a female Assistant U.S. Attorney for the Northern California district. All these developments, as well as conversations with working girls in San Francisco, must have spurred Mrs. Glide's decision to build The Mary Elizabeth Inn. During the First World War, some residents enlisted in the Women's War Service League. A few others traveled overseas with the Red Cross and YMCA. During World War II, some women lived at The Mary Elizabeth Inn while serving in the Armed Forces. Following is an excerpt from a 1930 article from San Francisco highlighting The Mary Elizabeth Inn: "These young women hold a very responsible position in the future of our nation. Many of these girls work for very low wages; but we are fortunate in that California has a minimum wage law of sixteen dollars per week ..."

Throughout its history, The Mary Elizabeth Inn has held several events to educate the community about its mission and to celebrate its history. An event in 2006 featured guest panelist, then San Francisco District Attorney, Kamala Harris. Another event featured Dr. Melba Beals, one of the Little Rock Nine and Congressional Medal holder. We learned that she lived at The Mary Elizabeth Inn while a student at San Francisco State University.

In April 2014, The Mary Elizabeth Inn celebrated its centennial with a gala at the Mark Hopkins Hotel. Banners honoring the centennial were on display throughout San Francisco, in such places as along Sunset Boulevard and West Portal Avenue.

c. Has the business ever been referenced in an historical context? Such as in a business trade publication, media, or historical documents?

Over the years, The Mary Elizabeth Inn has been featured in local newspapers and other religious publications. A January 2013 article in the San Francisco Examiner by journalist Andrea Koskey

featured one of their residents, and the story was promoted to highlight the centennial celebration in 2014.

d. Is the business associated with a significant or historical person?

The business was founded by Mrs. Lizzie Glide, a prominent businesswomen and devout Christian, who invested a considerable amount of her time and personal funds to build The Mary Elizabeth Inn in 1914 and the Glide Memorial Church in 1931. In religious circles, Mrs. Glide is well known as a generous philanthropist. In his book, The Life Story of Lizzie H. Glide (c.1936), Julian C. McPheeters writes: "She has lived for others and not herself. The spirit of unselfish devotion which she exemplified is needed in every area of human life today." In the early 1930s, Mrs. Glide created the Glide Foundation for the purpose of managing and supporting the Glide Memorial Church, and later to purchase the California Hotel, formerly located at Taylor and O'Farrell streets.

The Mary Elizabeth Inn has hosted special events over the years at which significant or historical people have participated as speaking guests. Such guests have included Kamala Harris, Dr. Melba Pattillo Beals (one of the Little Rock Nine), and David Chui (then-President of the San Francisco Board of Supervisors). David Chui spoke at the centennial gala in October 2014. At the same gala, the city's beloved Wilkes Bashford took an interest in Mary Elizabeth Inn. When he visited, he, like many others, was fascinated by the ironing boards that are original to the building and exist to this day. He saw that they needed covers, so he had his tailor make custom covers for the organization.

e. How does the business demonstrate its commitment to the community?

The Mary Elizabeth Inn continues to be a vital partner in ending homelessness in San Francisco for its vulnerable female population.

f. Provide a description of the community the business serves.

Since 1914, The Mary Elizabeth Inn has served San Francisco's vulnerable female population. Originally, the target population was "young working girls" who arrived in San Francisco seeking an affordable and safe place to live. All residents in those early years were required to have jobs and pay rent. Over time, the organization saw the growing need for housing and supportive services to women who were homeless and at risk of being homeless. To this day, women served are homeless and low income, and many have co-occurring disorders and histories of sexual violence.

g. Is the business associated with a culturally significant building/structure/site/object/interior?

The Mary Elizabeth Inn is among the many structures designed by the architect Julia Morgan.

h. How would the community be diminished if the business were to be sold, relocated, shut down, etc.?

The Mary Elizabeth Inn is vital to the community. If the business were to no longer exist, many of the residents would be displaced, possibly returning to homelessness, even if only temporary while city

agencies coordinated to secure other similar housing. Also, a safe and affordable permanent supportive housing program focused on the needs of women would no longer be available to San Francisco's vulnerable female population.

CRITERION 3

a. Describe the business and the essential features that define its character.

The Mary Elizabeth Inn stands out on Bush Street as one of San Francisco's historic buildings that has not been altered in anyway. The historic 92-unit SRO houses formerly homeless and low income, single, adult, unaccompanied women. It is home to the current occupants.

b. How does the business demonstrate a commitment to maintaining the historical traditions that define the business, and which of these traditions should not be changed in order to retain the businesses historical character? (e.g., business model, goods and services, craft, culinary, or art forms)

The Mary Elizabeth Inn serves a vulnerable population of women in San Francisco who are recovering from homelessness, insecurity, and sexual violence. The building is a welcome site for women in need of a safe and affordable place to live. The provision of onsite case managers, 24-hour property management services, and free meals help residents achieve housing stability and self-sufficiency. As early as 1996, The Mary Elizabeth Inn has partnered with the following San Francisco Agencies for the support of housing programs and operations, as well as a major building rehabilitation, and these partnerships continue to this day: The Department on the Status of Women (DOSW), the Division of Homelessness and Supportive Housing (DHSH), and its predecessor; and The Mayor's Office of Housing (MOH).

c. How has the business demonstrated a commitment to maintaining the special physical features that define the business? Describe any special exterior and interior physical characteristics of the space occupied by the business (e.g. signage, murals, architectural details, neon signs, etc.).

Throughout the years, The Mary Elizabeth Inn has retained the original features of the building. Currently, the building is undergoing a roof replacement and special attention is being given to maintain the façade so that it is not altered in any way. The building has a laundry room, and while modern coin operated washing machines and dryers have replaced the early machines of 1908, the original ironing boards with heavy steel bases attached to the floor remain. In 2014, San Francisco's beloved Wilkes Bashford donated new ironing board covers that were crafted by his team of tailors.

d. Over one hundred years after its founding, Mary Elizabeth Inn continues its mission of providing housing and services for women in need from its historic property at 1040 Bush Street. The three-story, painted-brick Tudor-Revival building the organization calls home was originally constructed in 1913 by the organization's founder Lizzie Glide, who used her personal resources to build Mary Elizabeth Inn as safe and affordable housing for young working women in San Francisco.

At the time of the Inn's founding in the early part of the 20th century, San Francisco was a rough and dangerous place for women. As the story goes, one day Mrs. Glide asked a group of women on the street what she could do to help others if money were no object. The women replied that

they would build a safe home for working women. And that is what Mrs. Glide did: Mary Elizabeth Inn was her first gift to the city, followed by the now important legacy institution Glide Memorial Methodist Episcopal Church in 1929.

The Inn's 92-unit building is a design of trailblazing architect Julia Morgan, appropriate given the Inn's focus on women. In the 1930s, Mrs. Glide donated the building to the National Office of the United Methodist Women (UMW), and established the public nonprofit organization, Mary Elizabeth Inn (MEI), which continues to steward the building and its programs today. Early in 2021, the UMW donated the title to The Inn to MEI, which itself is celebrating over 90 years of service.

MEI is looking ahead to the next 90 years as caretakers of their historic building and its important service mission. It has long partnered with the Department on the Status of Women (DOSW) and the Human Services Agency (HSA) of the City and County of San Francisco to ensure housing at affordable rates, and with community-based organizations such as La Casa de La Madres and the San Francisco Food Bank to offer vital supportive services and food programs to residents. Comprehensive, onsite case management service are available as needed to assist women in getting back on their feet, some of which have been modified due to Covid-19. Other services include free meals, weekly food giveaways, free use of computers and peripherals, as well as free internet access. Clients are single adult, unaccompanied women who are formerly homeless and low income; many are survivors of domestic violence. The average length of stay for a majority of the residents is two to three years before moving on to more independent housing or reuniting with family. For many others, housing obtained at Mary Elizabeth Inn remains their only affordable housing option.

MEI recently submitted an application to join the San Francisco <u>Legacy Business Registry</u>, which recognizes businesses that have operated in San Francisco for 30 years or longer and have contributed to San Francisco's history and identity.

Business Description

Mary Elizabeth Inn is a 92-unit Single-Room Occupancy (SRO) residential hotel in Nob Hill, which was founded in 1914 by Methodist philanthropist, Mrs. Elizabeth Snyder Glide and designed by the famous architect Julia Morgan. The Mary Elizabeth Inn has been one of San Francisco's unsung heroes, providing permanent housing, supportive services, and free meals to women who are homeless, low-income, and, in many instances, survivors of domestic violence.

The Mary Elizabeth Inn was founded in 1914 by Mrs. Lizzie Glide, who had lived her entire adult life dedicated to helping others. A wealthy widow at the time and residing in the Sacramento area, Mrs. Glide became aware of the need for safe and affordable housing for young working women in San Francisco. Mrs. Glide proceeded to use her personal resources to buy the land and erect The Mary Elizabeth Inn, naming if after her two daughters.

In 1915, shortly after building The Mary Elizabeth Inn, Lizzie Glide donated it to an iteration of the National Office of the United Methodist Women (UMW). From 1915 through 1932, per records, The Inn was managed by the religious women leaders. In April 1932, Mrs. Glide created a nonprofit organization, Mary Elizabeth Inn, to operate and administer The Mary Elizabeth Inn.

In November 2021, ownership of the Mary Elizabeth Inn was transferred to the nonprofit organization, Mary Elizabeth Inn, that Mrs. Glide created in 1932, and has since continuously operated and administered the programs at the historic building. This was a generous gift by UMW (which recently changed their name and branding to United Women in Faith).

Since 1914, The Mary Elizabeth Inn has served San Francisco's vulnerable female population. Originally, the target population was "young working girls" who arrived in San Francisco seeking an affordable and safe place to live. All residents in those early years were required to have jobs and pay rent. Over time, the organization saw the growing need for housing and supportive services to women who were homeless and at risk of being homeless. To this day, women served are homeless and low income, and many have co-occurring disorders and histories of sexual violence.

Mary Elizabeth Inn is located at 1040 Bush Street. The building is a Category A (Historic Resource Present) structure on the North side of Bush Street between Leavenworth and Jones Streets in the Nob Hill neighborhood. It is within the RC-4 (Residential-Commercial, High Density) Zoning District and a 65-A Height and Bulk District. This building was included in several historical surveys including the National Register of Historic Places for being a contributor to a district and having multiple resources, California Register of Historic Resources, and the Apartment Hotel District survey, and the DCP 1976 Survey being rated as a 3 of 5 for its architecture.

Staff Analysis

Review Criteria

1. When was business founded?

The business was founded in 1914.

2. Does the business qualify for listing on the Legacy Business Registry? If so, how?

Yes. Mary Elizabeth Inn qualifies for listing on the Legacy Business Registry because it meets all of the eligibility Criteria:

- a. Mary Elizabeth Inn has operated continuously in San Francisco for 108 years.
- b. Mary Elizabeth Inn has contributed to the history and identity of the Nob Hill neighborhood and San Francisco.
- c. Mary Elizabeth Inn is committed to maintaining the physical features and traditions that define the organization.
- 3. Is the business associated with a culturally significant art/craft/cuisine/tradition?

No.



4. Is the business or its building associated with significant events, persons, and/or architecture?

Yes. The Mary Elizabeth Inn is listed in the Lower Nob Hill Apartment Hotel Historic District which is a dense area primarily comprised of three- to seven-story multi-unit residential buildings. Most of the structures were built between 1906 and 1925, leading to a stylistically consistent district. Buildings often exhibit Art Deco or Spanish/Mission/Mediterranean influences.

Th building was constructed by architect of merit Julia Morgan, who has designed more than 700 buildings in California throughout her career. She is best known for her work on Hearst Castle in San Simeon, California. The Mary Elizabeth Inn is a four-story structure built in an Edwardian style of architecture with Tudor Revival ornaments which is contributing to the period and character of its surrounding neighborhood.

The Mary Elizabeth Inn has hosted and homed numerous significant and famous people throughout its history. An event in 2006 featured guest panelist, then San Francisco District Attorney, now Vice President Kamala Harris. Another event featured Dr. Melba Beals, one of the Little Rock Nine and Congressional Medal holder. She lived at The Mary Elizabeth Inn while a student at San Francisco State University.

5. Is the property associated with the business listed on a local, state, or federal historic resource registry?

Yes. The site has is within the boundaries of the listed California Register and National Register Lower Nob Hill Apartment Hotel Historic District.

6. Is the business mentioned in a local historic context statement?

No, not as of the date of this Executive Summary.

7. Has the business been cited in published literature, newspapers, journals, etc.?

Yes. Over the years, The Mary Elizabeth Inn has been featured in local newspapers and other religious publications. A January 2013 article in the San Francisco Examiner by journalist Andrea Koskey featured one of their residents, and the story was promoted to highlight the centennial celebration in 2014.
