JUSTIS Program

Key Objectives FY21/22

- 1. <u>Modernize JUSTIS Hub Data Design</u>: migrate the JUSTIS data from the flat file structure inherited from the mainframe to a relational database **COMPLETED**
- 2. <u>Mainframe Retirement</u>: migrate mainframe reports, transactions, and queries by redeveloping them to run on the JUSTIS Data Hub
- 3. <u>Superior Court C-Track Interface</u>: JUSTIS team is developing an interface to exchange data with C-Track (CMS replacement system). This interface is required for C-Track go live which in turn enables the retirement of CMS on the mainframe.
- 4. <u>Data Center of Excellence</u>: design and implement the data analytics capabilities required to support the reporting needs of the criminal justice agencies and their stakeholders

In support of the SFPD's effort to migrate their applications off the mainframe, in April, the JUSTIS Team agreed to develop the replacement for the 2 Arrest Systems (Adult and Juvenile). That added 6 8 additional transactions to the scope.

C-Track Business Value to Partners


Modern Court Management System for the Courts

- Increased system reliability by removing dependency on mainframe infrastructure
- Allows for new information to be readily available for users, improved reporting and data analytics, and more comprehensive data sharing with Criminal Justice Partners
- Increased flexibility to configure the system the meet changing business operational needs and legislative changes
- Able to capture a richer data set by removing the constraints of the current system limitations

Modern JUSTIS Hub for Partners

- Modernized data architectures for efficient data exchange
- Real time data updates to JUSTIS partners
- Allow JUSTIS partners to upgrade business systems without impacting others
- Expand data analytics and reporting



Objective 3: C-Track Interface Development Status

Data exchange with C-Track for Court modernization & mainframe retirement.

The new data exchange interface (API) between JUSTIS and C-Track requires mapping the data between systems and writing associated transaction software. The C-Track API data exchanges is taking more time than originally estimated.

- Three sprints are planned to complete the work and testing
- Courts freezing data changes October 29th
- JUSTIS added two contractor resources to assist with the software development
- After a month of lifecycle testing and data validation Go-Live is scheduled for March
- Sheriff submitted to DOJ for temporary approval in the event DOJ cannot complete JUSTIS application review



Lifecycle Testing and Data Validation

Lifecycle operations testing with the JUSTIS partners is needed to confirm production readiness of the JUSTIS Hub changes to data exchange, reports and transactions

- Use Case Development Completed 9/3
- Test Plan Development In progress
 - > JUSTIS Team will develop of the detailed C-Track API test plan which will include the approach, specific test events, resource plan and the schedule
 - We need participants from the JUSTIS agencies to work with us on the test plan development. The level of participation for the JUSTIS agency resources is 2 hours per week from early November through January.
- Go Live Plan
 - > JUSTIS and Courts will plan go-live and will need support from JUSTIS agencies to script the transition steps and test during go-live



Production Readiness

- 6. Migrated mainframe transactions
- 7. Level II queries migrated to JUSTIS
- 8. DOJ Reporting
 - a. MACR
 - b. 8715 Disposition Reporting

Successful Go-Live Planning

- 1. Completed test plans for each agency
- 2. Log questions in ServiceNow
- JUSTIS will establish incident severity levels, track defects and resolve based on severity
- 4. Weekly or daily calls to coordinate fixes and retesting in the teams
- 5. Expect 4-6 weeks to normalize operations
- 6. After go live, keep CMS in read-only mode







Advisory Committees – Update

Architecture and Data Sharing – FY21/22 Workplan

With the retirement of the mainframe on the horizon, the work of the committee has shifted its focus to completing data-related workplans and tasks in an effort to develop the Data Center of Excellence (DCOE)

- 1. Data governance is the foundation for the DCOE
- 2. Developing roles and responsibilities structure for Data Governance
- 3. What's next: Deep dive into data taxonomy gaps, fine tune policies on data access
- 4. In collaboration with Performance & Strategy Committee
 - > building a structure that can be shared/used by agencies
 - building taxonomy, commonality of language and compliance with internal and external rules/laws from other governing bodies
 - > CIBRS and customizing standard to meet needs of agencies



Advisory Committees – Updates

Architecture and Data Sharing

FY21/22 Workplan cont'd

- 5. Committee is engaged and having productive conversations about data and data governance
 - Data and Transactions in JUSTIS and agency impacts
- 6. Working in tandem with C-Track Go Live date to ensure data governance is in place
- 7. Gartner assisting with facilitating the discussion and standards identification

FY21-22 Goals

Cross system Benefit

- 1. Establish source and methods for race and ethnicity variables for city-wide KPIs.
- 2. Establish source and methods for crime and case type categories for city-wide KPIs. <u>Recidivism</u>
- 3. Validate and expand Justice Dashboard for tracking subsequent criminal justice contact.
- 4. Explore the use and impact of custody holds and processes related to them, establishing crossdepartmental protocols and new JUSTIS workflows

Well Being

5. Expand knowledge about High User Analysis and make recommendations for well-being indicators.



Advisory Committees – Update

Performance and Strategy

- 1. Generated draft Race & Ethnicity policy (Goal 1) based on the CIBRS standard
 - Matches reporting requirements to State/Fed DOJ
 - Department options retained
 - Flexibility to change as needed
- 2. P&S Sub Committee **recommend approval** of the Race & Ethnicity policy
 - 3 to Zero votes to approve (PD, DA, SHF). 1 abstention (APD), 3 absent (JUV, PDR, CRT)
- 3. Future questions for sub-committee consideration
 - Methodology and process for reporting data conflicts, which takes priority
- 4. Initial discussions on Crime and Case type ongoing (Goal 2)



Performance and Strategy Collaboration Work Beyond FY21-22 Goal Set

Crime & Case Type

- Discussion ongoing to validate how JUSTIS can count crimes/cases in support of related KPIs.
- Ties tightly to the validation of the Justice Dashboard and it's migration into the JUSTIS system. (Goal 3)
- Projected draft policy Q2 2022.

Municipal Code table

• The sub-committee has been unable to locate a municipal code table for county ordinances. Lack of a table will cause standardization issues across datasets.

MACR Data

• JUSTIS is looking into data reporting as we cutover from CMS to JUSTIS led MACR reporting
