She provided additional background information regarding the AB 361 legislation including its requirements.

Commissioner Beltran seconded followed by Commissioner Schnair, moved to adopt a resolution setting forth findings required under Assembly Bill 361 that would allow the Arts Commission and its subcommittees to hold meetings remotely according to the modified Brown Act teleconferencing set forth in AB 361.

There was no public comment, and the motion was unanimously approved.

In-person, by Tamika Chenier, shared her disappointment with the failure of payment for completed work that contributed to a remaining unpaid balance of 27,900.00 by the SFAC Cultural Equity Initiative award through the 19CEI15 to the African American Art & Culture Complex (AAACC). Chenier was given the role of general project manager from 2019-2023, by the AAACC. Chenier provided documented evidence of several printed email correspondences and invoices to showcase neglect of payment for her art and services, along with a refusal to provide a copy of the contract agreement between her and the AAACC. Through public records, Chenier became aware of the SFAC grant amount agreement under 22SPX-AB24. Chenier's demands a deadline of November 14, 2022, for compensation fulfillment by the AAACC, along with a call for action for SFAC to implement additional oversight and financial management of art and cultural organizations that receive funding/support from SFAC.

In addition, Chenier requested that the documents provided by her will be included in public records.

Public Comment no.2

(22:27)

Virtual public comment was provided by Rebekah Black, who is the treasurer and secretary of the Juneteenth nonprofit Inc. This organization was a fiscally sponsored by AAACC and a subgrantee funded by SFAC to compensate Chenier for duties as general manager during the SF Juneteenth Festival. Black has yet to receive financial records from AAACC, which were requested in April 2021. Black's public comment pertained to the support for Chenier's discrepancies claims against AAACC. Black, **requested a response** from SFAC to identify the purpose that Chenier did not receive payment from the following grant contracts: 19CEI15, 19SPX03, 20SPX-AB27, and 22SPX-AB24 and to be paid in full by November 14,



2022. As a final request, Black recommended that SFAC not grant further funding to AAACC until all past due payments have been fulfilled, and to provide additional financial oversight of grantee institutions.

There were no additional public comments, Acting President Shiota thanked individuals for the public comments that were made.

Acting President Shiota requested action to vote to ensure that documents are added to records and commitment to follow up on claims against AAACC. Commissioner Beltran seconded followed by Commissioner Schnair

Director's Report

Director of Cultural Affairs Ralph Remington acknowledged former Ordenãna's contributions to SFAC and staff. Then welcomed newly appointed commissioner McCoy. Director Remington highlights monthly recap of his experience at the 2022 World Cities Cultural Summit in Helsinki, Finland. As a result, Remington identified barriers for immigrant artists and their lack of opportunities, particularly within circumstances to access funding.

He provided updates on MMAC, feedback from the assessment surpassed goals, and achieved nearly 700 responses. Next step in process is that SFAC's staff will collaborate with sponsors to identify new funding for next year's report and recommendations.

He provided insight that the Community Investment team will be closing applications for the 2022-2023 Cultural Equity Grant Program and is headed for panel reviews.

Director Remington announced ongoing SFAC action items, which includes Pier 27 cruise terminal project artist's call, and the installment of the 2022 Art on Market Poster Series, by artist A.C Esguerra.

Director's report concluded with HR Updates and welcomed Temporary Commission Secretary Traka Lopez-White along with additional acknowledgements of Operations Associate Veronica Limcaco, the Director of Galleries and Public Program Carolina Araniber-Fernandez, and Temporary Program Associate Fedi Lopez.

Commissioner Carney asked if commissioners are permitted to preview artworks in Muni station before public openings.

 - i. District 10 – Bayview Opera House Inc., \$150,000 over two years to support Space for Community Events.
 - j. Citywide – Gay, Lesbian, Bisexual, Transgender Historical Society, \$200,000 over two years to support Lesbian, Gay, Bisexual, Transgender, Queer (LGBTQ) Services.
 - k. Citywide — First Voice Inc., \$50,000 over one year to support Asian American Artists.
