President/Chair Collins announced the hybrid meeting instructions.

Commission Secretary Traka Lopez-White announced public comment instructions.

President Collins began the meeting reading the Arts Commission's land acknowledgement statement.

2. AB361 Legislation Impact (13:41)

President Collins introduced the item. He reminded commissioners that the commission approved the motion at their last meeting. President Collins explained that the commission must approve the motion every 30 days to



continue meeting virtually. He provided additional background information regarding the AB 361 legislation, including its requirements.

There was no public comment.

Commissioner Beltran, seconded by Commissioner Shiota moved to adopt a resolution setting forth findings required under Assembly Bill 361 that would allow the Arts Commission and its subcommittees to hold meetings remotely according to the modified Brown Act teleconferencing set forth in AB 361.

4. General Public Comment (21:00)

5. Directors Report (22:37)

Director Remington welcomed everyone to the new year 2023. He acknowledged the unprecedented flooding and its impact on the San Francisco community, particularly many local artists. In response, the SFAC is collaborating with other city agencies and community organizations to assess community needs in order to form resources along with additional emerging aid to support our local artists. In addition, SFAC's partnership with the Minnesota Street Project Foundation promoted available Emergency Relief Grant information.

Director Remington congratulated Commissioner Collins on his newly appointed role as the SFAC 2023 Commission President and Commissioner Shiota as the Commission Vice President. Furthermore, he recognized the historical significance of Commission President Collins as the first Black Commission President and Director Remington, the first Black Director of Cultural Affairs serving under the leadership of San Francisco's first Black Woman Mayor, London Breed.

Following, he shared a few highlights of December and January events. One of those events was a ribbon-cutting celebration for the opening of the Central Subway station at Union Square/ Market Street Station on January 7, 2023. Numerous elected officials, SFAC staff and commissioners and



artists that produced the ten unique and opulent installations attended the opening event.

Director Remington provided an update from the Full Commission meeting on November 7, 2022 regarding the African American Cultural Complex (AAACC) and the former organizer of Juneteenth Festival. He shared that the Community Investments team will aim to resolve a payment dispute.

As for the Public Art's ongoing activities, the deadline for Pier 27 Cruise Terminal Project RRQ has been extended to January 13, 2023. Next, Director Remington appreciated David Johnson, his family and the Bancroft Library for their partnership on the successful eight-month *David Johnson: In the Zone (1945-1965)* exhibit. The next City Hall exhibition will be The Power of Creativity and Community, in partnership with the Art with Elders. Meanwhile, the Sowing Worlds exhibition is currently being displayed at the SFAC main gallery.

In other announcements, the submittal deadline for the RFP for vendors to assist with developing an agency-wide strategic and business plan has been extended to January 30, 2023. In addition, he announced SFAC's newest staff member, Edward Tom, who will serve as Public Information Officer. With a few more hires, SFAC remains on track to become fully staffed by March 2023.

6. Committee Reports and Committee Matters (34:47)



1. Civic Design Review Committee

(35:16)

Commissioner Stryker shared that the committee reviewed and approved the BAYS (Bay Area Young Survivors) Memorial Garden project at Golden Gate Park. Then Commissioner Stryker acknowledged the hard work and commitment that CDR committee members and staff contributed to last year. After the commissioner's report concluded, Commissioner Carney shared his gratitude for Commissioner Stryker's leadership as the CDR committee's Chair.

There was no public comment.

2. Community Investments Committee

(40:01)

Commissioner Collins shared some insight on a new grant category, the Arts Impact Endowment First Time Grantee Initiative which led to the approval of 34 new grantees who have never received funding from SFAC nor GFTA. We received 140 applications, and 117 eligible applications were reviewed in five distinct application review panels. With a total of \$1.6 million dollars invested in these first-time grantees, 80% of applicants identified as BIPOC. As the Community Investments team is superseding measures to support artists and art organizations, they aim to expand their team by hiring a Senior Program Officer and a Program Associate. And the Native American Arts and Cultural Traditions grant guidelines and application will be released in late January.



Commissioner Shiota asked if the new grant category will continue every fiscal year or if it will be a one-time grant.

Deputy Director of Programs Lee replied that the Arts Impact Endowment funds support current and emerging needs within the sector. Staff will evaluate this Initiative to determine whether to launch another cycle next year. Commissioners Beltran and McCoy acknowledged Deputy Director of Programs Lee's hard work and the importance that these grants will support the emerging art community.

Public commenter Michael Warr expressed the significance of the SFAC's new grant category. He was joined by his creative partner Chun Wu. They received a grant for the "two languages, one community" project. Despite the violence and social injustices during the pandemic, their organization developed spoken word and poetry workshops to unite Black American and Chinese American communities.

No additional comments.

3. Visual Arts Committee Report

(50:37)

Commissioner Ferras discussed the "Art on Market Street Posters," and the posters will be installed from early January 2023 through March 2023. Then she provided updates on the "Treasure Island Public Art Program. The Visual Arts Committee received an update on the Hiroshi Sugimoto sculpture for Yerba Buena Hilltop Park on Treasure Island. The artwork will be prepared to ship in February 2023, and installation will be in the Spring of 2023.



Commissioner Shiota asked if the Hiroshi Sugimoto sculpture would be part of the Civic Design collection. Staff member Mary Chou confirmed that the artwork will belong to the development firm TIDA.
