1. SUMMARY. What major changes is the department proposing? Clearly describe each change, including the fiscal impact of the proposal. Alternatively, you may submit a 1-2 page memo with your budget submission summarizing the major changes.

The Controller's Office proposed an expenditure budget increase from the Base Budget by \$1.4M in FY 2023-24 and \$0.4M in FY 2024-25, as well as sources increase from the Base Budget by \$4.8M in FY 2023-24 and \$0.9M in FY 2024-25. The General Fund Support reduced by \$3.3M and \$0.5M in FY 2023-24 and FY 2024-25, respectively.

Major changes include:

- 1) a reduction of lease budget in Systems Division which is achieved by space consolidation in City Hall. Utilizing a shared-work station model, the Controller's Office has decided to vacate its second work location at 1155 Market, 6th Floor to co-locate its entire staff at City Hall. This consolidation will result in over \$1M lease savings annually. The budget change will be centrally loaded by the Mayor's Budget Office.
- 2) increasing accounting work order requests from other city departments for Financial Assistance & Support Team (FAST) services, net increase of \$2.1M in FY 2023-24 and \$1.5M in FY 2024-25. The recovery budget increase is accompanied by an increase of the programmatic projects budget to fund the personnel cost in Accounting Operations and Supplier Management Division (AOSD).
- 3) adding Beginning Fund Balance of \$3.9M in FY 2023-24 as one-time source to offset two budget years' downstream general fund support increase that is caused by relatively more spending incurred by general fund departments in FY 2021-22 due to COVID.
- 4) increase of new positions and position changes to better serve other city departments and expand the Controller's financial professionals development and training programs, including:
 - a) Budget and Analysis Division: one new off-budget 0931 in the Financial Standards Training Project
 - b) Accounting Operations and Supplier Management Division: two position upgrades (1657 to 1670) and two position downgrades (1652 to 1820) will be made to neutralize the cost impact.
 - c) City Services Auditor (CSA): one new off-budget 1824 as Disaster Cost Recovery Manager.
 - d) Payroll Division: one 1404 Clerk deletion and slight increase in step adjustments, resulting in a net personnel savings of \$89K in FY 2023-24 and \$91K in FY2024-25.
- 5) increase of programmatic projects budget to fund two off-budget Refuse Rates Administration positions that were approved last year and one new Financial Standard Training project off-budget position, \$0.6M in FY 2023-24 and \$0.7M in FY 2024-25.
- 6) a realignment of the uses and sources budget in City Service Auditor, which resulted savings of \$0.1M in FY 2023-24 and \$0.6M FY 2024-25.

2. GENERAL FUND TARGET. How did the department meet its target in each year? What are the high-level programmatic, operational, or staffing impacts of this proposed reduction? For non-GFS departments, please describe your strategy for absorbing cost increases or revenue reductions without adding new costs to the General Fund?

The Controller's Office proposed to remove Systems Division's annual lease budget (centrally load), utilize current year savings from the City Services Auditor Division as well as close one-time project to mitigate the downstream General Fund Support impact. The increase of the uses budget is offset by the increase of the sources budget, and the net General Fund Support reduced by \$3.3M in FY 2023-24 and \$0.5M in FY 2024-25. The Controller's Office met its target over the two budget years over all. The impact of the Systems Division's lease reduction as well as its work order recovery budget changes are reflected in the below table and will be centrally loaded during Mayor's Phase:

What position changes is the department proposing to prioritize core service delivery while meeting the General Fund reduction target or NGF revenue reductions? The Controller's Office has steadily focused on hiring and recruitment addressing vacancies present before and during the COVID-19 emergency. This effort has resulted in a year to date vacant count of 15.33 FTEs. Some of the vacancies are purposely kept vacant to meet department's attrition savings requirement. The Department proposed following position changes to better support core services and expand the Controller's financial professionals development and training programs and create pipelines to equip financial professionals with essentials skills and knowledge, including:

- a) Budget and Analysis Division: one new off-budget 0931 in the Financial Standards Training Project to launch a Budget Academy to develop trained budget analyst professionals.
- b) Accounting Operations and Supplier Management Division: two position upgrades (1657 to 1670) to pilot a senior-level accounting manager training program (similar to the 1649 Accountant Intern Program). Two position downgrades (1652 to 1820) will be made to neutralize the cost impact.
- c) City Services Auditor (CSA): one new off-budget 1824 as Disaster Cost Recovery Manager.
- d) Payroll Division: one 1404 Clerk deletion and slight increase in step adjustments, resulting in a net personnel savings of \$89K in FY 2023-24 and \$91K in FY2024-25.

The Controllor's Office proposed deletion of its annual lease budget at 1155 Market Street, 6th Floor (centrally load) in Systems Division, and increase the City Services Auditor's professional services (CSA) contract budget netted out by a reduction of the CSA's Programmatic Projects spending. Accounting Division proposed to increase its FAST Programmatic Projects budget to fund the division's personnel cost of off-budget and temporary positions due to increasing accounting service requests from other city departments. The AOSD's expenditure budget increase is offset by the increase of revenue.

10. BUDGET EQUITY. How has the department considered equity in its budget proposal?

The Controller's Office budget supports equity through both staffing and service contracts in two meaningful ways: internal support of departmental racial equity initiatives and actions and external support of Citywide racial equity mandates and resources. The department budgets FTES to support the access to workforce demographics and citywide contract inclusion reporting through the City and County of San Francisco's PeopleSoft Applications, SF People & Pay, SF Procurement, SF Financials, SF Learning and SF Reports & Analytics. In partnership with HRC's Office of Racial Equity (ORE), the City Administrator's Office, the Office of Contract Administration (OCA), and the Contract Monitoring Division (CMD), the Controller's Office has developed a citywide inclusionary reporting implementation plan as well as citywide equity and inclusion reporting available through SF Reports & Analytics. Budgeted staff time is used towards our partnership with the Department of Human Resources (DHR) and HRC's ORE in the publication of the Annual Workforce report as well as Citywide, multi-year demographics reporting on DHR's website. Internally, a combination consulting services contracts and FTEs are used to support racial equity initiatives. The Controller's Office issued two racial equity contracting opportunities: one RFP in coordination with the Treasurer Tax Collector's Office and the Assessor Recorder's Office for departmental support services to further our racial equity work, as well as a citywide RFQ pre-qualified pool bid opportunity open to all City department to use for their racial equity support service needs, in coordination with HRC's ORE, DRH and others. Our joint services contract with TTX and ASR has been leveraged to support executive assessment and leadership training, all-staff training, diversity recruitment assessment and policy development, and capacity building for our racial equity workgroup. The Controller's Office workgroup has utilized allocated hours and resources to: implement recurring, facilitated learning sessions on myriad racial equity topics; develop and implement best practices around diversity recruitment and selection; updated existing processes with a focus on inclusion and belonging; oversee completion or ongoing progress of our 3 year racial equity action plan.

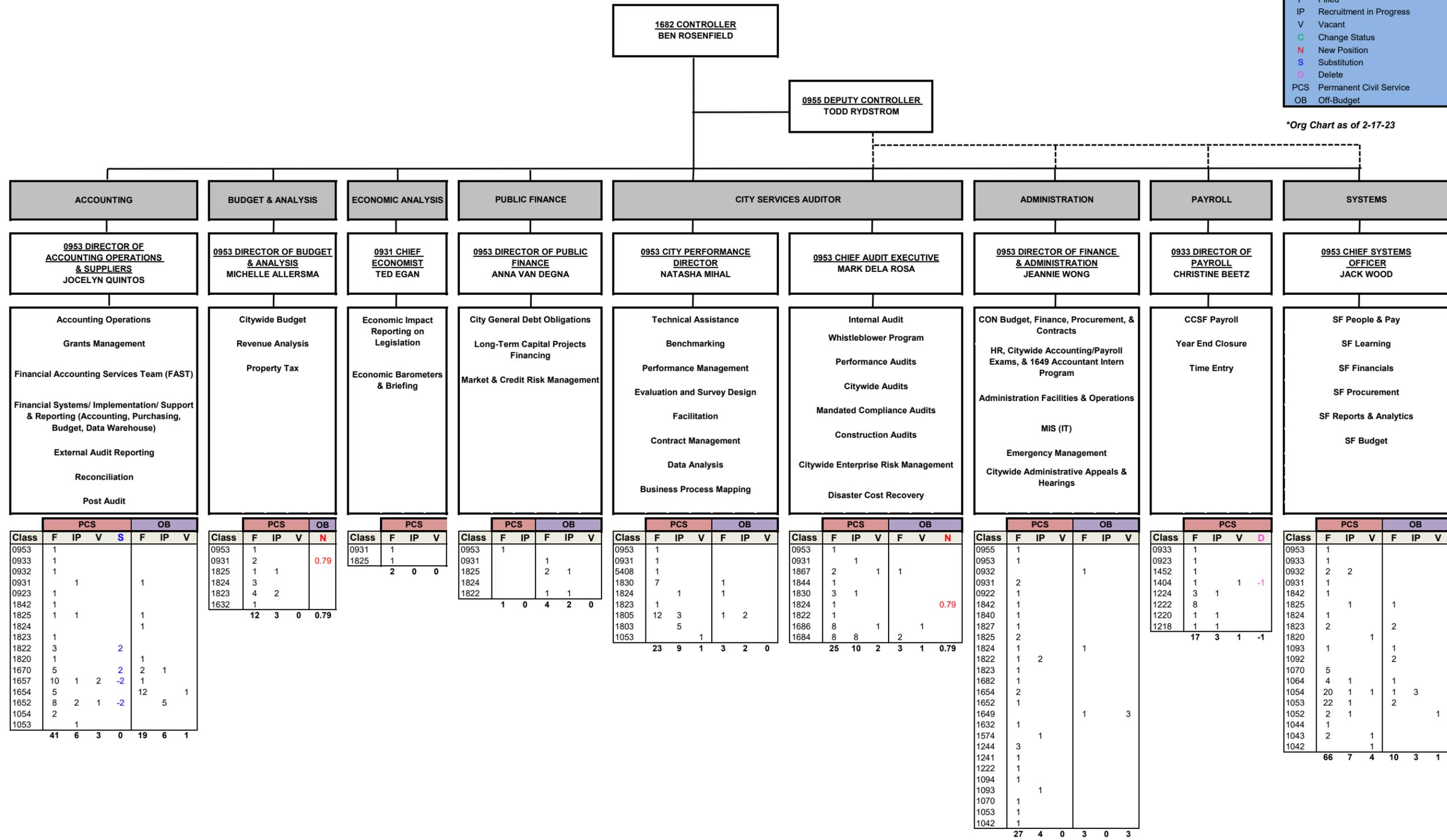

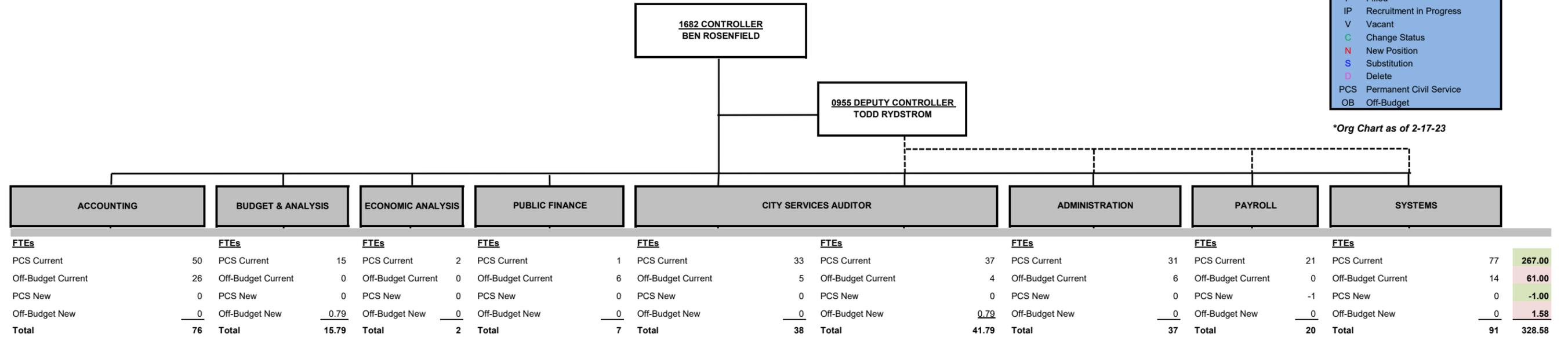
