President Collins began the meeting by welcoming newly appointed Commissioners J. Riccardo Benavides and Seth Brenzel to the Arts Commission. President Collins acknowledged Commissioners Benavides and Brenzel's expertise they bring and their impact on with in the arts and to the City. Then President Collins, reminded commissioners and the public that all meetings will be returning to in person beginning March 1, 2023; this includes City Boards, Committee meetings, and Advisory Bodies meetings. Full Commission meetings will remain hybrid and will continue to



be held at City Hall. All other SFAC related meetings will be held at the War Memorial Veterans Building room 125.

He also shared a few administrative updates regarding annual Form 700 Statement of Economic Interest, and the implementation of new assigned emails for each commissioner.

President Collins announced the hybrid meeting instructions.

Then Commission Secretary Traka Lopez-White announced public comment instructions.

Followed by President Collins began the meeting reading the Arts Commission's land acknowledgement statement.

2. AB361 Legislation Impact (11:18)

President Collins introduced the item. He reminded commissioners that the commission approved the motion at their last meeting. President Collins explained that the commission must approve the motion every 30 days to continue meeting virtually. He provided additional background information regarding the AB 361 legislation, including its requirements.

She also addressed a concern about a choreographer at SF Ballet. Lastly, Rose expressed her interest to become more involved in the art community and the SFAC.

5. Directors Report (22:31)

Director Remington welcomed newly appointed Commissioners J. Riccardo Benavides, and Seth Brenzel. Then he shared an overview of his previous month activities, that primarily took place in New York. While in New York, Director Remington met with other cultural leaders along with attending SFAC Galleries Director Carolina Aranibar-Fernandez's exhibition at Que gallery in New York City.

Following his return to San Francisco, Director Remington joined Mayor Breed for the Lunar New Year Celebration at City Hall. February 2nd, was the opening reception of the Power of Creativity & Community, exhibition at City Hall, North Light Court; presented by SFAC Galleries Program in partnership with the nonprofit Art with Elders. He announced SFAC galleries upcoming exhibit, Crossing Lines opening on March 3rd and on display until April 29th.

Next, Director Remington provided public art updates, which include the Art on Market Street Poster Series, the India Basin Shoreline Park public art project, Artists in Conversation: Highlights from the Public Art Collection program and Highlight of Black Art at SFO program.



SFAC will be launching an Arts Storm Relief Fund later this week.

Commissioner Carney inquired about concerns of vandalism incidents on public artworks. Director Lee responded by explaining protocols, reporting incidents, and maintenance.

Commissioner Shelby; inquired about the eligibility of the city's storm funding. Response by Director Lee indicated that San Francisco artists, cultural centers, and art and cultural nonprofit organizations will be eligible for funding.

Director Catapang presented report of the Arts Commission FY 2023-2024 and 2024-2025 Draft Budgets proposal. The budgetary proposal consisted of the budget developmental process, priorities, timeline, and an overview of the mayor's budget instructions and budget environment.

Commissioner Shiota commented about the logistics and actions concerning the building restoration of selected cultural centers. Director Remington and Director Lee provided some insight on the capital budget processes and funding.
