PUBLIC NOTICE IS HEREBY GIVEN, in compliance with California Code of Regulations (CCR), Title 27, §21660.3, that the San Francisco Department of Public Health, Environmental Health Branch, Solid Waste Program, acting as the Local Enforcement Agency is distributing this public notice regarding the new Registration Permit application for Excess Recovery, Inc.

The San Francisco Department of Public Health (SFDPH), Environmental Health Branch, Solid Waste Program, acting as the LEA, is certified by the Department of Resources Recycling and Recovery (CalRecycle) to enforce state laws and regulations at solid waste sites within its jurisdiction.
