#### **BUSINESS DESCRIPTION**

Bernie's Pet Shoppe, Inc. (also known as "City Dogs") is a dog grooming service that aims to minimize stress and promote the best interest of the dogs in their care without sacrificing quality. Bernie's Pet Shoppe was founded in 1989 by Bernadette ("Bernie") Machado and originally operated in the Mission District for 14 years before opening a location within the South Beach neighborhood, where it operates today and serves over 6,000 canines a year. The woman-owned business is committed to maintaining compassionate canine grooming and related services within the view of the public, which is not common in the grooming industry. Additionally, the business has been a vocal advocate in encouraging canine owners to spay or neuter their pets and is committed to providing complete transparency to their Bay Area customers about the grooming process and educates them on proper pet care.

The hands-on nature of the work by Bernie's Pet Shoppe makes them the first line of defense when it comes to identifying potential health risks of pets and their staff regularly makes referrals to veterinarians for a diagnosis and treatment of all types of health conditions. The business continues to tailor appointments to a canine's needs and cares for pets in a safe and comfortable manner.

In 2006, Carl Fieldman, the Director of the San Francisco Animal Care and Control (SFACC), offered Bernie the opportunity to operate her grooming business at the facility. Bernie provided services free of charge to thousands of dogs while they were awaiting adoption. Bernie's Pet Shoppe was the first private grooming business in San Francisco that worked within and alongside the SFACC facility.

Since 2012, staff at Bernie's Pet Shoppe voluntarily provides professional mentorship to students at the Life Learning Academy (LLA), a San Francisco Unified School District charter high school. LLA students are provided weekly lessons on the basics of bathing and caring for dogs, which allows them to develop responsibility and compassion for animals in addition to gaining academic, vocational, and social skills. The business has also partnered with the Mayor's Youth Employment and Education Program since 2017 to provide hands on training to San Francisco's youth related to job readiness skills, work experience, and personal development.

Yes, Bernie's Pet Shoppe, Inc. has contributed to the history and identity of the South Beach neighborhood and San Francisco.

The Historic Preservation Commission recommended the applicant as qualifying, noting the following ways the applicant contributed to the neighborhood's history and/or the identity of a particular neighborhood or community:

• The business is located within the Delancey Street Foundation building which has received commendations and awards from the American Institute of Architects, Urban Land Institute, and the Gold Nugget Awards. However, the property was constructed in 1989 and has not been evaluated for historic significance due to age of the building. This building also hosts training programs that provide ex-felons, substance users, and the homeless population with training on academic, vocational, and social skills in a variety of trades.

#### **CRITERION 3**

Is the applicant committed to maintaining the physical features or traditions that define the business, including craft, culinary, or art forms?

Yes, Bernie's Pet Shoppe, Inc. is committed to maintaining the physical features and traditions that define the business.



Bernie's Pet Shoppe was established in 1989, located at 714 Valencia in San Francisco's Mission district and relocated in 1992 towards 367 Valencia. It has continued to serve the Mission District until 2006. Carl Friedman, the director of the San Francisco Animal Care and Control, offered Bernie the opportunity to operate her grooming business inside the shelter itself. In 2010, Bernie expanded to a second location at 177 Brannan Street and finally consolidated all business at the location in 2022.

#### **Written Historical Narrative**

#### INTRODUCTION

#### a. Describe the business. What does it sell or provide?

Bernie's Pet Shoppe (DBA City Dogs Grooming) offers canine grooming and bathing services for Bay Area dog owners. It aims to minimize stress and promote the best interests of the dogs in their care without sacrificing quality.

#### b. Describe who the business serves.

Bernie's Pet Shoppe is located in the South Beach neighborhood and provides grooming for over 6,000 dogs per year. Their human clients span across all demographics, representing the diversity of Bay Area dog lovers. From doodles to danes, Bernie's Pet Shoppe is open to all.

c. In about 2-5 words (15-30 characters), describe what the business is known for.

Professional and compassionate canine grooming.

## CRITERION 1: The business has operated in San Francisco for 30 or more years, with no break in San Francisco operations exceeding two years

#### a. Provide a short history of the business, including locations and owners.

Bernie's Pet Shoppe was founded August 1, 1989 by Bernadette ("Bernie") Machado at 714 Valencia Street in San Francisco's Mission District.

In 1992, the business relocated to a larger facility at 1367 Valencia Street and continued to serve the Mission district at that location for 14 years.

In 2006, Carl Friedman, the director of the San Francisco Animal Care and Control (SFACC), offered Bernie Machado the opportunity to operate her private grooming business inside the SFACC then located at 1200 15th Street. The SFACC relocated to 1419 Bryant Street in February of 2020.

In 2010, Bernie Machado expanded to a second location at 177 Brannan Street in the Delancey Foundation complex.

In 2022, Bernie Machado closed the 1419 Bryant Street location and consolidated all business to the 177 Brannan Street location.

b. Provide the ownership history of the business in a consolidated year-to-year format.

1989 to Present Bernadette Machado

c. Describe any circumstances that required the business to cease operations in San Francisco for any significant length of time.

San Francisco's initial mandatory closure of non-essential businesses forced Bernie's Pet Shoppe to close for six weeks in 2020.

## CRITERION 2: The business has contributed to the neighborhood's history and/or the identity of a particular neighborhood or community

a. Describe the business' contribution to the history and/or identity of the neighborhood, community, business sector, or San Francisco as a whole.

Bernie has been a vocal advocate encouraging pet owners to spay or neuter their pets since her founding of the shop in 1989. In 2006, she agreed to operate within the city animal shelter, San Francisco Animal Care and Control, providing grooming services free of charge for thousands of dogs awaiting their forever homes and improving their chances of being adopted while elevating public awareness about shelter animals. This association makes Bernie's Pet Shoppe the first private business in San Francisco to work within and alongside the San Francisco Animal Care and Control facility.

#### b. Is the business associated with significant people or events, either now or in the past?

Carl Friedman, the former director of Animal Care and Control who invited Bernie's Pet Shoppe to relocate to the city shelter, provided over 30 years of leadership of the San Francisco Department of Animal Care and Control and Animal Welfare community.

#### c. How does the business demonstrate its commitment to the community?

The dedicated staff at Bernie's Pet Shoppe DBA City Dogs voluntarily provides professional mentorship to the students of Life Learning Academy (LLA), a San Francisco Unified School District charter high school committed to creating a nonviolent community for students who have not been successful in traditional school settings. LLA is designed specifically to serve the highest-need students in San Francisco. Once a week, LLA student interns are instructed in the basics of bathing and caring for dogs, offering the opportunity to develop responsibility and compassion for animals, and build their academic, vocational, and social skills necessary to be successful.

The staff at Bernie's Pet Shoppe has also volunteered to mentor the students of LLA since 2012 and the Mayor's Youth Employment and Education Program since 2017. The hands-on training starts in the bathing room and progresses to the job of a groomer's assistant. The goal is to

provide job readiness training, work experience, academic support, and personal development to San Francisco's youth challenged in their attempt to access employment.

In addition, the business is committed to complete transparency in the grooming process, with open windows allowing the public to look in and observe their practices. This is unusual in the grooming industry, but Bernie's staff believes that making the compassionate, humane way they treat the animals in their care visible to all, and serves to inspire public trust.

d. Has the business ever been referenced in the media, business trade publication, and/or historical documents?

Not applicable.

e. Has the business ever received any awards, recognition, or political commendations?

Not applicable.

f. How would the community be diminished if the business were to be sold, relocated, shut down, etc.?

If the business were to close, the ramifications would not be limited to a few thousand dogs going without their 'dos. Although groomers are not medical experts, the hands-on nature of their work makes them the first line of defense when it comes to identifying potential health risks. They regularly make referrals to veterinarians regarding suspicious irregularities, resulting in the diagnosis and treatment of all sorts of health conditions.

## CRITERION 3: The business is committed to maintaining the physical features or traditions that define the business

a. Is the business associated with a culturally significant building, structure, object, signage, mural, architectural detail, neon sign, or any other special physical feature that defines the business?

Bernie's Pet Shoppe is located within the 370,000-square-foot Delancey Street Foundation complex that was primarily built and supervised by Delancey residents. Mimi Silbert was the developer, and Delancey was its own general contractor for this unique development called a "masterpiece of social design" by Pulitzer Prize-winning architectural critic Allan Temko. Covering an entire city block, this four- story complex contains street level retail stores, a popular public restaurant and highly reviewed outdoor espresso café and bookstore, and several other vocational schools and housing units for 500 people that overlook a Mediterranean-style courtyard, which also holds a vast array of educational and recreational facilities for Delancey residents. This was also an unprecedented vocational training program providing 300 formerly unemployable drug addicts, homeless people, and ex-felons now in Delancey Street every skill in the building trades with the support of the unions, as well as

training in purchasing, contracting, computer, and accounting services. There is nothing else in the country like this self-built, self-managed, self-help complex. The complex has received numerous commendations including awards from the American Architects Association, Urban Land Institute, and the Gold Nugget Building Award. It allowed Delancey Street to expand its population, as well as its services, recreational and vocational opportunities.<sup>1</sup>

#### b. In a few words, describe the main business activity you commit to maintaining.

Bernie's Pet Shoppe is committed to maintaining compassionate canine grooming. All grooming services should continue to be performed within the view of the public.

#### c. What challenges is the business facing today?

The pet grooming industry faces a chronic shortage of skilled labor, and there are currently no grooming schools in all of Northern California. The region's lack of educational opportunities makes it difficult to source qualified groomers that meet their high standards.

With the COVID pandemic, San Francisco experienced a surge in pet adoptions, particularly doodle breeds that require very specific coat maintenance. Many of these dogs went to first-time owners who are still learning how to properly care for their dogs' coats. The shop regularly sees severe matting, which can cause skin irritation and lesions that can be extremely uncomfortable for the dog. Educating owners on proper care is one of the main challenges the business faces.

They have been in business for 15+ years, over which they have developed a strong body of great reviews and strong referrals. Bernie's Grooming also partnered with the San Francisco Animal Care and Control in 2006, relocating their grooming shop into the shelter. This was to ensure that shelter dogs are healthy and happy. Bernie's signature 7-step bath process is designed to leave pups clean and refreshed. The first step is a basic shampoo, then they condition to ensure healthy, moisturized skin. Ears are then cleaned, and if requested, the anal glands are expressed. Then the dogs are hand dried, their nails trimmed,

and a full brushing to remove tangles. Bernie's also does trimming to keep dogs neat and tidy. Teeth cleaning is also available upon request. They have two locations, one at 177 Brannan Street San Francisco, 94107 and the other at 1200 15th Street San Francisco, 94103.

#### **Business Description**

Bernie's Pet Shoppe, Inc. (also known as "City Dogs") is a dog grooming service that aims to minimize stress and promote the best interest of the dogs in their case without sacrificing quality. Bernie's Pet Shoppe was founded in 1989 by Bernadette ("Bernie") Machado and originally operated in the Mission District for 14 years before opening a location within the South Beach neighborhood, where it operates today and serves over 6,000 canines a year. The women-owned business is committed to maintaining compassionate canine grooming and related services within the view of the public, which is not common in the grooming industry. Additionally, the business has been a vocal advocate in encouraging canine owners to spay or neuter their pets and is committed to providing complete transparency to their Bay Area customers about the grooming process and educates them on proper pet care.

The hands-on nature of the work by Bernie's Pet Shoppe makes them the first line of defense when it comes to identifying potential health risks of pets and their staff regularly makes referrals to veterinarians for a diagnosis and treatment of all types of health conditions. The business continues to tailor appointments to a canine's needs and cares for pets in a safe and comfortable manner.

In 2006, Carl Fieldman, the Director of the San Francisco Animal Care and Control (SFACC), offered Bernie the opportunity to operate her grooming business at the facility. Bernie provided services free of charge to thousands of dogs while they were awaiting adoption. Bernie's Pet Shoppe was the first private grooming business in San Francisco that worked within and alongside the SFACC facility.

Since 2012, staff at Bernie's Pet Shoppe voluntarily provides professional mentorship to students at the Life Learning Academy (LLA), a San Francisco Unified School District charter high school. LLA students are provided weekly lessons on the basics of bathing and caring for dogs, which allows them to develop responsibility and compassion for animals in addition to gaining academic, vocational, and social skills. The business has also partnered with the Mayor's Youth Employment and Education Program since 2017 to provide hands on training to San Francisco's youth related to job readiness skills, work experience, and personal development.

The business's primary location is at 177 Brannan St, which is a Category C (No resource Present / Not Age Eligible) building located along Brannan and Delancey Street in the South Beach neighborhood. It is within the South Beach Downtown Residential Zoning District and a 45-X Height and Bulk District.

#### **Staff Analysis**

#### **Review Criteria**

1. When was business founded?

The business was founded in 1989.

2. Does the business qualify for listing on the Legacy Business Registry? If so, how?

Yes. Bernie's Pet Shoppe qualifies for listing on the Legacy Business Registry because it meets all of the eligibility Criteria:

- a. Bernie's Pet Shoppe has operated continuously in San Francisco for 34 years.
- b. Bernie's Pet Shoppe has contributed to the history and identity of the South Beach neighborhood and San Francisco.
- c. Bernie's Pet Shoppe is committed to maintaining the physical features and traditions that define the organization.
- 3. Is the business associated with a culturally significant art/craft/cuisine/tradition?

No.

4. Is the business or its building associated with significant events, persons, and/or architecture?

Yes. The business is located within the Delancey Street Foundation building which has received commendations and awards from the American Institute of Architects, Urban Land Institute, and the Gold Nugget Awards. However, the property was constructed in 1989 and has not been evaluated for historic



significance due to age of the building. This building also hosts training programs that provide ex-felons, substance users, and the homeless population with training on academic, vocational, and social skills in a variety of trades.
