GENERAL PUBLIC COMMENT

Paulette Brown: Speaks on son, Aubrey Abrakasa Jr.'s, murder. Asking for a resolution to these unsolved murders. Introduces grandson and speaks on effect of murder on her grandson.

Chief's Report

- Weekly crime trends
- Major/Significant Incidents

Assistant Chief David Lazar on behalf of Chief Scott (remotely) reported on crime trends YTD: Violent Crime up 3 percent; homicide up 25 percent; rape down 42 percent; robbery up 11 percent; assault down 0.46 percent; human trafficking down 50 percent. Property Crimes down 22 percent; burglary down 17 percent; motor vehicle theft down 20 percent; arson down 14 percent; larceny theft down 24 percent. Gun violence is up 20 percent compared to 2022; Two shooting incidents this week; total 15 incidents resulting in 18 victims YTD. One homicide for the week; there are a total of 5 homicides YTD with 5 resulting from a firearm; 125% overall clearance.

Significant Incident: Homicide 100 block of Hester, 1/31/23, gunshots heard, deceased person in vehicle. Shooting on 2/1/23, Ellis and Hyde, robbery, victim shot in leg. Shooting, person walking dog heard shots and discovered they were shot, 800 Block of Ellsworth, Ingleside, 2/3/23. 2600 Block of Balboa, Richmond, Jewish Synagogue incident, suspect shot blanks, suspect taken into custody. AAPI attack on bus, Kearny Street, suspect taken into custody. Elder abuse, AAPI, suspect threw brick and heavy object at victims, suspect taken into custody and charged. Stunt driving- coming from Oakland 150 vehicles, Jennings and Armstrong/41st and Noriega, able to prevent and intervene, got vehicles to leave area.

Significant arrest: Two subjects, along with juvenile, operation performed- 6lbs of fentanyl off street, investigation led to Oakland, additional 14 lbs of fentanyl, ghost gun, ammunition, paraphernalia, 14k in cash located.

Strategies: Department celebrated Lunar New Year with community. Community Academy for public through Community Engagement Division 2/23-4/20/23, applications on website. The 279th Recruit Class started, graduating in September. With Acting Assistant Chief Flaherty attended graduation for Leadership Development Institute, internal leadership program. Tenderloin, seized 11,844 grams of fentanyl YTD, this week 24k in cash seizures. Capp Street prostitution issues, Supervisor Ronen and AC Lazar walked the neighborhood, have strategies. Assistant Chief Lazar and Chief Scott provided update on SFPD/DA MOU.

Executive Director Henderson reported the following: In the year 2023: 53 cases opened; 74 closed; 256 pending; 7 cases sustained; 27 cases past 270-day; 1 case mediated. Cases received in the past week: 14 new cases; Central (3) Parking citation violation and retaliatory behavior. Southern (1) Failing to make an arrest. Bayview (2) Using excessive force and failing to intervene in a report of trafficking a minor. Mission (1) Failing to take action against vehicle break-ins. Northern (2) Improperly towing a vehicle. Richmond (1) Stopping a vehicle without cause and failing to activate BWC. Taraval (2) Neighbor dispute. Tenderloin (2) Failing to prepare an incident report and arresting a person outside of SFPD's jurisdiction.

Audits: DPA and Controller's Office have completed their review of SFPD's 24 month status updates on recommendations made in the 2020 Use of Force Audit, recommendations made and periodic check ins. 10 of 37 recommendations remain open.
