Re: Q2 FY19-20 Reporting on Prioritization of 100% Affordable Housing Projects (File #180547)

Enclosed please find the fourth quarterly report on MOHCD's 100% Affordable Housing Projects, as required by City Ordinance, covering Q2 19-20, the period from October 1 to December 31, 2019. This report is also submitted as part of OEWD's Executive Directive 17-02 report on all City sponsored housing developments. Progress has continued in the entitlement, permitting and construction of a number of key affordable housing developments. The following are a few highlights for this Quarter:

- **Sunnydale Parcel Q**, the first of the Sunnydale HOPE SF parcels commenced move-in of 55 family units.
- Francis Scott Key Educator Housing at 1352 42nd Avenue submitted its Site Permit application on 12/9/19 for a development in collaboration with SFUSD, which will comprise 129 units serving ParaEducators and Teachers in the San Francisco Unified District.
- **455 Fell (Central Freeway Parcel O)**, achieved 100% lease-up during this quarter of 108 family units (including 33 for formerly homeless families).
- **1296 Shotwell** received its Temporary Certificate of Occupancy on 11/13/19 for 94 units of Senior housing and is currently leasing up units.
- **735 Davis and 88 Broadway**, two projects concurrently developed on adjacent City and Port sites, comprise 53 Senior and 125 Family units, respectively, have progressed in vertical construction ending the quarter at approximately 28% and 20% completion, respectively.
- At this time, approximately **966 multifamily units are under construction, with another 1,780 units** in active predevelopment (new construction, 100% affordable rental only).

Ongoing challenges exist in the areas of electrical service design and provision due to coordination of PUC and PGE design and installation requirements. MOHCD is pleased to see the Permit Centers' Electronic Plan Review (EPR) pilot commencing in February however, and anticipates improvements in speed and quality of the permitting process as this becomes more fully adopted. MOHCD has proposed 1-2 affordable housing projects for this pilot.
