Chief's Report

- Weekly crime trends
- Major/Significant Incidents

Assistant Chief David Lazar on behalf of Chief Scott reported on crime trends YTD: Violent Crime up 4 percent; homicide up 17 percent; rape down 43 percent; robbery up 17 percent; assault down 2 percent; human trafficking down 33 percent. Property Crimes down 15 percent; burglary down 8 percent; motor vehicle theft down 17 percent; arson up 19 percent; larceny theft down 16 percent. Gun violence is down 4 percent compared to 2022; Two shooting incidents this week; total 19 incidents resulting in 23 victims YTD. No homicides for the week; there are a total of 7 homicides YTD with 6 resulting from a firearm; 114% overall clearance.

Significant Incident: Two shooting incidents – 1st shooting 2/21/23 19:20 at McLaren Park Ingelside District, unknown subject approached victim from behind and demanded their belongings, as victim turned to face subject the subject shot the victim and fled, no arrest made. 2nd shooting 2/26/23 03:26 Ferry Building, Central District, subject attempted to take victim's property at gunpoint, subject shot victim and fled, victim transported, no arrest made.

Uptick in burglaries at cannabis dispensaries. On 2/26/23 00:46, 500 block of Brannan, dispensary employee kidnapped and brought to Oakland-returned to dispensary where multiple suspects accompanied victim in and robbery took place.

Significant arrest: Hate crime near Headquarters, 400 block on China Basin, 2/22/23 23:38 an individual called another individual a derogatory name several times before striking the victim multiple times with a cane, Southern Station made arrest. Part of attempt to arrest Fentanyl sellers in the Tenderloin, Officer engaged in foot pursuit and injured, suspect taken in to custody.

Strategies: Encourage Officers to be connected with dispensary owners and keep up relationships. Decline in burglaries overall. Stunt driving response unit working overnight- stunt shows on 24th and Mission 2/25- dispersed, CHP assisted, violators stopped, others left to Richmond, CA, another one at Broadway and Embarcadero 2/26-group dispersed and headed for bridge, Officers prevents stunt drivers from setting up in SF. Enforcement- operations in Tenderloin and Capp Street. Coffee with a cop on Capp St at 9pm on 3/1.

Community engagement- Polar Plunge, raise money for Special Olympics.

Part of Captain's Complimentary reports: 1/24/23 – around midnight Shot Spotter around 1500 Block of Golden Gate, Northern Station. Officers found suspect armed hiding behind vehicle. Officers deescalated situation, blockade, time and distance, negotiations, safety equipment. Officers talked suspect into custody. Applied latest department tactics to avoid officer involved shooting.

Executive Director Henderson reported the following: In the year 2023: 96 cases opened; 110 closed; 265 pending; 7 cases sustained; 26 cases past 270-day; 2 cases mediated. Cases received in the past week: 27 new cases; - Central (3) Improperly parking a vehicle, using excessive force, and improperly detaining a person. Southern (2). Bayview- Inappropriate comments. Mission (5)

Improperly issuing a citation, failing to respond to a domestic violence call, harassing a person on social media, and arresting a person without cause. Northern (2) Failing to make an arrest, write an incident report, illegally detaining a person for littering, and using excessive force. Park (1) Failing to respond to a call for service. Ingleside (1) Failing to write an incident report. Taraval (1) Writing an incorrect incident report. Tenderloin (6) Illegally detaining a person for littering, inappropriate comments, and failing to take action. Airport (1) Failing to assist an individual lost at SFO. Not Applicable (2) Referral to DEM. Out of Town (2) Referral – Other Police Dpts. Pending (1).

Audits: Preparing to send draft of next misconduct report on SFPD's electronic monitoring of communications to SFPD for review. Final step – input for that review before it gets published.

Outstanding Issues: From Legal Team- uptick in SFPD denials of DPA requests. DPA will continue to track inhouse issue.

Outreach: Last week DPA hosted CCOA (California Coalition Oversight Agencies)- two day state conference to discuss perspectives and best practices on police reform throughout the state, Keynote address, CLE Training, CMCR Training with SFPD. The conference ended with open panel. DPA presenting this week at the Hayes Valley Neighborhood Association on 3/6, presentation open to public. Diana Rosenstein, Chief Attorney, participated in panel discussion for National Counsel of Jewish Women regarding national efforts for police reform.
