Paulette Brown: Spoke about son, Aubrey Abrakasa Jr.'s, unsolved homicide. Spoke on homicide rewards and other ways to come forward regarding unsolved homicides. Gave names of perpetrators. Provided personal story regarding son's murder.

Chris Romero: Executive Director of San Francisco Municipal Executives Association, referenced February 15<sup>th</sup> Commission Meeting where a city employee was questioned by Vice President Carter-Oberstone. Spoke on interrogation and entrapment of city employees at Commission Meetings. Spoke on how Commissioners should be speaking to city employees with respect. Commissioners respond.

### **Chief's Report**

- Weekly crime trends
- Major/Significant Incidents

Chief Scott reported on crime trends YTD: Violent Crime up 6 percent; homicide N/C; rape down 31 percent; robbery up 18 percent; assault down 2 percent; human trafficking down 50 percent. Property Crimes down 15 percent; burglary down 10 percent; motor vehicle theft down 17 percent; arson up 9 percent; larceny theft down 15 percent. Gun violence is even compared to 2022; Seven shooting incidents this week; total 30 incidents resulting in 33 victims YTD. One homicide for the week; there are a total of 8 homicides YTD with 7 resulting from a firearm; 100% overall clearance.

Significant Incident: One homicide, Central District, 2/27/23 01:00, Pier 5, witness heard a pop followed by a male yelling, witness went outside and saw victim leaning against wall, witness call 911,

victim pronounced at scene, no arrests made, investigation ongoing. Suspicious death on 3/1/23 21:07, 200 block of Taylor, victim and acquaintance were in an apartment, residents left victim there, acquaintance called resident and stated that they were smoking an unknown substance, acquaintance saw victim asleep early in the morning and left again, when acquaintance returned victim was not breathing, 911 called, victim pronounced at scene, ruled suspicious death, waiting on Medical Examiner's determination on cause. Seven non-injury shootings – two in Southern (200 block of 9<sup>th</sup>, 900 block of B Ave on Treasure Island), two in Bayview (Fitzgerald and Jennings 2/28, George Court 3/4), Ingleside (LaSalle) and two at unknown locations, don't appear to be related, no arrests made, all investigations on going.

Significant arrest: Bayview, 1000 block of Kansas, attempted kidnapping of baby, suspect apprehended, case has been presented to DA's Office. Incident on Riordan High School grounds, battery of basketball player from opposing team, fight during game, punched from behind, started a brawl, no arrests made, investigation ongoing.

Strategies: Tenderloin operation still on going. 63% increase in Fentanyl YTD. Seized over 50,000 grams of Fentanyl. Number of strategies to disrupt drug sales.

DPA Attorney, Diana Rosenstein on behalf of Executive Director Henderson reported the following: In the year 2023: 112 cases opened; 117 closed; 273 pending; 8 cases sustained; 24 cases past 270-day; 2 cases mediated. Cases received in the past week: 13 new cases; - Bayview (1) Failing to investigate and take required action. Mission (1) Failing to write an incident report regarding a stolen license plate. Park (1) Officers harassed and threatened the complainant's family and accused his minor daughter of engaging in illegal activity. Richmond (2) Failing to return a call and harassing a person. Ingleside (1) Failing to conduct a wellness check. Tenderloin (3) Failing to provide name or badge number and failing to respond to calls of service. Airport (1) Failing to provide name and start number. Not Applicable (3) Inappropriate comments and failing to investigate.

Audits: N/A

Outstanding Issues: 87 pending cases for Chief's Hearings. Over 25 cases are 2 years old. Have solution moving forward, incorporate language for DGO 2.07.

Outreach: DPA presented at the Hayes Valley Neighborhood Association community meeting on March 6<sup>th</sup>, provided information about organization and discipline process. Presented at Bayview Station community meetings. Mediators received implicit bias training, Captain Canning spoke to mediators. Commissioner Benedicto: Serving as audit liaison to DPA, quarterly meeting next week to get status of audits. Accompanied AC Lazar to community event on Capp Street. DGO 7.01 significant progress, 2<sup>nd</sup> to last meeting tomorrow. Commended Commander Moran for work in working group. Moving forward on DGO 10.11 Body Worn Cameras, extension granted by Commission.

Vice President Carter-Oberstone: Met with Department and DPA to discuss DGO 8.10 First Amendment Surveillance Activities, working group moving forward, tentatively set start date for late March, discussing groups and individuals that might be invited to groups.

Commissioner Yee: Recognized International Women's Day. Thanked Chief on 30x30 initiative. Percentages headed in right direction. Thanked women of the Command Staff, DPA, Commission and City Attorney.
