2. BOS File 230312 – Curbside Shared Spaces Permit and License Fees (Discussion and Action Item)

Supervisor Safai presented an ordinance amending the Public Works and Administrative Code to eliminate permit fees for Curbside Shared Spaces and increase the gross receipts threshold from \$2,000,000 to \$2,500,000 for reductions to annual Curbside Shared Spaces license fees.

Ms. Acevedo presented the Workforce Employer Concierge tool that both employers and job seekers can utilize to find employers and employees.

Commissioner Comments:

Ortiz-Cartagena: The job fairs are amazing

Carter: The concierge service is great. How do employers find out about the tool? Word of mouth.

Zouzounis: How can we better reach microbusinesses? We need more funding to help with small business hiring.

Herbert: How do you measure impact? Main KPI is unemployment rate.

Huie: How many employees are on this? 700!

Tang: Note that OSB already works with Workforce to proactively support when a business is hit by disaster etc.
