Motion to pursuant to Charter Section 16.106(1), to authorize the Director of Cultural Affairs to enter into an agreement with the San Francisco Symphony to support a free outdoor concert, and live performances in Davies Symphony Hall during the Symphony's 2022-23 season for an estimated amount from the Controller's office of FY 23-24 ad valorem tax \$4,259,460 and not to exceed \$6,000,000.
