**Chief's Report**

- Major/Significant Incidents

Chief Scott reported on crime trends YTD: Violent Crime up 6 percent; homicide up 20 percent; rape down 22 percent; robbery up 14 percent; assault up 2 percent; human trafficking down 67 percent. Property Crimes down 11 percent; burglary down 11 percent; motor vehicle theft down 8 percent; arson up 6 percent; larceny theft down 12 percent. Gun violence is up 6 percent compared to 2022; Three shooting incidents this week; total 48 incidents resulting in 51 victims YTD. No homicides for the week; there are a total of 12 homicides YTD with 8 resulting from a firearm; 90% overall clearance.

Significant Incident: Two homicides. April 1, 2023, 13:04, Golden Gate and Leavenworth, victim located with gunshots, victim shot by suspect, succumbed to injuries, no arrests made. April 4, 2023, 02:34, Folsom and Harrison, Department awaiting approval from Medical Examiner to release specific information, victim called 911 advised he had been stabbed but did not provide location, Officers located victim, Officer rendered aid until SFFD arrived, victim succumbed to injuries, ongoing investigation. Three shootings- 1<sup>st</sup> on March 29, 2023, 9:40 p.m., 800 block of Missouri, Officers responded to a shot spotter activation, located victim who advised he heard loud bangs and realized they were shot, victim did not see suspect, recovered video from area, video being followed up on, no arrests made, investigation ongoing. 2<sup>nd</sup> on March 20, 2023, 11:14 p.m., Willow and Van Nuys, victim and witness passenger in their parked vehicle, unknown subject fired gun at victim, victim struck a bystander with vehicle as they were leaving scene, victim transported for gunshot wound, non-life-threatening injury, bystander received minor injuries, no arrests made, investigation ongoing. 3<sup>rd</sup> on April 1, 2023, 10:36 p.m., Officers responded to a shot spotter activation, 1100 block of Scott Street, Northern District, juvenile victim located with a gunshot wound to leg, juvenile near their residence, victim transported with non-life-threatening injuries, no arrests made, ongoing investigation.

Significant arrest: 1/22/23 Homicide, victim suffering from gunshot to chest located on 300 block of LaGrande Ave, arrest made on that case, 10-15 people involved in this incident, received information to serve warrant, suspect taken into custody. Invasion of privacy 11/15/2022, secret recording device in changing room at business, suspect identified 3/25/23, search warrant served, arrested on 6 misdemeanor counts.

Strategies: Tenderloin Narcotics arrests on going, 2018- 175 Buy Busts, 2021- 194 Buy Busts, 2022- 97 Buy Busts, YTD- 22 Buy Busts. Tenderloin Officers- plain clothes and narcotics investigation training, deployed by Captain to engage in narcotics enforcement, made 18 arrests, Narcotics unit 4 arrests. Fentanyl seizures increases YTD 169% compared to 2022, 883% compared to 2021, 70% of all seizures this year have been Fentanyl. Mission – 16<sup>th</sup> and 24<sup>th</sup> - illegal vending, narcotics, quality of life, Officers posted in area, keeping track of.

Chief's Hearings: cases still pending hearing from 2018- 6 cases (2 DPA, 4 IAD), 2019- 3 cases (3 DPA), 2020- 26 cases (13 DPA, 13 IAD), 2021- 53 cases (29 DPA 24 IAD), 2022-15 (11 DPA, 4 IAD), total 103 over last 4 years (58 DPA, 45 SFPD).

Executive Director Henderson reported the following: In the year 2023: 188 cases opened; 191 closed; 278 pending; 14 cases sustained; 22 cases past 270-day; 5 cases mediated. Cases received in the past week: 30 new cases; - Central (4) Making an inaccurate report and comments. Southern (2) Failing to investigate a traffic accident. Failing to return firearm seized by SFPD. Mission (7) Improperly restraining a person. Failing to take a private citizen's arrest. Failing to obtain an emergency protection order. Northern (3) Failing to respond to calls for service. Failing to arrest for trespassing. Richmond (2) Failing to respond to calls for service. Driving improperly. Ingleside (4) Failing to investigate a claim of assault. Making inappropriate comments and failing to prepare an accurate police report. Tenderloin (5) Using excessive force during an arrest and failing to take a report. Not Applicable (3) Referral. Officers failed to respond to a traffic collision.

Audits: March 20<sup>th</sup> DPA issued a key issue report on SFPD's monitoring of departmental communications for bias. Report available online, includes 4 key solutions.

Outstanding Issues: on March 25<sup>th</sup> Association of Governmental Auditors announced DPA's Audit of SFPD received national award for an audit review. Acknowledged their audit team, 2<sup>nd</sup> award won.

Outreach: Legal team, Diana Rosenstein, met with Deputy Director of King County in Seattle, working with their oversight agency, looking at San Francisco's model(s).
