
### Re: San Francisco Department of Police Accountability April 2023 Monthly Statistical Report


Dear President Cindy Elias and San Francisco Police Commissioners:

#### **Summary of Complaints Received in April 2023**

The Department of Police Accountability received a total of **73** cases in **April 2023**, **68** SFPD complaints and **5** SFSO complaints. Compared with a total of **66** cases, **64** SFPD complaints and **2** SFSO complaint, in the same period last year, the **April 2023** case total is **6%** higher than the five-year average and the **11%** higher than the previous year.


From January through April, the DPA received a total of **272** new cases, **258** SFPD complaints and **14** SFSO complaints. Compared with the **229** cases filed during the same period in 2022, **223** SFPD complaints and **6** SFSO complaint. The April year to date case total represents an **19%** increase in new complaints over last year.
