


Dear President Cindy Elias and San Francisco Police Commissioners:

Summary of Complaints Received in March 2023

The Department of Police Accountability received a total of **80** cases in **March 2023**, **76** SFPD complaints and **4** SFSO complaints. Compared with a total of **56** cases, **53** SFPD complaints and **3** SFSO complaint, in the same period last year, the **March 2023** case total is **19%** higher than the five-year average and the **43%** higher than the previous year.


From January through March, the DPA received a total of 197 new cases,188 SFPD complaints and 9 SFSO complaints. Compared with the 163 cases filed during the same period in 2022, 159 SFPD complaints and 4 SFSO complaint. The March year to date case total represents an 21% increase in new complaints over last year.
