Chief's Report

- Weekly crime trends
- Major/Significant Incidents

Chief Scott reported on crime trends YTD: Violent Crime up 4 percent; homicide up 13 percent; rape down 25 percent; robbery up 12 percent; assault down 0.26 percent; human trafficking down 50 percent. Property Crimes down 9 percent; burglary down 10 percent; motor vehicle theft down 1 percent; arson up 7 percent; larceny theft down 10 percent. Gun violence is down 3 percent compared to 2022; Two shooting incidents this week; total 58 incidents resulting in 65 victims YTD. Two homicides for the week; there are a total of 17 homicides YTD with 12 resulting from a firearm; 100% overall clearance.

Significant Incident: Two Homicide incidents, 1st- 4/27/23 18:30, 800 block of Market, Security guard at a business and shoplifter, attempted to detain shoplifter, physical altercation occurred, shoplifter/victim left the store and turned to the security guard, spat on the guard, victim raised their arm toward security guard, security guard drew a firearm and shot toward the victim, victim struck, victim died of injuries, security guard detained and arrested, open investigation, DA did not file charges on case, investigation still ongoing . 2nd Homicide, 4/30/23 04:35, 900 block of Folsom, Subject shot victim at close range as victim sat in car, two friends in car were unharmed, witnesses gave detailed account of subjects involved, no arrests, investigation ongoing. Two shooting incidents, 1st- 100 block of Sadowa, Taraval, 4/26/23 14:05, Officers arrived in area of shooting, victim outside of vehicle with multiple gunshot wounds, several witnesses, investigation ongoing, victim status, non-life threatening. Stabbing 4/27/23 02:18 300 block of Grant, Tenderloin, victim told an Urban Alchemy staff member that he had been stabbed, when Officers arrived victim provided no further information, victim transported in stable condition, investigation ongoing. Battery with serious injury/Elder Abuse, 4/28/23 20:39, Market and Noe, Mission District, two victims walking when unknown subject ran towards their direction, flung his body into victim 2 causing victim 2 to fall into victim 1, victim 1 fell to concrete hit her head and lost consciousness, investigation ongoing.

Significant arrest: 2nd shooting- 4/30/23 21:38, 7th and Stevenson, Tenderloin, Officers located a victim with gunshot wound, victim transported in stable condition, victim did not provide any information, witnesses saw a possible suspect boarding a bus heading towards Mission District,

subject located at 16th and Mission, firearm recovered, suspect taken into custody. Shooting incident on 4/23/23 20:58 Grant and Columbus, on 4/24/23 suspect taken into custody. Robbery with gun series, 2/22-3/9/23 along area of 16th and Mission, suspects identified through video footage, third suspect identification not confirmed, warrants issued for two identified subjects, two subjects located on 4/21/23 at 18th and Mission, foot pursuit and taken into custody, Officers recognized a subject as the third suspect, subject vehicles towed.

Strategies: Tenderloin, 8,058 gross grams on Fentanyl seized this passed week, seized 47,125 grams in 17 weeks YTD, increase of 177% compared to 2022. 15 arrests for possession of sales, mostly in Tenderloin, total arrests YTD 284. CHP deployment, started on 5/1, discussed objectives.

DPA Director's Report

- Report on recent DPA activities, and announcement

Executive Director Henderson reported the following: In the year 2023: 252 cases opened; 262 closed; 270 pending; 23 cases sustained; 26 cases past 270-day; 6 cases mediated. Cases received in the past week: 35 new cases; - Central (7) Detaining, harassing, and a person without cause. Using excessive force during an arrest and behaving inappropriately. Southern (6) Refusing to take a report, failing to receive a private person's arrest, and issuing a citation without cause. Bayview (4) Traffic violations and making inappropriate comments. Mission (2) Failing to take required action. Failing to address a crime witnessed by officers. Northern (2) Failing to take required action. Park (2) Failing to write an accurate incident report. Making an inappropriate comment. Richmond (2) Detaining a person without reasonable suspicion. Harassing and displaying threatening or intimidating behavior. Ingleside (1) Failing to write an accurate incident report. Making an inappropriate comment. Tenderloin (5) Failing to write an accurate incident report. Making an inappropriate comment. Engaging in selective enforcement. Not Applicable (1) Referral. Pending (3) Pending further investigation.

Audits: DPA and Controller's Office are following up with SFPD on status of open recommendations from 2020 Use of Force Audit. 37 Recommendations made, 10 are considered open after the last review. DPA issued another key issue report as part of misconduct audit-report on SFPD's handling of Officer discipline and discusses SFPD's use of holding discipline in abeyance and timeliness of Chief's disciplinary hearings.

Outstanding Issues: Joint Discipline Tracker- program where SFPD can independently log in to track Officers' cases, waiting for funds to be approved by COIT.

Outreach: Invited members of the public to provide feedback and recommendations on policy revisions, currently three policies that are receiving public comment- 1. Critical Incidents, Critical Response Team, 2. Foot Pursuits, 3. SFPD's Training Plans.


