


Dear President Cindy Elias and San Francisco Police Commissioners:

Summary of Complaints Received in May 2023

The Department of Police Accountability received a total of **58** cases in **May 2023**, **56** SFPD complaints and **2** SFSO complaints. Compared with a total of **61** cases, **59** SFPD complaints and **2** SFSO complaint, in the same period last year, the **May 2023** case total is **6%** lower than the five-year average and the **5%** lower than the previous year.


From January through May, the DPA received a total of **329** new cases, **314** SFPD complaints and **15** SFSO complaints. Compared with the **290** cases filed during the same period in 2022, **282** SFPD complaints and **8** SFSO complaint. The May year to date case total represents an **13%** increase in new complaints over last year.
