SBDC partners with nonprofit organizations and the Office of Small Business as part of a larger family meant to help entrepreneurs. Advisors are not alone in the endeavor of helping a business by yourself.

Program	SBDC gets a lot of micro-enterprises and solo entrepreneurs looking for one-on-one advising and trainings versus businesses with a specific problem, limited time, and a focus on solutions to reach desired outcomes. SBDC is interested in economic development and vibrant commercial corridors. As SBDC diversifies our client portfolio, there may be a need for parternship building and system design. A case could be made for strategic partnerhsip and system design to fall under sub-area 6. Management & Operations (a. Restaurant Management , b. Retail Management , c. Brick-and-mortar). Strategic partnership has a lot of intersectionality, so the focus is on how it aligns with what the entrepreneur is looking for. Because this is nuanced, make sure to present your expertise in your application, and whether there is a specialization under one of the sub-areas which relates. For example, systems design could relate to corporate contracting, physical space design, hiring systems, etc. Clarify your particular experience and how it relates to the sub-areas you select.

Under the management and operations section, when thinking about brick-and-mortar, the RFQ wants consultants that can help entrepreneurs with maintaining a physical presence in SF by understanding their strategy to bring foot traffic to their business, understanding their costs to operate a physical location, assisting them with navigating licenses and permits, and potentially accessing capital for tenant improvements.

Program	Yes, you can collaborate with other consultants within the SBDC. If looking to collaborate with other organizations that are not applying directly to the RFQ, respond to the RFQ with the organization in mind and make sure to highlight what their expertise is in. At the time of contract, if awarded, you can list them as subcontractors.

I attended the Technical Assistance Conference yesterday where it was mentioned that references from 10 clients are requested in the application process. Since I am already an SBDC advisor, is it necessary for me to submit information about my SBDC clients?	Program	Applicants are required to submit the following, among other items: the RESUME should document at least three years of experience. The CLIENT LIST requires a minimum of 10 small businesses consulted or trained, regardless of how many subareas you select for consideration. For example, If you select 11 sub-areas, you are welcome to list 11 (or more) small businesses. Please make sure to identify which sub-areas were part of the support provided to each client. The REFERENCES require contact information for only 3 small businesses served (regardless of how many sub-areas are selected). Current SBDC advisors are under a confidentiality agreement which precludes disclosure of SBDC client identity. Current and prior SBDC experience should be identified in the resume. The Client List and References can include SBDC clients served by using the client's NeoSerra CLIENT ID ONLY, in order to maintain confidentiality.

Some of the other documentation such as business insurance proof, license, and SAM.gov is requested later. Is that correct?	Admin	Page i of RFQ 227 lists the mandatory minimum qualification documentation due with each online submission: the online application, resume, client list, and references. Part III, Proposer Checklist, page 3 of the Appendix A Application Questions, provides certain key compliance items required prior to contract execution. Depending on entity type, contractors will be required to have reached compliant City Supplier status, and to provide current SAM registration, insurance, First Source Hiring form, among other items. OEWD staff will provide specific requirements during the contract drafting process, but reaching compliant status in advance is recommended to expedite contract processing. In particular, the SAM registration/renewal process can be very lengthy. Compliance with the San Francisco Treasurer and Tax Collector's Office, as well as the 12B Equal Benefits program, were covered at our Technical Assistance Conference. This would be really helpful for us to get a better idea on what types of services we could offer. Also, would it be possible to see their proposals?		Yes, we can provide a list of current or previous SBDC consultants. However, since the program has been running since 2014, it would be time-consuming for us to pull a complete list. Alternatively, images and bios for the current SBDC advisors are located on the SBDC website: https://www.sfsbdc.org/about/team/?tm_category%5B%5D=20. We do not have a proposal for Port Labs; they are listed on the website as a SBDC regional affiliate, and not as an applicant to our previous procurements. Yes, we can provide proposals from the advisors who got into contract with SBDC. Again, this would be a very large number if we went back all the way to 2014, so can you please specify how many you would like to review, or within what timeframe? Perhaps upon reviewing the current advisors, you may identify a specific selection (although certain information would be redacted). Also, please remember that whereas a Request for Proposals (RFP) requests service proposals, a Request for Qualifications (RFQ) such as RFQ 227 asks for demonstration of experience providing the set of services outlined in the procurement. Rather than offering services, RFQ respondents will identify which sub-areas to be considered for, and will present relevant experience in those categories. One tip for a faster response: please separate your questions for different procurement into separate emails. We have different team members responding to different procurements, so our RFQ 227 team can respond more quickly if the subject identifies 227. Please remember that today Tuesday 8/23 at Noon is the deadline for substantive questions. After that we will be limited to technical questions (e.g. about the online application). Since presumably the proposals will be sent to you after the deadline, we will not be able to answer any questions about them. Make sure to allow enough time to submit the online application by the deadline. As volume increases close to the deadline, application from consideration.
