Chief's Report

- Weekly crime trends
- Major/Significant Incidents

Chief Scott reported on crime trends YTD: Violent Crime up 2 percent; homicide up 8 percent; rape down 24 percent; robbery up 12 percent; assault down 5 percent; human trafficking down 42 percent. Property Crimes down 6 percent; burglary down 8 percent; motor vehicle theft up 8 percent; arson up 4 percent; larceny theft down 9 percent. Gun violence is up 11 percent compared to 2022; Two shooting incidents this week; total 100 incidents resulting in 120 victims YTD. Two homicides for the week; there are a total of 28 homicides YTD with 19 resulting from a firearm; 85% overall clearance.

Significant Incident: Two homicides. 1st on 800 block of Jamestown, 7/4/23, 22:30, victim saw his son, confronted his son, son ran away, victim followed at that time son shot victim, victim was transported but succumbed to injuries, no arrest, investigation ongoing. 2nd on 3rd and Egbert, victim and husband walking in area, unknown person walked up and pushed victim, victim lost balance, fell and struck her head, transported but succumbed to injuries, investigation ongoing, have good leads. Two non-fatal shootings. 1st on 1800 block of Sunnydale and Ingleside, 7/4/23, victim sitting in vehicle, unknown subject opened fire and struck subject, victim transported in stable condition, no

life-threatening injuries, no arrests, investigation ongoing. 2nd on Golden Gate and Leavenworth, 7/8/23, 05:08, victim located in streets with gunshot wound, no suspect information at this time, victim has life threatening injuries, no arrests. Shots fired at Franklin and Broadway, Northern, 7/5/23, 18:47, witnesses heard gunshots, two vehicles traveling near each other, occupants of both vehicles discharges their weapons at each other, one vehicle located unoccupied with casings inside at California and Octavia, uninvolved vehicle damaged, CHP stopped another vehicle at 8th and Stevenson, confirmed driver matched video of the driver leaving the vehicle at the scene of the shooting, investigation ongoing for subject.

Significant arrest: Narcotics- on 6/26/23 search warrants were obtained for two subjects identified as selling Narcotics in the Tenderloin. On 6/28 Subjects located and probable cause was developed for arrests. Subjects placed into custody. Search resulted in seizure of Fentanyl, Cocaine salt, Cocaine base, Meth, Heroin and Oxycodone. Search at residence in Oakland located narcotics and large amounts of US currency. Both subjects booked for multiple charges.

Strategies: Tenderloin- Officers seized 3519 gross grams of Fentanyl. YTD seized 72,036 gross grams of Fentanyl in 27 weeks, 3 times more than 2022, increase of just under 200%. Total Narcotics seized year to date 110,500 grams of Narcotics, compared to 2022 169% increase. Enforcement on drug dealers 463 arrests this year, double from 2022.

DPA Director's Report

- Report on recent DPA activities, and announcement

Chief of Staff, Sara Hawkins, on behalf of Executive Director Henderson reported the following: In the year 2023: 390 cases opened; 392 closed; 283 pending; 32 cases sustained; 19 cases past 270-day; 15 cases mediated. Cases received in the past week: 39 new cases; - Central 7-An officer parked a personal vehicle of redlines and failed to curb the front wheels. Officers did not investigate properly and misconstrued the incident as a "Hate Crime" and was taken to hospital for Mental Health. Southern 7- Officers failed to provide assistance to a person who sought their help. This person was actively being followed, harassed, and threatened. The officer did not arrest a burglary suspect and did not write an incident report. Bayview 5- Officers illegally search a home. They were aggressive and unprofessional while doing so. Mission 6 -Officers failed to properly investigate a battery and improperly cited an individual. An officer threatened to harm a person and did not activate their body-worn camera during the exchange. Northern 3 -The officers were verbally aggressive towards the complainant. Officers failed to notify when the owner's vehicle was recovered. Richmond 1-An officer-involved shooting occurred involving one officer and a male subject. Ingleside 3- The complainant stated that officers failed to take a report and rushed him out

of the station. Taraval 1 - The officer behaved inappropriately and issued an inaccurate citation. Tenderloin 3 - The officer arrested the complainant without cause and treated the complainant unfairly. Airport 1- An officer spoke inappropriately and issued a citation without reason. Not Applicable 1- The officer made a stop without cause, used excessive force, and foul language towards the complainant. Another officer used unnecessary force against the complainant's partner. Out of Town 2- An officer was removed from the Narcotics Unit at the same time as one of the drug cases the officer was involved in was dropped at court due to potential disciplinary issues. The complainant alleged a failure to protect an informant.

Audits: Last week sent draft of full misconduct audit to controller's office for an independent review. As soon as it is cleared at the controller's office DPA will submit to SFPD for their response.

Outstanding Issues: Increase of case load compared to 2022.

Cases received in the past week: 13 new cases; Central-4-Officers improperly parked their vehicle. Officers failed to respond to a complaint in a timely manner. Southern-2-Officers were disrespectful and rude. Officers pointed their guns and screamed at complainant. Mission-1-Officers responded excessively

and inappropriately to detain a group of minors. Park-1-The officer drove improperly and failed to check if the complainant was injured. Richmond-2-Officers did not respond to the complainant's call and failed to investigate. Taraval-3-The officer unlawfully detained complainant. 
