President Collins announced the hybrid meeting instructions.

Chief of Staff Ventre announced public comment instructions.

President Collins began the meeting by reading the Arts Commission's land acknowledgment statement.

2. Approval of the Minutes (6:57)

Commissioner Stryker, seconded by Commissioner Shiota moved to approve the August 7, 2023, minutes.

There was no public comment.

The motion was unanimously approved.

3. General Public Comment (8:40)

There was no public comment.

4. Directors Report *(10:25)*



Director Remington reported on participating in several events from the past month including a press event for Edge on the Square celebrating their first Executive Director Joanne Lee on August 17 and an Arts Loan Fund Arts Exchange gathering on August 30. He said he attended A.C.T.'s opening night for *Hippest Trip - The Soul Train Musical* on September 6 and he also attended the Chinese Culture Center's 58th anniversary gala, on September 8. He said he attended the World Arts West Dance Festival at Presidio Tunnel Tops on September 10.

Director Remington shared program updates. He said the Community Investments team is working on several items including the Arts Impact Endowment (AIE) Project-Based Initiative, onboarding eight cultural ambassadors to strengthen outreach, and the eligibility and panel process for the Dream Keeper Initiative. He also recognized some Public Art initiatives which included a kick of the construction phase for the Mission Branch Library's collaboration with the San Francisco Public Library and SF Public Works. He said the highlight of this project is the commissioned artwork by Juana Alicia, titled *Nopal De La Misión*. He also noted Request for Qualifications (RFQ) for the Gene Friend Recreation Center Improvement Project's Public Art Project are due September 18. He shared updates on the ongoing restoration work of the iconic 'Mechanics Monument' by Douglas Tilden. He announced the new exhibit at San Francisco's City Hall, titled A Public Voice/Una Voz Pública: From the Archive of Mission Cultural Center for Latino Arts. He shared that the opening reception is scheduled on September 20 at the North Light Court at City Hall. He also congratulated Galleries staff for their 2-day symposium celebrating the remarkable influence and work of Juana Alicia.

Director Remington announced the appointment of the newest Deputy Directors: Sarah Hollenbeck as the Deputy Director of Finance & Administration and Lex Leifheit as the Deputy Director of Programs. He said they both officially assumed their roles on September 8.

Deputy Director of Programs Leifheit thanked Director Remington. She said she was honored to be joining the Arts Commission and looked forward to working with the Commission, Director of Cultural Affairs and staff.



Deputy Director of Finance and Administration Hollenbeck also thanked Director Remington. She said she was thankful for the opportunity to marry her professional experience with her love for the arts. She said that it's an honor to be a part of the Arts Commission.

Director Remington also shared that the application window for the Community Investments Program Officer role closed. He added that applications are still being accepted for the Commission Secretary and Senior Monuments and Memorials Program Manager roles

President Collins welcomed Deputy Director of Finance & Administration Hollenbeck and Deputy Director of Programs Leifheit.

There was no public comment.

5. Commissioner Rules and Responsibilities Overview (25:35)

Deputy City Attorney Lauren Curry provided a high-level overview of Arts Commissioner rules and responsibilities. She briefly provided background information of the Arts Commission structure, it's powers and duties, general powers and duties of city commissions, the rule of Arts Commission and the rule of Department Head, annual filing obligations and the general ethics matters including conflict of interest, political activity by city officers and employees and the statement of incompatible activity. She thanked the commissioners for their service.

She reminded commissioners to reach out to her directly for any specific questions.

Commissioner Hakimi asked clarification regarding political activity restrictions.

There was no public comment.



6. SFAC Galleries Fall 2023 Exhibitions (41:27)

Director of Galleries and Public Programs Carolina Aranibar-Fernandez provided an overview of the SFAC Galleries Fall 2023 exhibitions. She reported that the City Hall exhibition is currently being installed. She said this exhibition is a collaboration with the Mission Cultural Center for Latino Arts focusing on the history of community political activism and cultural events through the posters produced by Mission Gráfica and La Raza Graphics from 1971-1995.

She explained that the next exhibition in the main gallery, *Transcending Physicality: The Essence of Place*, will feature a group exhibition curated by Minoosh Zomorodinia with fourteen diverse artists focusing on the concept of space and the interplay of human activities, relationships and interaction that shape and define the essence of place.

Commissioner Hakimi asked for the details for the opening receptions. Director Aranibar-Fernandez said that the City Hall opening reception is scheduled on September 20 and the Main Gallery opening reception is scheduled on October 13.

There was no public comment.

7. Committee Reports and Committee Matters (49:00)

1. Civic Design Review Committee (49:10)

Commissioner Stryker shared that the Committee reviewed the following projects at the August meeting: Ocean Beach Climate Change Adaptation Project, Sunol Valley Water Treatment Plant Ozonation Project (Phase 3), Treasure Island Water Resource Recovery Facility: Phase 2 (Phase 2), Southeast Plant: Operations,



Engineering, Maintenance Buildings (conceptual) and the Dolphin Club Renovation (Small Project Review).

Commissioner Stryker shared details about the Ocean Beach Climate Change Adaptation Project which was approved with accolades. She said in addition to promoting ecological resilience to climate change, the project also offered new amenities and was a multiple agency project. She said the project built walls to stabilize slopes and minimize sand movement, created open space for pedestrians, bike riders and surfers, added a restroom and an opportunity for art on the plaza. She also commented on the extensive palette of native plants used.

There was no public comment

- 2. Community Investments Committee (53:35)
 - 1. Community Investments Committee Report (53:50)

Vice President Shiota shared several items from the August Committee meeting. She explained that the committee recommended the approval of two San Francisco Artist Grants for \$20,000 each totaling \$40,000. She said these two additional grants are being made due to a couple of applicants' inability to register with the City's payment system and receive funds. She also announced that Director of Community Investments Denise Pate provided an update on the new Community Services Allocation Plan (CSAP) and shared that AMS planning and research was selected as the consultant. She reported that Program Officers Jonell Molina and Jennifer Chu presented an update on the Cultural Ambassador Program. She said committee members commended the work of staff and suggested a possible payment increase for the work, to ensure equity in the Arts Commission's support of artists and individuals working in arts and culture. She also provided details regarding the FY24 grants season which will



include launching eight distinct grant programs for San Francisco based artists and arts organizations and a series of grantseeker webinars and technical assistance to assist applicants. She added that applications for grant panelists is open and application details can be found on the SFAC website.

There was no public comment.

2. Cultural Center Allocations (58:20)

Vice President Shiota presented the two cultural center allocation motions. She said explained that the motions were necessary because there was a change for the virtual center, the American Indian Cultural Center, to become the subgrantee of SOMArts.

Commissioner Beltran asked if there would be a physical space for the American Indian Cultural Center. Senior Program Officer Anne Trickey confirmed that the American Indian Cultural Center would remain virtual.

Commissioner Beltran, seconded by Commissioner Styrker moved to approve the Cultural Center fiscal year 2023-2024 grant amount not to exceed \$864,822 to SOMArts; and to subgrantee Asian Pacific Islander Cultural Center for a grant amount not to exceed \$149,880; and to sub-grantee Queer Cultural Center for a grant amount not to exceed \$149,880; and to sub-grantee American Indian Cultural Center for a grant amount of \$449,880; which includes \$300,000 in general operating support (authorized by resolution 1107-22-196) for a 2023-2024 total of \$1,614,462 and to authorize the Director of Cultural Affairs to enter into a total grant agreement not to exceed \$4,350,870 for fiscal years 2024-2026.



There was no public comment.

The motion was unanimously approved.



3. Executive Committee (1:07:25)

President Collins explained that the Arts Commission issued a RFP for the planning and development of an agencywide strategic and business plan to help SFAC build a system of accountability, provide tools to measure the agency's success and growth, and provide long-term assistance with agency goal setting. He said that AECOM Technical Services, LLC was chosen as the consultant and a motion is necessary to authorize the Director of Cultural Affairs to enter into an agreement since the contract amount is over \$100,000.

Commissioner Beltran, seconded by Commissioner Shiota moved to authorize the Director of Cultural Affairs to enter into an agreement with AECOM Technical Services, LLC to procure an agencywide strategic and business plan for an amount not to exceed \$374,000.

Commissioner Stryker asked about the duration of the plan and when the process would begin. Director of Cultural Affairs Ralph Remington confirmed the planning process would be two years including a strategic plan and business plan component. He added the process should begin at the end of the month.

There was no public comment.

RESOLUTION NO. 0911-23-147: Motion to authorize the Director of Cultural Affairs to enter into an agreement with AECOM Technical Services, LLC to procure an agencywide strategic and business plan for an amount not to exceed \$374,000.

The motion was unanimously approved.

4. Visual Arts Committee (1:11:45)

Commissioner Ferras provided an overview of several agenda items



from the August committee meeting including the completed artwork by Walter Kitundu and purchased artwork by Adrian Arias for the Alameda Creek Watershed Center. She provided images and a brief description of Kitundu and Arias' work. She also explained that 5 of 11 final total designs for the 49 South Van Ness Video Wall were presented by Program Associate Craig Corpora. She provided a reminder that the RFQ for Gene Friend Recreation Center is open until Monday, September 18th.

Commissioner Beltran added that the video installations are beautiful at night and that it's exciting to commission this time of work for the first time. Commissioenr Stryker added that so many employees are proud to go to work and that the art elevates the experience.

There was no public comment.

President Collins congratulated A.C.T. for their show, *Soul Train*. He encouraged all to support this important investment in a difficult part of the City. He said this is a significant cultural moment to be chosen to curate this work and bring it to life. He congratulated A.C.T. for the impressive production, courage, and vision of their new artistic director Randall Kline. Commissioner Shelby added his excitement for the production.

Director of Cultural Affairs Remington added his excitement for Terrance Blanchard as the new Executive Artistic Director of SFJAZZ.

Commissioner Beltran added to go to *Soul Train* before it heads to Broadway.

Commissioner Ferras thanked commissioners and Supervision Mandelman for joining the Castro ArtWalk. She added that the next ArtWalk will be in Glen Park on October 7 followed by a night market on Clement Street on November 16.

There was no public comment.



10. Adjournment *(1:29:55)*

President Collins again welcomed Deputy Directors Sarah Hollenback and Lex Leifheit to the Arts Commission.
