The San Francisco Department of Public Health, Environmental Health Branch, Solid Waste Program, acting as the Local Enforcement Agency (LEA), is certified by the Department of Resources Recycling and Recovery (CalRecycle) to enforce state laws and regulations at solid waste sites within its jurisdiction. San Francisco Solid Waste Transfer and Recycling Center (SFSWTRC) operates under a Solid Waste Permit No. 38-AA-0001

issued by LEA. On September 25, 2023, LEA received an application for RFI amendment to the Solid Waste Facility Permit (SWFP). The RFI, a document that describes the design and operation of a solid waste facility, is a required component of an application for a SWFP.

As required by Title 27, California Code of Regulations (27 CCR), § 21660.1, LEA is distributing this notice for the purpose of noticing its acceptance of the amendment to the RFI for SFSWTRC.

Project Description

The RFI amendment proposes to amend the Transfer Processing Report (TPR) to amend existing TPR to update languages for the following State Minimum Standards including but is not limited to:

- 1. Inclusion of language in the TPR reflecting the addition of a trommel screen in the Organics Transfer Operation (OTO)
- 2. Update of list of equipment to include a trommel screen
- 3. Inclusion of language for compliance with Senate Bill 1383, 14 CCR § 17409.5.5, for the new piece of equipment.
- 4. Update Operations Manager of Transportation emergency contact information
- 5. Update to Appendix B, Facility Design Schematics of the OTO, and addition of Appendix D, SFDBI Electrical Permit

The RFI amendment does not propose any changes to the permitted operations, tonnage, traffic volume, hours of operation, and facility area boundaries.

LEA's Determination

LEA found that the proposed changes are: (1) consistent with all applicable certified and/or adopted CEQA documents, (2) consistent with State Minimum Standards, and (3) do not conflict with the terms and conditions in the current SWFP. Pursuant to 27 CCR § 21666, LEA determined that the application met the requirements of 27 CCR § 21665(c) and accepted the application for filing on October 13, 2023.
