Seconded by Commissioner Murawski, three staff. The BHC would like to know what the protocol is for developing a complaint process from the public. It was considered to address this at the general meeting. The committee wanted to discuss amending the motion to protocols and needs for the Behavioral Health Services to have a portal on their website managed by at least three of their staff. What is the complaint process like for the BHS.

Public Comment: The San Francisco Health Plan should be reviewed by the BHC. It is a performance review and the BHC does not have the power to order the BHS. We have a quorum of the implementation and the site visit committee and not noticed which is a violation of the Sunshine Ordinance. 54954.1 Notice was not sent out in a timely order which makes everything at this meeting willful misconduct. A suggestion to come up with facts that show a reason to have a web portal on the Behavioral Health Commission to address concerns of the public.
