Chief Scott reported on crime trends YTD: Violent Crime up 3 percent; homicide N/C; rape down 15 percent; robbery up 16 percent; assault down 8 percent; human trafficking down 7 percent. Property Crimes down 5 percent; burglary down 6 percent; motor vehicle theft up 10 percent; arson down 9 percent; larceny theft down 8 percent. Gun violence is down 2 percent compared to 2022; Two shooting incidents this week; total 137 incidents resulting in 160 victims YTD. No homicides for the week; there are a total of 40 homicides YTD with 27 resulting from a firearm; 75% overall clearance.

Assault on a sworn Office, suspect in a suspected stolen vehicle, 9/27/23 01:38, Tenderloin, Golden Gate and Hyde, Officers and CHP located a reported stolen vehicle, while attempting to detain suspect in a marked a vehicle, suspect rammed CHP vehicle and then attempted to ram SFPD vehicle, pursuit initiated as vehicle fled and terminated at dead end of Van Ness and McDowell, suspect was arrested. Shaw's Candy, 9/27/23 13:42, West Portal Ave, suspect assaulted an elderly worker at shop, when Officers arrived, bystanders had detained suspect, Taraval responded to 100 block of West Portal regarding assault in progress, male suspect had assaulted a victim without provocation and caused her to fall to sidewalk, coworker ran to the aid of victim and was also assaulted by suspect, coworker pushed into establishment, while inside store suspect assaulted another elderly victim which caused her to fall to the ground, during assault a worker form a nearby business witnessed the attacks and ran to their aid, witness held suspect but was also assaulted by suspect, suspect fled from store but was followed by witnesses and bystanders and detained by them, Officers arrested suspect and booked, victims treated and release, one transported, Chief Scott thanked the public that intervened, advised public

to use caution and do so safely. Assault and attempted murder 9/28/23 600 Block of Powell 15:48, Officers responded to a burglary call, upgraded to a verbal dispute between victim and neighbor, neighbor broke into apartment and trashed it, suspect confronted victim inside victim's apartment and attacked victim with a hammer, suspect also swung knife towards victim, did not make contact with knife, victim treated at scene, Officers arrived and arrested suspect.

Executive Director Henderson reported the following: In the year 2023: 601 cases opened; 552 closed; 304 pending; 42 cases sustained; 22 cases past 270-day; 31 cases mediated. SFPD Cases received in the past week: 35- Central-5-The complainant alleges that officers failed to properly investigate. Officers pulled guns, detained, and handcuffed the complainant without cause. Southern-2- An officer failed to properly investigate and failed to make a required contact to the owner of a recovered car. The officer used profanity and made a homophobic comment. Bayview-1-The complainant alleges that the officers arrested them without cause and lied in their report. Mission-2-The complainant stated that the officer did not do anything to help when he reported that he was followed by a man. Officers delayed a response to a 911 call. When the officer did arrive, they failed to write a report. Northern-3-Officers failed to properly investigate a sexual assault, to preserve evidence, to activate their body-worn cameras, and to make an arrest. Officers responded to a call for service and instead of asking the complainant to leave they arrested him and placed him in tight handcuffs which caused bruising. Richmond-2-The officers failed to file a police report regarding a stolen animal. The officers failed to investigate the burglary of a vehicle as presented by the complainant. Ingleside-1-Officers were dismissive and unprofessional when the complainant called the station to ask a question. Taraval-2-Unhoused complainant was relieved of their personal property despite protest and threatened by officers if he did not get out of the way. Tenderloin-9-The officer failed to enforce a court restraining order and made inappropriate comments during a phone call. The complainant was followed and tased by a private security guard

while leaving a retail store. The officers failed to properly investigate, arrested the complainant without cause, and used unnecessary and excessive force. Not Applicable-6-Referral. Out of Town-1-Referral. Pending-1-The officer failed to comply with the SFPD policy on Stop Data Collection and falsified information.

Shooting, Mission and Cesar Chavez, 10/8/23 20:00, victim was walking when heard gunshot and felt pain, self-transported to hospital out of the city, injuries believed to be no life threatening. 10/7/23 during fleet week, rooftop party, a lady fell from roof, succumbed to her injuries. Officer involved shooting at Chinese Consulate on Geary Street, will be having a town hall meeting.

Significant arrest: Aggravated assault on elderly victim, 10/5/23 07:50, Bay and Lyon, Northern District, victim was walking dog when unknown subject approached him and hit him in the head with an unknown object, victim fell and hit his head on sidewalk, transported, surveillance footage located, identify of suspect developed, suspect located that day by Northern Officers and taken into custody. Armed robbery series, 9/26-10/4/23, three armed commercial robberies occurred, in and around the Mission District, between midnight and early morning hours, robberies involved taking over businesses, forcing victims to floor or backrooms at gunpoint, some victims pistol whipped, loss of currency and merchandise, atm machines, during course of investigation- determined robberies committed by same suspects, identified two suspects, on 10/4 several units participated to take suspects in to custody, both suspects taken in to custody, search warrant served, evidence recovered, both suspects booked, one of the robberies, at 2200 Bryant a market, two victims inside market, same two suspects with firearms entered and physically assaulted victims, suspect robbed one victim and left with market safe.

Strategies: Retail theft operation, part of series of retail blitz operations, occurred in San Francisco Center, with assistance of CHP, uniformed and plain clothes Officers conducted operations, observed 9 individuals stealing from various stores, individuals arrested and property recovered. Department obtained funding, through organized retail crime grant, of \$15.3 Million. Ongoing drug market breakdowns, 44 arrests, seized 2100 grams of illegal narcotics.

Chief Scott reported on crime trends YTD: Violent Crime up 3 percent; homicide up 2 percent; rape down 14 percent; robbery up 16 percent; assault down 6 percent; human trafficking down 13 percent. Property Crimes down 7 percent; burglary down 6 percent; motor vehicle theft up 9 percent; arson down 10 percent; larceny theft down 9 percent. Gun violence is down 3 percent compared to 2022; Three shooting incidents this week; total 142 incidents resulting in 167 victims YTD. No homicides for the week; there are a total of 43 homicides YTD with 28 resulting from a firearm; 72% overall clearance.

Significant Incident: Three non-fatal shooting incidents, resulting in five victims. 1st at Polk and Sutter, Northern District, 10/12/23 03:30, victim on sidewalk approached by two suspects, demanded victims belongings, after suspects fled with victims belongings the victim realized they had been shot, victim transported with non-life threatening injuries, investigation on going, no arrests. 2nd at Leavenworth and Golden Gate, three victims, 10/12/23 12:43, three victims were in and/or near a vehicle when suspect pulled up and fired several shots then fled, two victims transported, third victim self-transported, all in stable condition, non-life threatening injuries, investigation ongoing, no arrests. 3rd incident, self-inflicted wound, not believed to be a criminal matter.

Significant arrest: Organized retail theft blitz, Ingleside Officers conducted a surveillance operation at Walgreens, Mission and Geneva, multiple subjects entered the store, dressed in masks and dark clothing. The subjects quickly grabbed and concealed store merchandise, Officers were able to arrest six of the eight individuals, including one juvenile, also a baby with this group of suspects, other subjects were able to exit the store before officers could detain them, that investigation is ongoing, merchandise that they were attempting to steal was recovered and six out of the eight individuals were arrested. Auto burglary, turned into an assault on an Officer and a vehicle pursuit, Officers responded to a vehicle break in at Irving Street and 43rd Ave, 10/12/23 02:12, suspects fled on foot and jumped into a waiting vehicle at a high rate of speed, Officers attempted to stop the suspect during the foot pursuit and was dragged by the suspect's vehicle for approximately three feet, sustaining minor injuries, a pursuit was initiated and as the vehicle entered the freeway, CHP assisted and the vehicle eventually stopped and a single occupant fled, eluding capture, investigation ongoing. Armed Robbery at Smart and Final, 10/12/23 10:53, two suspects walked to the cash register to make a purchase, when the clerk opened the register, a note was passed to the clerk indicating that the person had a gun and the store was being robbed, the suspect was able to escape with cash, no arrest has been made, investigation ongoing, evidence is being examined.

Strategies: Joint news conference today regarding the APEC, the Asian Pacific Economic Cooperation Conference that will be happening next month, led by the U.S. Secret Service, who is the lead law enforcement agency on this, national special security event which is equivalent of a presidential inauguration in terms of the security needs, twenty one 21 heads of state, including our head of state

and Vice President, expected to have about 20,000 visitors to attend this conference in one way or another, about a thousand media outlets will be here, Officers will be fully deployed, mobilized, some disruption with public transportation, that information can be found on the SFMTA website, there's a link APEC and it has a map with all the closures, keep the public informed, including the maps that were made public with the street closures.

The complainant stated that an officer behaved inappropriately and a commanding officer failed to intervene. Ingleside-2-The complainant stated that officers failed to promptly respond to a call for service, failed to make a custodial arrest, behaved improperly and an officer did not provide his name when requested. Taraval-1-Officers failed to investigates and write a police report, and failed to arrest the complainant's neighbor who poured gasoline around the complainant's property as a form of intimidation. Tenderloin-3-The officer lied about witnessing a domestic violence incident and subsequently arrested the complainant without cause.
