NOTICE TO REGISTRANT

PURSUANT TO CA BUSINESS & PROFESSIONS CODE 17900 et seq. & SF BUS. & TAX REG. Article 12

Any person who is a general partner in a partnership that is or has been regularly transacting business under a fictitious business name may, upon withdrawing as a general partner, file a statement of withdrawal from the partnership operating under a fictitious business name. The statement shall be executed by the person filing the statement in the same manner as a fictitious business name statement and shall be filed with the county clerk of the county where the partnership filed its fictitious business name statement. (B&P Code Sec. 17923)

- Make the necessary changes regarding your DBA and pay any delinquent taxes on your business tax registration account with the S.F. Tax Collector's Office at City Hall, Room 140. Phone: (415) 554-4400.
- Complete the Statement of Withdrawal from the Partnership Operating Under a Fictitious Business Name form with the same information as stated on the original statement from which you are withdrawing.
