Chair Schnair called the meeting to order at 1:00 p.m.

They noted a unanimous call for Commissioner Collins to continue to serve in the President role and for Commissioner Shiota to continue to serve as Vice President.

Commissioner Brenzel, seconded by Commissioner Shelby moved to approve the following motion: Motion to nominate and elect officers of the Arts Commission (President and Vice President) for a term beginning on January 1, 2024. The Nominating Committee approved the slate of Charles Collins as President and Janine Shiota as Vice President.

There was no public comment.

The motion unanimously carried by the following vote: Ayes: Schnair, Brenzel, Shelby.

Commissioner Shelby shared his agreement and comments from other commissioners.

Commissioner Schnair discussed how commissioner comments will be shared in the future and noted that they are important as the agency begins the strategic planning process.



Commissioner Brenzel said he is grateful that President Collins and Vice President Shiota are willing to serve another term.

Commissioner Shelby thanked Chair Schnair for leading the committee.
