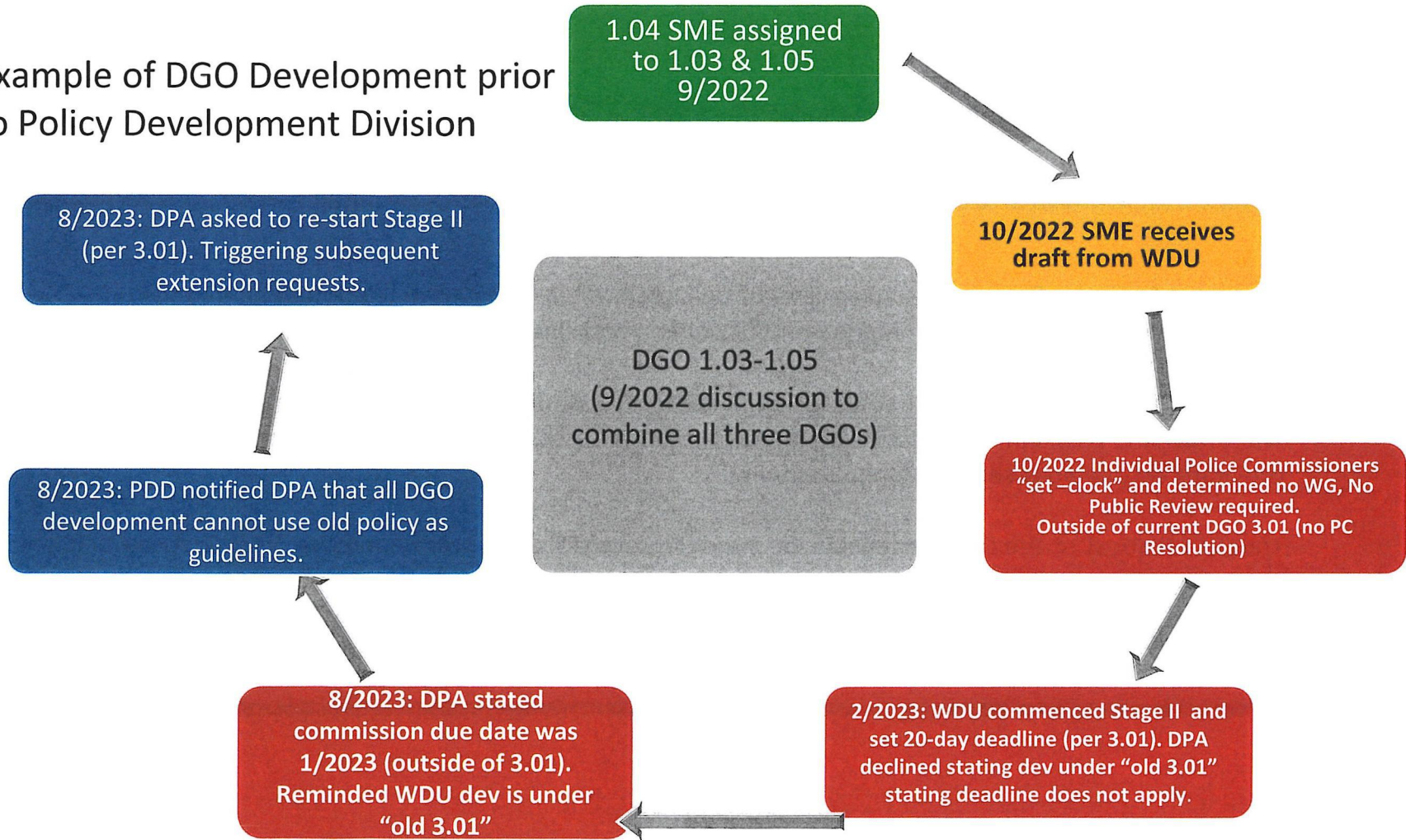

Updates since 2/9/2024 submission

| DGO 1.06 | WDU received final edits and are routing DGO (blue folder) for final signatures. Within 5 business days of receipt from Chief's Office, WDU shall submit to the Police Commission Office. The Department will seek DGO 1.07 rescinding order from Police Commission as well. |
| DGO 2.07 | PDU received DPA comments on draft Public Review responses. This is ready to be scheduled for Simultaneous Concurrence. Holding 4/19/24. |
| DGO 6.14 | City Attorney has responded with initial guidance regarding definition for "gravely disabled", however, further clarification is needed. Dept. will continue to work closely with DPA & City Attorney on definition criteria. As the current development stage is post concurrence edits prior to Police Commission submission, there is no DGO 3.01 determined timeline. Once SME and DPA confer on edits, the draft DGO will be routed (blue folder) for final signatures. |
| DGO 9.06 | WDU has updated the DPA Stage II RG deadline on internal tracking documents. |

2022 DGO Development Challenges

Transition from the former version to current version of DGO 3.01 where DGOs had been under development for years (former version of 3.01 had no timelines) and changed hands several times.

6/15/22: The Department reached an agreement with all labor unions on the requirements of DGO 3.01. Therefore, the Department cannot amend the language, or the processes detailed in the DGO without providing formal notifications to all Labor Unions.

The DPA request of the Department to add timelines or extensions to the process detailed in DGO 3.01 can not be implemented without amending the DGO (DGO 1.03, 1.06, 2.07, 6.14)

Overall Status of 14 DGOs

Two (2) DGOs is between Stage II and Public Review Process

One (1) DGO in “blue folder” routing during the “Submission of Final Draft to the Police Commission” process (3.01.04(F))

Two (2) DGOs have been approved by the Police Commission

Three (3) DGOs are between Public Review Process and Simultaneous Concurrence

One (1) potential extension request for Stage I (to be determined by leadership)

One (1) moved to the approved 2024 General Order Review List

Two (2) DGOs between post-concurrence and submission to Police Commission office

One (1) DGO moved to proposed 2023 carry forward list

One (1) DPA proposal from 2021. Unable to locate record of Police Commission initiation per 2019 DGO 3.01.

No current policy guideline for managing timelines related to DPA submissions to the Chief of Police that are outside of current DGO 3.01.04(A). Draft is being considered as a resource during DGO 6.12 update.
