- JUSTIS API (Read Capabilities)
 - Soft launch of the JUSTIS API, and started working with DA's Office for building of the eProsecutor interface
- Released New Connections and Functions
 - Criminal History Data Feed from JUSTIS to SFPD
 - Query Open Charges for DA
 - Query Filed Cases for the Courts
 - Attorney Assignment for DA and Public Defender
- ServiceNow Workflow for JUSTIS Portal Access Request
 - Streamline the Access Request, cut down number of human steps
 - Total of 682 Users Now
- Operations Work Group Weekly Meetings
 - Actively working with department operation team to improve process flow, data quality in CCSF


