#### **Minutes**

## 3. Consent Calendar *(0:06:42)*

### 5. SFAC Galleries Mentorship & Exhibition Fellowship (0:11:22)

Director of Galleries and Public Programs Carolina Aranibar-Fernandez presented a new National Endowment of the Arts grant funded mentorship and exhibition fellowship. The new program is designed to support emerging artists in the Bay Area by providing resources and space for meaningful professional development, culminating in an exhibition at the SFAC Main Gallery in September 2024. A panel has selected Shirin Makaremi to be the mentor to selected artists Shirin Khalatbari and Sun Park and to curate the resulting exhibition.

The commissioners were excited by this new program and inquired if, as part of this program, the artists would be introduced to the Public Art team to learn about the Public Art process. Ms. Aranibar-Fernandez explained they would learn about all aspects of the agency's work.

## 6. GROW - Goldman Environmental Prize Temporary Installation (0:19:15)

Project Manager of Temporary Art and Activation, Rebeka Rodriguez Mondragón introduced Julia Neff from Demonstrate (a marketing and creative agency in San Francisco) and artist Laura Hapka to discuss their temporary installation at Proxy. As part of the 35<sup>th</sup> anniversary of the Goldman Environmental Prize, this temporary installation of a grid of eight living trees was conceived as a way to extend the prize ceremony into the City. The species of trees will be chosen in conversation with the non-profit, Friends of the Urban Forest, who will also plant the trees throughout the City after the exhibit. The trees will be weighed down and the surrounding scaffolding inspected. This is their first temporary exhibit and they hope to expand the installation to an annual exhibition if successful.



Commissioner Collins expressed how important the Goldman Environmental Prize is locally and globally and that it was an honor to have the artwork brought to the City.

There was no public comment.

**Motion:** to approve *GROW*, a temporary installation by artists Laura Hapka and Brian Singer consisting of a grid of 8 trees, with each tree surrounded by scaffolding holding up letters: 'G', 'R', 'O', and 'W' constructed out of living moss, to be located at Proxy located near the intersection of Octavia Blvd & Hayes Street in Hayes Valley. Pending final approval from the Department of Real Estate. The installation measures H60 in. x W60 in. x D60 in. will be on display from April 19 – May 8, 2024, with all funding from the Goldman Environmental Foundation. The work will not become part of the Civic Art Collection.

#### 8. 11th and Natoma Park Project



(0:27:22)

Project Manager Arianne D. Gelardin presented the public art project plan for the new half-acre 11<sup>th</sup> and Natoma Park in the South of Market neighborhood. The project site is in the southwest corner of SOMA's Filipino Cultural Heritage District and one block from the Leather and LGBTQ Cultural District.

The artwork opportunity is for the integration of artist-designed fence panels on the 11 ft. high, powder-coated aluminum perimeter fence and entry gate along the 11<sup>th</sup> Street frontage of the park. The artist will be responsible for the design of up to 1300 square feet of fence, which will be fabricated and installed by a separate contractor paid for and managed by the Recreation and Park Department (RPD) park project. The total Art Enrichment budget is \$110,000 and the design only artist contract budget is \$25,000. The Request for Qualifications (RFQ) will be posted March 26, if approved today, and is open to all artists or artists teams who reside in the United States and recruitment will focus on artists with a meaningful connection to SOMA.

Commissioner Schnair asked about the construction timeline and the integration of the art and construction schedules for this project.

Alex Schuknecht, of partner agency RPD, confirmed the integration of the art and construction schedules and RPD's approval of this project plan.

There was no public comment.

9. 2024 Art on Market Street Poster Series (0:48:23)



Program Associate Craig Corpora presented the conceptual proposal by Kirti Bassendine for the second series in the 2024 Art on Market Street Poster Series. This poster series will illuminate compelling historic narratives, showcasing the invaluable contributions of Native communities to the cultural landscape of the San Francisco Bay Area, and envisioning a future where Bay Area Native people thrive while honoring their rich heritage.

Each poster will weave together portraits that are accompanied by personal statements from native Ohlone community members calling attention to cultural connections to the land and climate change, highlighting their message "We Are Here." Each poster will include the name of the individual featured, tribal group name, tribal website, and statement.

This initiative aims to highlight and raise awareness about the Ohlone tribal groups, who have been an integral part of California for thousands of years as the region's original inhabitants. It will significantly contribute to education and unite not only the participating indigenous tribal groups but also other indigenous communities in San Francisco, providing them with a collective voice.

This poster series will represent some of the leading members from some of these tribal groups. Association of Ramaytush Ohlone, The Confederated Villages of Lisjan- Corrina Gould, Muwekma Ohlone Tribe of the San Francisco Bay Area, Tamien Nation, Indian Canyon Nation-Kanyon Sayers -Roods, Amah Mutsun Tribal Band, the Rumsen Ohlone Tribal Community, Esselen Tribe of Monterey County, the Salinan Tribe of San Luis Obispo and Monterey Counties and the Salinan Trowt'raahl tribal community.

The commissioners were very appreciative of how this project can be a representation of the pledge in our land acknowledgement and that it comes from within the community.

## 10. Southeast Treatment Plant – New Headworks Facility (0:53:59)

Civic Art Collection & Public Art Program Director Mary Chou presented the completed artwork *Whorl Whirl: Our Circular Nature* by artist Norie Sato. The artist was selected in 2016 and the design was approved in 2019. The newly installed artwork is 335 ft. long and up to 30 ft. tall. The artwork uses a circular vortex motif to reference the complex and regenerative process that occurs at the Headworks Facility at the Southeast Treatment Center which processes 80% of the city's wastewater. Sato highlights the cyclical movement of water from dirty to clean in the brightly colored aluminum fins that transition from dark to light to dark again, this movement is also represented in the perforated steel panels behind the fins. The artwork makes the invisible power and water structure of the city visible. The dynamic artwork imagery changes as one walks the length of the artwork and as the light of day changes.

Blair Randall, Arts and Education Program Manager from the San Francisco Public Utilities Commission (SFPUC), thanked the Arts Commission and the artist Norie Sato for this artwork and the process. This artwork is evocative of making the invisible infrastructure of SFPUC visible.

The commissioners appreciated the artwork and the partnership with SFPUC, particularly with the community and artwork in this part of the city.

**Motion:** to approve as installed *Whorl Whirl: Our Circular Nature* (2024) a painted aluminum and stainless-steel sculpture by Norie Sato on the façade of the new Headworks Facility of the Southeast Treatment Center. The artwork ranges in height from 27 ft. 6 in. to 30 ft. 6 in. tall, is up to 2 ft.



deep, and approximately 335 feet wide.

#### 11. Staff Report

(1:04:16)

Director of the Public Art Program and Civic Art Collection Mary Chou presented an update on the Monuments & Memorials project funded by the Mellon Grant.

SFAC had a positive response rate to the equity audit consultant request for proposals (RFP) and are in the final phase of the interview process. The selected consultant team will begin in April, following a timeline to produce the equity audit report and findings by the end of this calendar year.

In tandem with the onboarding of the consultant, SFAC will be releasing an RFP for community engagement consultants and assembling the artists and cultural leaders who are integral to the sustained engagement and stewardship of this work.

Per our learnings from the Monuments and Memorials Advisory Committee (MMAC) process and recommendations, SFAC will engage a trauma informed systems consultant to provide trainings and workshops for the *Shaping Legacy* team and interested individuals from the broader SFAC staff team. The initial trainings will begin before the end of this fiscal year, with ongoing reflection workshop moments throughout the span of the project.

In late January, SFAC gathered a small working group of key staff to consider a new name for the project and aligned on: *Shaping Legacy: San Francisco Monuments & Memorials*. Staff look forward to presenting the *Shaping Legacy* visual identity and unique logo to the Committee later this Spring. Ms. Chou thanked Angela Carrier for moving this work forward and being a champion for this program.



Following the approval of the 11<sup>th</sup> and Natoma Park Public Art Project Plan, the RFQ will launch Tuesday, March 26 and will run through May 1, 2024. The opportunity is open to professional practicing artists and artist-teams who reside in the United States, and recruitment will focus on artists with a meaningful connection to SOMA. Ms. Chou asked Commissioners to share the RFQ with anyone who they think might be interested in applying.

The Treasure Island Water Resource Recovery Facility RFQ application deadline is March 26, 2024.

There will be a reading of the 2023 Art on Market Street Poster Series, Comics 2.0 at CCA on Saturday April 6 from 4-6pm where artists will be reading from their work.

There was no public comment.

## 9. New Business and Announcements (1:07:58)

Commissioner Collins said that the Hiroshi Sugimoto artwork on Treasure Island had a soft opening on the Spring Solstice and thanked the staff for this beautiful artwork with a monumental impact. Ms. Chou said the public park opening will be summer 2024.
