3. BOS File No. 240126 – Extending Waiver of Permit, License, and Business Registration Fees for Certain Small Businesses (Discussion and Action Item)

The Commission discussed an ordinance Extending Waiver of Permit, License, and Business Registration Fees for Certain Small Businesses.

Commissioner comments:

Ortiz-Cartagena: the money saved makes a huge difference for a small business who can save it for another month of rent, etc. Love this program. It gives businesses a sense that SF is open and supportive. Herbert: Does this count for expanding businesses too? Yes

Huie: I'm a FYF beneficiary. Sometimes it's tricky because contractors pull permits on behalf of small businesses but they don't get the fees waived. But you can get refunded. Where is this in the legislative process? Going to the Board of Supervisors tomorrow.

4. Discussion of Strategic Goals (Discussion Item)

Director Tang presented the Commission FY23-24 strategic goals and discussed potential updates.



Commissioner comments:

Huie: My goals are to grow and strengthen merchant groups. Help them be vocal. I also want to support new leadership within the small business commission.

Ortiz-Cartagena: We should focus on intradepartmental coordination. We need to hold CBOs accountable. Benitez: Merchant groups vary in terms of how organized they are, what their capacity is, etc.

Herbert: What's our plan for downtown? What about engaging merchant groups - we could have merchant groups come and present to us about what they are experiencing, seeing, etc.

Cornet: We should be using social media to look at corridors and get them activated.

Dickerson: Third Street has Earl Shaddix, who advocates on behalf of the merchants. It's important not to put more burdens on small business owners themselves – we need to get advocates in place to support them. Zouzounis: OSB has good customer service but we need to expand that to other departments. It might be helpful to review how an idea gets shaped into policy.
