3.1 Conard House site visit on October 19, 2022 (BHC Minutes, 10/19/2022). Several concerns about the program at Conard House were identified. The site visit team suggested having the Conard staff make a follow-up presentation to the Behavioral Health Commission to address some of the questions that came up during the visit.

3.2 Eldorado Hotel (9th Street) --Conard--SRO Supportive Housing, February 26, 2024. Referral process is used to make referrals for supportive housing. On the day of the site visit, the reviewers noted that only 37 out of the 57 beds were occupied on the day of the site visit. They were informed that referrals had to go through coordinated entry. The commissioners are requesting that Eldorado staff make a follow up presentation to the BHC to provide more information about why the beds are not filled and what additional support is needed to assure San Francisco residents are getting the services they require.

DISABILITY ACCESS

The ADA is a civil rights law that protects people with different types of disabilities from discrimination in all aspects of social life. More specifically, Title II of the ADA requires that all programs offered through the state

and local government such as the City and County of San Francisco must be accessible and usable to people with disabilities. The ADA and City policy require that people with disabilities have equal access to all City services, activities, and benefits. People with disabilities must have an equal opportunity to participate in the programs and services offered through the City and County of San Francisco. If you believe your rights under the ADA are violated, contact the ADA Coordinator. Ordinance 90-10 added Section 2A.22.3 to the Administrative Code, which adopted a Citywide Americans with Disabilities Act Reasonable Modification Policy that requires City departments to: (1) provide notice to the public of the right to request reasonable modification; (2) respond promptly to such requests; (3) provide appropriate auxiliary aids and services to people with disabilities to ensure effective communication; and (4) train staff to respond to requests from the public for reasonable modification, and that requires the Mayor's Office on Disability to provide technical assistance to City department responding to requests from the public for reasonable modifications.
