Commissioner Beltran called the meeting to order at 2:08pm.

1. Call to Order, Roll Call, Agenda Changes, Land Acknowledgment

Commissioner Beltran announced she was facilitating the meeting today as Chair Ferras was under the weather. Commissioner Beltran stated that item 10 Portsmouth Square would be taken out of order. Item 10 would be called after item 8, San Francisco International Airport Terminal 3 Connector Two-Dimensional Artwork Program and before item 9, Patricia's Green Temporary Art Project. Commissioner Beltran also stated that Public



Comment would be limited to 2 minutes due to the length of the agenda and the time constraints of room availability.

3. Consent Calendar *(0:07:53)*

- 1. Motion to approve the final design of *Listening Stones*, a series of 11 granite boulders, by Mark Baugh-Sasaki for the Ocean Beach Climate Change Adaptation Project, located at Great Highway and Sloat Blvd. The 11 boulders will range in size from H7 ft. to H9 ft. (large), H5 ft. to H6 ft. (medium), to H18 in. (small). The large- and medium-size boulders will have 20-degree "cone cuts" at H43 in. to H56 in., full cane clearance at the base, and a minimum of 4 ft. to 5 ft. clearance from surrounding built elements to provide broad accessibility. The placement of the 11 boulders along the Plaza maintains clearance from underground infrastructural elements, as well as emergency and maintenance vehicle routes.
- 2. Motion to rescind RESOLUTION NO. 0204-19-036: Motion to approve the Alex Nieto Memorial Monument, a design by Josué Rojas and Armando Vasquez. The memorial will be installed at Bernal Hill, located at Bernal Heights Park. The monument will be constructed of concrete with painted imagery and measure approximately 4 ft. high by 2 ft. wide by 4 ft. deep on a 12 ft. circular concrete base. The project is sponsored by the Alex Nieto Memorial Committee and Acción Latina; the memorial will not become part of the Civic Art Collection.
- 3. Motion to approve the design of the *Alex Nieto Memorial* by Lucia Gonzalez Ippolito and Mehmet Alademir. The memorial



will be installed at Bernal Heights Park. It will be constructed of stone, tile and concrete, and measure approximately 4 ft. 6 in. high by 5 ft. wide by 5 ft. deep with a 12 ft. diameter circular stone base. The project is sponsored by the Alex Nieto Memorial Committee; the memorial will not become part of the Civic Art Collection.

- 4. Motion to approve San Francisco, a mural design by Casey Gray. The mural will be installed at 72 Ellis St. in District 3. The mural measures approximately 42 ft. tall by 55 ft. wide. The artwork is funded by citizenM and will not become part of the Civic Art Collection.

4. Sunnydale Hope SF – California Bear over Head of Peace sculpture relocation (0:09:57)

Senior Registrar Allison Cummings introduced the item and Mercy Housing Project Manager Leigh Ann Llarena. Ms. Cummings stated that the sculpture has been located at this site since 1945 and the artwork was



created in 1935. The sculpture is not currently part of the Civic Art Collection however, it is the same artist and a similar type of sculpture to other sculptures in the Collection located on other San Francisco Housing Authority properties (Valencia Gardens, Western Edition). Since the jurisdiction of this piece is unclear and staff are still researching, Ms. Cummings thought it best to bring this relocation before the committee as it may belong to the City.

Ms. Llarena explained that the Sunnydale Community Center is part of a multi-phase 50-acre housing transformation that includes Sunnydale housing, Herz Recreation Center, and the community center. The proposed new location is in the plaza at the corner of Sunnydale Avenue and Jackson Way, next to the community center. The new plinth will match the color and finish of the base of the wayfinding signs located throughout the development. The sculpture plaque will be displayed at an angle on the sculpture plinth.

Commissioner Schnair asked for clarification of the wayfinding plinth material. Ms. Llarena clarified that it is cast concrete with a wood-like texture. Commissioner Hakimi asked who was funding the relocation and maintenance of the sculpture. Ms. Cummings and Ms. Llarena stated that the relocation was part of the housing project cost and conservation may be part of the process. The Arts Commission does not currently have maintenance responsibilities for this sculpture.

There was no public comment.

Motion: to approve the proposed new location for *California Bear over Head of Peace*, a black granite sculpture by Beniamino Bufano at the former Sunnydale Housing Project – now Sunnydale Hope SF. The sculpture will be relocated from the entryway to the former Leasing Office to a more prominent location in front of the new Community Center on the corner of Jackson Way and Sunnydale Avenue, as a part of the larger housing reconstruction project.

5. 2024 Art on Market Street Poster Series (0:23:59)

Program Associate Craig Corpora presented the second installment of the 2024 Art on Market Street Poster series, showcasing the Bay Area indigenous community. We Are Still Here, by Bay Area photographer and documentarian Kirti Bassendine, illuminates compelling narratives and invaluable contributions of Native communities to the cultural landscape of the San Francisco Bay Area.

Each poster includes the name of the individual featured, tribal group name, tribal website, and a personal statement. The series aims to raise awareness of and contribute to education about the participating Ohlone groups and provide a collective voice.

This poster series represents a leading member from various Bay Area tribal groups: Association of Ramaytush Ohlone with Gregg Castro; The Confederated Villages of Lisjan with Corrina Gould; Muwekma Ohlone Tribe of the San Francisco Bay Area with Monica Arellano; Tamien Nation-Quirina Geary, Indian Canyon Nation with Kanyon Sayers-Roods; Mutsun Tribal Band with Valentin Lopez; the Rumsen Ohlone Tribal Community with Linda Yemane; Esselen Tribe with Tom Little Bear Nason; the Salinan Tribe with Mary Rodgers; and the Salinan tribal community with Gregg Castro.

The posters will be installed in early June and will be up through the end of August.

The Commissioners liked the project and asked that the "We Are Still Here" text color along the top of the posters be reviewed as they felt that the text on some posters were harder to read than others. Mr. Corpora said that the composition of the posters will not change but that the artist is still working



on the graphic design of the text, and they will work on the colors to make the text more legible.

6. Mission Bay School Public Art Project (0:29:25)

Project Manager Arianne G. Davidian presented the finalists for the new Mission Bay School located on 2.5 acres at 6th Street and Nelson Rising Lane in San Francisco's Mission Bay neighborhood. The new school is scheduled to open August 2025 for the 2025-2026 academic year. The project plan was approved by the Full Commission on February 5, 2024.

The public art opportunity is a tile or mosaic artwork located on the exterior of the school's east entrance on sixth street. The total artwork area is approximately 330 sq. ft. The artwork will be bold and colorful, visually enhance the learning environment, and inspire and engage students. The artist's budget is \$136,000 (inclusive of all artist's fees, as well as associated expenses for artwork design, fabrication, insurance, transportation, and installation).

The panel reviewed a shortlist of 15 applicants for the Mission Bay School Public Art Project and identified four finalists to recommend for Arts Commission approval to develop conceptual proposals for the Mission Bay School Public Art Project. The four artists are Harumo Sato, Priscila De Carvalho, Josué Rojas, and Nico Berry.

There was no public comment.

7. Gene Friend Recreation Center Project (0:38:03)

Project Manager Arianne G. Davidian presented the selected artist, Cece Carpio, and her proposal, *Barrio Fiesta*, as recommended by the Gene Friend Recreation Center artist review panel for the integrated wall artwork public art opportunity along the interior north-facing wall of the Center's new gym located at 6th and Folsom Streets. The public art project plan was previously approved by the Commission on August 7, 2023 and the artist review panel was held on March 13th with Cece Carpio's proposal receiving the highest score.

Barrio Fiesta refers to a neighborhood celebration that brings communities together where everyone is welcome as guests and active participants. The proposed artwork design weaves historical, present-day, and futuristic figures to capture the vision and spirit of the South of Market (SOMA) neighborhood. The artwork contains portraits of well-known community leaders with portraits of "everyday" heroes. The background colors are inspired by pre-colonial batik textiles from various regions in the Philippines. Ms. Carpio will conduct interviews with SOMA community members to specify certain portrait characters to highlight in the final design. The interviews will be documented and edited by a consulting filmmaker.

The final artwork will be fabricated locally and consists of 16 panels of dyesublimated aluminum that will cover approximately 740 sq. ft. of the gym



wall. The artist's budget is \$206,550 and the site work/installation budget is \$50,000. The anticipated completion date of the project is early 2026.

Commissioners appreciated the intentionality to reflect the local cultural and neighborhood community. Commissioner Beltran appreciated that the portraits are intergenerational. Commissioner Schnair expressed concern that some of the portraits may be too dark once installed in the location. Ms. Davidian said that the colors would be tested in the physical space before fabrication.

There was no public comment.

8. San Francisco International Airport Terminal 3 Connector Two-Dimensional Artwork Program (0:54:47)

Ms. Davidian presented the list of two-dimensional (2D) artworks suggested for purchase and display in the two wall niches on either side of Alison Saar's sculpture *Flourish* at San Francisco International Terminal, Terminal 3 Connector. The 2D program's project plan was approved by the Full Commission on August 7, 2023. In August 2023, a curatorial committee made up of artist Alison Saar, an outside curator, a San Francisco International Airport Museum (SFOM) curator, and Ms. Davidian



met to nominate artists for consideration. In March 2024, the artwork selection panel met and recommended 11 artworks for purchase that relate conceptually and/or aesthetically to the Saar sculpture or it's themes. Pending approval, the artworks are expected to be installed in November or December 2024.

The Commissioners asked about how the artwork would be installed and Ms. Davidian explained that the current glass on the niches would be removed, and each artwork would be individually framed and installed within the niche.

10. Portsmouth Square *(1:10:56)*

Project Manager Aleta Lee presented the revised project plan for Portsmouth Square. Ms. Lee stated that a prior project plan was presented at VAC in February 2022 and approved. The previous plan highlighted the art glass facades on the new clubhouse as the art enrichment opportunity at the site with an art enrichment budget of \$104,000.

In response to feedback from Commissioners and community stakeholders, and with the approval of the City Administrator's Office, the Arts Commission identified an additional \$104,000 of Art Enrichment funding for the commissioning of a new artwork at Portsmouth Square. In addition, \$500,000 was funded by California State Assembly Member Phil Ting's office to be used for culturally significant public art components and maintenance for this project. Moreover, San Francisco Recreation & Parks Department committed an additional \$317,000 in funding to support a second public art commission in alignment with themes called out in the art and interpretive master planning.

Additional funding from Supervisor Peskin's office was granted to the Chinese Culture Center of San Francisco (CCC) to continue meaningful



community outreach efforts throughout the artist selection process. Ms. Lee stated that SFAC staff is working with CCC to conduct artist outreach for the Chinatown Artist Registry RFQ that will be released this summer and encompass a call for artists for several projects including the Chinatown Branch Library, Chinatown Public Health Center, and Portsmouth Square. The increase in funding has increased the artwork enrichment budget to \$921,000 precipitating a new project plan with two artwork opportunities at Portsmouth Square.

The park, located above the Portsmouth Square parking garage, will receive a complete renovation. The new park design is the result of robust community engagement and participatory design process and reflects the significance of the neighborhood while addressing programmatic challenges unique to Chinatown. The community engagement process precipitated the development of the Art & Interpretive Master Plan which will inform the goals and themes of the new public artwork commissions at Portsmouth Square. This interpretive planning process began Spring 2023 and was led by San Francisco Recreation & Parks Department and design consultant Clearstory with input from SF Planning Department, Arts Commission, project architects, and community stakeholders and scholars.

Ms. Lee shared that the two new public art opportunities are a sculpture opportunity and an art wall opportunity. The sculpture opportunity is for a human-scale sculpture comprised of durable, sustainable materials intended for exterior use to be located at the corner entrance of Walter U Lum Place and Washington Street. The art wall opportunity is for approximately 606 sq. ft. area on the large interior wall of the clubhouse and the adjacent exterior wall by the building entrance from the plaza and should be comprised of a durable material.

Ms. Lee shared that the Artist Selection Process will follow SFAC's typical guidelines and will include a Qualification Panel to create a Chinatown Artist Registry Pre-qualified Pool. Two shortlists of artists will be created for each opportunity. Artist Review Panels will consist of one representative of the client agency, four arts professionals, and one community member. The panel will identify three finalists for each artwork opportunity who will be invited to develop conceptual site-specific proposals after attending an



orientation session with the project team and key stakeholders. These finalists will be paid an honorarium of \$3,000 plus travel reimbursement for development of a proposal.

The Portsmouth Square Improvement Artist Review Panel will reconvene to consider the finalists' proposals in an interview format and will select one artist for each artwork opportunity for recommendation to the Arts Commission. The tentative release date of the RFQ is June 10th with the intention to have artists under contract by March 2025.

Ms. Lee introduced project partner Noah Levy, the Portsmouth Square project manager at San Francisco Recreation and Parks Department (RPD) Capital and Planning Division. Mr. Levy spoke about the park design which maximizes useable space, removes barriers, and better connects the park to its environment. Mr. Levy expressed RPD's full support of the public art plan, whose art opportunities will enhance the overall park design, reflect the significance of Chinatown, and enliven the public realm.

Commissioners expressed gratitude to all the partner agencies and collaborators who joined together to increase the artwork budget.

Commissioner Beltran asked for further information about the Chinatown Artist Registry. Ms. Lee explained the process of the registry in more detail and that SFAC would be collaborating with CCC to outreach to artists with a meaningful connection to Chinatown.

Public Comment:

Amy Zhou, senior planner at the Chinatown Community Development Center (CCDC) spoke in support of the new project plan and thanked SFAC staff, RPD staff, Supervisor Aaron Peskin, and Assemblymember Phil Ting for the collaboration and support in this long robust process.

Candace Huey, Head Curator at Edge on the Square, thanked Supervisor Peskin, Assemblymember Ting, SFAC and RPD for responding to the community and championing community voices and values. Ms. Huey spoke in support of the Portsmouth Square and artwork project plans.



Hoi Leung, Curator and Deputy Director of CCC, thanked Assemblymember Ting and Supervisor Peskin for championing art in Chinatown. Ms. Leung expressed gratitude for the collaboration between the Arts Commission and the Recreation and Parks Department in creating an interagency synergy that uplifts community voices. Ms. Leung expressed pride in the project and is looking forward to the new public art.

Project Manager Temporary Art & Activation, Rebeka Rodriguez Mondragón, presented the artwork review panel's selected artwork for temporary display at Patricia's Green. Ms. Rodriguez Mondragón explained the Arts Commission receives an annual allocation of development impact fees (IPIC) to display a sculpture in Patricia's Green in Hayes Valley located at the intersection of Octavia Boulevard between Hayes and Fell Streets. A public competition was conducted to solicit proposals for a sculpture to be displayed for a period of one year in Patricia's Green from artists with existing works of art that are ready and appropriate for exterior display.

The Patricia's Green review panel met May 2, 2024. Ms. Rodriguez Mondragón shared that of the proposals reviewed by the panel, Oleg Lobykin received the highest ranking. The next highest ranking went to Kristine Mays who will be considered an alternate if we are unable to proceed with the Lobykin work. Pending approvals by the Arts Commission and the Recreation and Park Commission, and the execution of the loan agreement between the Arts Commission and the artist, the sculpture will



be installed in late June or July and will remain in place for a year.
