For your reference, the relevant provisions of Elections Code section 13107 are reproduced below:

- (a) With the exception of candidates for Justice of the State Supreme Court or court of appeal, immediately under the name of each candidate, and not separated from the name by any line, unless the designation made by the candidate pursuant to Section 8002.5 must be listed immediately below the name of the candidate pursuant to Section 13105, and in that case immediately under the designation, may appear at the option of the candidate only one of the following designations:
- (1) Words designating the elective city, county, district, state, or federal office which the candidate holds at the time of filing the nomination documents to which the candidate was elected by vote of the people.
- (2) The word "incumbent" if the candidate is a candidate for the same office which the candidate holds at the time of filing the nomination papers, and was elected to that office by a vote of the people. A candidate shall not use the word "incumbent" if the candidate was elected to their office in an at-large election and is a candidate in a district-based election.
- (3) No more than three words designating either the current principal professions, vocations, or occupations of the candidate, or the principal professions, vocations, or occupations of the candidate during the calendar year immediately preceding the filing of nomination documents.
- (4) The phrase "appointed incumbent" if the candidate holds an office by virtue of appointment, and the candidate is a candidate for election to the same office, or, if the candidate is a candidate for election to the same office or to some other office, the word "appointed" and the title of the office. In either instance, the candidate may not use the unmodified word "incumbent" or any words designating the office unmodified by the word "appointed." However, the phrase "appointed incumbent" shall not be required of a candidate who seeks reelection to an office which the candidate holds and to which the candidate was appointed, as a nominated candidate, in lieu of an election, pursuant to Sections 5326 and 5328 of the Education Code or Section 7228, 7423, 7673, 10229, or 10515 of this code.
- (b) (1) Except as specified in paragraph (2), for candidates for judicial office, immediately under the name of each candidate, and not separated from the name by any line, only one of the following designations may appear at the option of the candidate:
- (A) Words designating the city, county, district, state, or federal office held by the candidate at the time of filing the nomination documents.
- (B) The word "incumbent" if the candidate is a candidate for the same office that the candidate holds at the time of filing the nomination papers.
- (C) No more than three words designating either the current principal professions, vocations, or occupations of the candidate, or the principal professions, vocations, or occupations of the candidate during the calendar year immediately preceding the filing of nomination documents.
- (2) For a candidate for judicial office who is an active member of the State Bar employed by a city, county, district, state, or by the United States, the designation shall appear as one of the following:
- (A) Words designating the actual job title, as defined by statute, charter, or other governing instrument.
- (B) One of the following ballot designations: "Attorney," "Attorney at Law," "Lawyer," or "Counselor at Law." The designations "Attorney" and "Lawyer" may be used in combination with one other current principal profession, vocation, or occupation of the candidate, or the principal profession, vocation, or occupation of the candidate during the calendar year immediately preceding the filing of nomination documents.
- (3) A designation made pursuant to subparagraph (A) of paragraph (1) or paragraph (2) shall also contain relevant qualifiers, as follows:
- (A) If the candidate is an official or employee of a city, the name of the city shall appear preceded by the words "City of."
- (B) If the candidate is an official or employee of a county, the name of the county shall appear preceded by the words "County of."
- (C) If the candidate is an official or employee of a city and county, the name of the city and county shall appear preceded by the words "City and County."
- (D) If the candidate performs quasi-judicial functions for a governmental agency, the full name of the agency shall be included.
- (c) A candidate for superior court judge who is an active member of the State Bar and practices law as one of the candidate's principal professions shall use one of the following ballot designations as the candidate's ballot designation: "Attorney," "Attorney at Law," "Lawyer," or "Counselor at Law." The statements filed shall remain confidential until the expiration of the filing deadline. (CAEC §13311)

2. Statements are printed as submitted, no changes or corrections after the filing deadline

Type or print your statement neatly. Proofread your statement carefully before submitting it. Statements will be printed as submitted. You may not make changes or corrections after the deadline for filing. Errors in spelling, punctuation, grammar, or intent will not be corrected by any official agency.

Nothing in this section shall be deemed to make any statement or the authors thereof free from any civil or criminal action or penalty because of any false, slanderous, or libelous statement offered for printing or contained in the Voter Information Pamphlet.

Any candidate who knowingly makes a false statement of a material fact in a Candidate's Statement, with the intent to mislead the voters in connection with their campaign for nomination or election to a nonpartisan office, is punishable by a fine not to exceed one thousand dollars (\$1,000).



为吸引选民支持 大量旧金山政客用正统中文名参选

【侨报网讯】华裔占旧金山市总人口的约1/4,因此地方选举的选票中默认使用中英双语。从 1999年开始,候选人开始使用中文名参与选举。而现在这一趋势影响的范围越来越广。

根据英文媒体报道,2020年,旧金山市议员迪恩·普瑞斯顿(Dean Preston)在竞选连任时, 将自己在选票上的英文名改为中文名"潘正义"。而在这之前,他在选票上的中文名是直接由英文 名音译过来的"迪恩·普瑞斯顿"。

作为一名直言不讳地倡导租户权利和其他进步事项的议员,他将"正义"作为自己中文名的原 因显而易见。

从以往来看,很多没有中国血统的候选人在选票上的中文名都是根据英文名音译而来,但是直 接的译名很多时候都过长目略显尴尬。

现在政治候选人们在选中文名的时候慎重了很多,更倾向使用正统的中文名。这样的中文名更容易让部分只会说中文的华裔选民记住,也可以帮助候选人提高在中文媒体上的知名度。

副总统贺锦丽在2003年首次竞选旧金山地区的检察官时也跟随了这一趋势,她放弃了基于音译的名字"哈里斯",选择了"贺锦丽"作为自己的中文名。

在选票上使用正统的中文名能带来多大的影响不得而知,但是根据人口普查数据,目前约有18.4万华人居住在旧金山,其中11.8万不是在美国出生的。

选举部门的数据显示,95%的旧金山选民收到的是中英双语的选票,另外5%的选民则要求西班牙语等其他语言的选票。另外,约有3万名选民要求获得中文选民资料手册,占所有选民的6%。


来自广州的移民凯伦·吉(Karen Gee)是旧金山市很多进步派政治候选人取中文名时首选的求助人选。她给很多民选官员取了中文名,比如她给州议员马特·哈尼(Matt Haney)取名为"杨驰马",寓意其在选举中能像奔跑的马一样迅速并且获胜。

在旧金山, 当候选人提交竞选表格时, 他们必须回答一个问题: 是想要让选举中文名, 还是使用已有的?

潘正义的名字还曾引起过一些争议。当他在2019年竞选市议员的时候,因为这个中文名寓意过于积极,被选举部门认为对他的对手不公平。不过在他赢得选举后,潘正义的名字得以沿用下来。

不过,关于人们是否会因为一个候选人的中文名而将选票投给他的问题,现在也变得越来越复杂。比如去年,当时的市议员马兆明(Gordon Mar)就在选举中输给白人对手乔尔·恩加迪奥(Joel Engardio)。很多华裔选民表示,他们过去会投票给任何有亚洲名字的人,但是现在他们也会考虑其他因素。

尽管如此,还是有很多潜在的候选人为自己取正统的中文名。比如,宣布将在2024年竞选第九区议员的特雷沃尔·钱德勒(Trevor Chandler)给自己取名为"陈泽维",同一选区的另一位候选人罗伯特·赫尔南德斯(Roberto Hernandez)给自己取名为"何保行",该选区的第三位潜在候选人杰姬·菲尔德(Jackie Fielder)也决定使用自己早已有的中文名"福天亮"。(完)

何保行曾经沾染毒品,并且是个酗酒者,今年是他成功戒毒戒酒的28年。他对吸毒者的经历有切身的体会,他认为应该帮助更多成瘾者送入治疗计划,提供更多公共服务。

何保行将自己描述为一个合作者,他尊重企业、生计和社区。「我不仅是个政 客,也是一个合作者。」



The Director of Elections has reviewed your submitted Chinese character-based name and supporting documents. The documentation provided insufficiently supports your usage of the Chinese character-based name that you requested to appear on the ballot for the <u>November 5, 2024 Consolidated General Election</u>. The documentation provided does not demonstrate the use of the Chinese character-based name during the preceding two years.
