President Collins asked for any agenda changes and no changes were suggested.

President Collins announced the public meeting instructions.

Commission Secretary Dhaliwal announced public comment instructions.

President Collins began the meeting by reading the Arts Commission's land acknowledgment statement.

2. Approval of the Minutes (6:20)

Commissioner Brenzel, seconded by Commissioner Schnair moved to approve the May 6, 2024, minutes.

There was no public comment.

The motion was unanimously approved.

3. General Public Comment (7:36)

Public Comment

Michael Jankosky with the American Guild of Musical Artists and member of National Labor Union representing singers, dancers, and production staff stated their request that the funds that are up for approval at Full Commission come with the condition of oversight that can be gained by board representation that includes labor level stakeholders.

There was no additional public comment.

4. Director's Report (11:45)

Director Remington recognized the month of June being Pride. Director Remington shared details about the People's Palace event that took place at City Hall. He noted his attendance at the following events: Opening of Panorama Park on May 11, public opening reception of *Praxis of Local Knowledge* on May 16, opening night performance of ACT's the *Lehman Trilogy* on May 29. He mentioned that June 8 will be the second annual Juneteenth Freedom Day Parade, as well as the 29th annual Pink Triangle Installation at Twin Peaks. He stated that the Community Investments Team and consultant AMS Research & Planning have completed the Cultural Services Allocation Plan (CSAP) and are scheduled to present the plan.

Director Remington moved on to Gallery updates. He shared *Praxis of Local Knowledge* is now open until August 17, curated by Carolina Aranibar-Fernandez, San Francisco Arts Commission Director of Galleries and Public Programs, which features the four artists Kimberley Acebo Arteche, Miguel Arzabe, Daniela Rivera, and Trina Michelle Robinson. He stated that *A Public Voice/Una Voz Pública* on the Ground Floor and North Light Court of City Hall, will be showcased through September 27, 2024. He noted a call for artists for the SFAC Galleries & SF Recreation and Parks: 2024 India Basin Artist in Residence RFQ has been extended to a deadline of 5:00 p.m., Friday, June 7, 2024, the RFQ aims to identify two San Francisco-based artists to research and engage with the India Basin Waterfront Park Project (900 Innes Avenue) and India Basin Shoreline Park (Hunters Point Blvd & Hawes Street, 950 Galvez Avenue), as well as the communities in the Bayview-Hunters Point neighborhood of San Francisco.

Director Remington shared a Public Art update. He mentioned on June 18 a sculpture by British Artist Thomas J Price, titled, *As Sounds Turn to Noise* will be installed on the Embarcadero promenade at Pier 1 and will be on view for a period of 6 months with possible extension. He made an HR

update, announcing Christian Weaver and Natalia Perez as new Program Associates hired to join the Community Investments team. Director Remington continued with a budget update, stating that Wednesday, June 12 through Friday, June 14, the Budget and Appropriation committee will hear the first round of departmental presentations, Thursday June 20 and Friday June 21 they will hold 2nd round of departmental hearing with a focus on recommendation from the budget legislative analyst, Wednesday, June 26, will be the final day of deliberations.

There was no public comment.

5. Committee Reports and Committee Matters (26:49)

1. Civic Design Committee Report (26:59)

Chair Schnair shared the Treasure Island Wastewater Resource Recovery Facility and Japantown Peace Plaza Renovation were two projects that were given final approvals. She noted the Treasure Island Wastewater Resource Recovery Facility came for its final approval, they presented the new less reflected glass that would maintain the desired design aesthetic. The team mentioned that the glass will incorporate a white dotted frit pattern which aides in bird safety. Chair Schnair explained the Japantown Peace Plaza Renovation presented a post-phase 3 approval that included changes to the stair, entrance wall, and flagpoles being made to the entryway on Geary Boulevard.

2. Visual Arts Committee Report (34:27)

Chair Ferras shared that the 2024 Art on Market Street Posters second installation showcasing the Bay Area indigenous community was approved. She noted installation will occur in early June and be up for display through the end of August. She continued with the

Mission Bay School Public Art Project approval, a tile or mosaic artwork approximately 330 square feet located on the exterior of the school's east entrance on Sixth Street. She mentioned the next approval being the Gene Friend Recreation Center Project, a 740 square feet integrated wall artwork public art opportunity along the interior north-facing wall of the Center's new gym located at 6th and Folsom Streets.

Chair Ferras announced the approval of the San Francisco International Airport Terminal 3 Connector Two-Dimensional Artwork Program, reviewed was the eleven two-dimensional artworks recommended for purchase and display in two wall niches on either side of Alison Saar's sculpture *Flourish* at San Francisco International Terminal, Terminal 3 Connector. She moved onto the approval of Portsmouth Square, a revised plan due to significant increase in Art Enrichment budget from California State Assembly Member Phil Ting's Office. She stated there are now two art opportunities, a human-scale sculpture and an art wall opportunity for approximately 606 square feet. She included the final project that was approved, Patricia's Green Temporary Art Project, *Talking Heads, 2019*, a sculpture mirror-polished stainless steel that will be exhibited for a period of one year, pending approval from Recreation and Park Department.

3. Executive Committee Report (34:30)

Chair Collins reported on approvals that occurred at Executive Committee, which included: an agreement with the San Francisco Symphony's 2023-24 and 2023-25 season, the Cultural Services Allocation Plan (CSAP), the Cultural Center grants, and the Cultural Center Lease and Operating Agreements that extends the renewal term for an additional 3-year period with the African American Art and Culture Complex, the Bayveiw Opera House, Inc., Mission Cultural Center for Latino Arts, and SOMArts Cultural Center.

There is no public comment.

4. Community Investment Committee – Market Manager Agreement (44:09)

Senior Program Officer Anne Trickey gave background on the Street Artist Vendor Program. They shared that the Market Manager does liaison work to ensure efficiency for the Street Artist program.

Commissioner Schnair, seconded by Commissioner Hakimi moved to approve the Market Manager Agreement.

There was no public comment.

The motion was unanimously approved.

RESOLUTION NO. 0603-24-153: Motion to approve a personal service contract with Costless Maintenance Services Company, Inc. dba CMSC to provide onsite management for the Embarcadero Plaza art vendor market for five years, July 1, 2024 through June 30, 2029, and to authorize the Director of Cultural Affairs to enter into a personal service contract not to exceed \$182,000 at this time.

6. Cultural Services Allocation Plan for 2024-2029 (48:39)

AMS Research & Planning Lauren Frankel and Bill Blake presented on the Arts Impact Endowment: Cultural Services Allocation Plan. Bill Blake began with the scope of work which was a multi-phased process that included evaluation and community engagement. Blake continued with the first phase which highlighted analysis and evaluation, the second defining the future, and lastly recommendations. Lauren Frankel gave a review of the first five years of the arts endowment. Blake spoke about the second phase highlighting community engagement; he provided details about the demographic included in meetings that occurred across the city. Frankel walked through the information that was gained from the community open house meetings. Frankel mentioned after attendees voted at the open houses, the top two open needs were sustaining ongoing initiative and resilience and growth. Blake stated the last phase being recommendations, they recommend sustaining ongoing initiatives,

resilience and growth, and new creative opportunities connecting to a single theme being to keeping artists in San Francisco. Frankel shared guiding principles recommendations. Concluding the presentation, Blake described the evaluation metrics that is attended to help San Francisco Arts Commission (SFAC) staff to implement program guidelines and guide recommendations in the next five years.

President Collins asked what the youth arts exchange was defining as the arts. Frankel stated that they defined the art as what they personally practiced and represented a variety of arts. Commissioner Schnair inquired about distributing fund with SFUSD, Frankel stated the funds potentially be given as individuals. Commissioner Brenzel spoke about clarifying funding for the grants for the arts and art endowment funds, Deputy Director of Programs Lex Leifheit mentioned that the funding is from the arts commission. Commissioner Hakimi suggested to reach out to communities that need attention and don't have the organization to attend open houses.

Commissioner Shelby, seconded by Commissioner Hakimi moved to approve the proposed Cultural Services Allocation Plan for 2024-2029.

There was no public comment.

The motion was unanimously approved.

7. Racial Equity Updates (1:31:24)

Senior Racial Equity and Engagement Analyst Sandra Panopio shared the Racial Equity Action Plan FY 23-24 Progress Report. Panopio implemented an annual racial equity staff survey that measured the climate of equity in the office highlighting staff needs and shared the results. She mentioned staff find it valuable to examine and discuss the impact of racial equity work. She stated 3 out of 4 staff have used racial equity tools or framework in making policy, programs, and budget decisions, they identified a need for racial equity training and standardized tools that can

be accessible by all staff to use in the workplace. She shared staff suggested leadership can increase and formalize communication around how and when they directly engage with community about racial equity goals.

Analyst Panopio continued by presenting the information that was sent as part of the progress report. She highlighted hiring and recruitment, organizational culture of inclusion and belonging, and community engagement. She continued with some racial equity practices that are priority for departments to learn or implement in the upcoming year, those being: conduct an internal analysis of existing tools and frameworks that staff already use, identify all-staff training opportunities to learn about the integrate key racial equity frameworks utilized within government and the arts sector to apply it to our work, utilize the SFAC internal homepage to provide an accessible location for racial equity training and learning resources, and racial equity team will work closely with the communications team to develop ways to share out how equity tools have been utilized.

Analyst Panopio spoke about community engagement and focusing on this aspect in the coming year. She shared some priorities that will be included in creating the community engagement plan. She mentioned what the focus will be when it comes to training. She noted the importance of conducting an internal analysis of existing tools and framework that staff already use. She shared the timeline for the Racial Equity Action Plan: a progress report to Office of Racial Equity that was recently sent in May, Racial Equity Action Plan assessment by end of summer 2024, and phase 2 Racial Equity Action Plan development beginning in the 2nd quarter of 2024.

There was no public comment.

8. Consent Calendar **(1:45:17)**

10. **RESOLUTION NO. 0603-24-165:** Motion to approve the final design of *Listening Stones*, a series of 11 granite boulders, by Mark Baugh-Sasaki for the Ocean Beach Climate Change Adaptation Project, located at Great Highway and Sloat Blvd. The 11 boulders will range in size from H7 ft. to H9 ft. (large), H5 ft. to H6 ft. (medium), to H18 in. (small). The large- and medium-size boulders will have 20-degree "cone cuts" at H43 in. to H56 in., full cane clearance at the base, and a minimum of 4 ft. to 5 ft. clearance from surrounding built elements to provide broad accessibility. The placement of the 11 boulders along the Plaza maintains clearance from underground infrastructural

elements, as well as emergency and maintenance vehicle routes.
