舊金山市議會撥徵九曲花街通行費

每逢周末都會有大批遊客湧入迂迴曲折的倫巴底街,造成交通嚴重壅塞。美聯社

三藩市市參事周四表示,在市內著名的倫巴底街 (Lombard Street, 俗稱九曲花街) 行駛的車 輛都應繳納通行費,以緩解每年數以百萬計遊客到此地參觀產生的嚴重塞車情況。

駕駛人在沿着位於住宅區內全長600呎的九曲花街行駛時,經常陷入長達三個街區的汽車長龍 中動彈不得。三藩市交通局近日發表一份報告提出該收費建議,轄區涵蓋該街的市參事麥法恩 (Mark Farrell) 再將構想落實成法案。九曲花街每年吸引大約200萬名訪客,在繁忙的夏天周 末常有高達1萬7,000人徒步或開車慕名前來。

麥法恩的發言人蒙特賈諾(Jess Montejano)表示: 「他們爬上屋頂拍自拍,或走在街道中 央, 還有人站在底部試圖拍攝仰望街道的自拍照。」

三藩市交通局最近提議建立一個電子系統、徵收通行費並追啟預約將在特定時間進入九曲花街 的汽車。住在街上的住戶則免繳費用。

駕駛人若沒有預約將開車進入該街,必須繳納更高額費用。



【大纪元2024年02月25日讯】(大纪元记者李沁一旧金山报导)曾于2018年,短暂出任旧金山市长的麦法恩(Mark Farrell),在2月13日公布,参加旧金山市长竞选。他的政见是"让旧金山市更加安全、清洁、充满活力。"

他说:"我要参加旧金山市长的竞选。我在旧金山市出生、长大,我和我的家人把旧金山社区,当成自己的家。过去5年,我们都目睹了旧金山由一个繁华、美丽的城市,一步步沦落成今天的惨不忍睹。"

麦法恩支持率暂居第一

麦法恩竞选团队在2月22日(周四)表示:"竞选市长活动刚刚启动4天,麦法恩的成绩就领先!当然,距离11月最后的投票时间尚早。"所以,麦法恩谦虚地表示:"如果今天出来的是选举结果,我是赢了。但现在说赢还太早,我们还要继续为选举日努力!"

麦法恩团队表示:"我们知道,大多数旧金山市长候选人,已经开展竞选达6个月以上,民众已经花费数百万美元支持他们。麦法恩刚刚参加竞选,您今天的捐助,任何金额都可以,就能支持他,保住第一名的成绩。"

这份关于旧金山市长选举的民意调查,是《旧金山纪事报》(San Francisco Chronicle)在2月14日~18日、对812名选民进行的。

其中40%选民未表态。在表态的选民中,20%支持麦法恩,18%支持现任市长布里德 (London Breed) ,16%支持李维斯公司(Levi Strauss & Co.) 的财富继承人丹尼尔·卢里 (Daniel Lurie) 。

选民对现任市长布里德不满

选民对布里德的不满主要集中在:她把旧金山搞得太肮脏,公共安全极差,无家可归者随处露宿,吸毒者太多且危险,居住环境糟糕,住房承担能力减弱等等。

所以, 《旧金山纪事报》在2月22日说, 市长布里德连任出现危机!

就麦法恩提出的"让旧金山市更加安全、清洁"的治理政策,本报记者随机采访了旧金山的本地居民。有大航空公司的职员表示认可,会帮助麦法恩在乘客中多做宣传,一起给麦法恩投票。

也有居民S哭诉,他早上骑自行车路过市政厅对面的公共图书馆(San Francisco Main Library),被那里成群的吸毒者,还有因为吸毒昏死过去的人,惊吓到了!居民S表示,图书馆是孩子们梦想开始的地方,是启迪人们深入思考、学习的地方。现在被这样的人群一直霸占着,政府和官员应该做点什么了!

上任第一天要解雇市警察局局长

麦法恩借选举平台表达:"我是竞选者中唯一一位,在第一天就发布了详细政见的候选人。让旧金山成为更安全、更清洁、更有活力的城市。我上任的第一天,就要解雇旧金山市警察局局长比尔·斯科特(Bill Scott)。"

麦法恩呼吁对犯罪采取"零容忍政策(A Zero Tolerance Policy for Crime)",他说:"我们需要一位,带头改革旧金山市警察局的人,他要和我一起努力,增加警察预算,增加数百名警员。"

麦法恩曾公开抨击市长布里德, 指出布里

德让旧金山市警员,减少超过500名;两年前,布里德给旧金山市警局的预算,削减1.2亿美元;麦法恩在2018年担任市长时,旧金山警察学院班级(San Francisco Academy Class),每个班平均有50多名学员,而布里德时期,只有19人,还有几人第一周之后就退学了。

根据旧金山市法律,市长有权解雇市警察局局长。但是,市长必须从该市警察委员会 (Police Commission) 推荐的候选人中,选出一人,出任新局长。

麦法恩竞选信息

麦法恩还承诺:"清理所有大型的无家可归者居住场所,帮助瘾君子,清理街头垃圾等。"

从麦法恩的政见看来,如果其选举成功,说明旧金山市的政治光谱,将从极左派转向温和的中间派。

從2017年12月12日淩晨,到2018年7月11日正午,211天,是美國一座大型城市市長 誕生所需要的時間。7月11日正午,在舊金山市府廣場前的市政中心廣場,美國中文 網記者與數千民眾一起共同見證了一個曆史時刻的出現:勝選市長布裏德宣誓就職, 正式成為第45任舊金山市市長、同時也是這座城市有史以來第一位女性非裔市長。

在宣誓環節後的就職演說中,布裏德不忘回顧她站上演講台的由頭,這一路的開端便 是2017年12月12日淩晨傳遍全城的一個噩耗: 時任舊金山市市長、舊金山曆史上首位 華裔市長李孟賢因突發心髒病搶救無效被宣告死亡。從接到這一消息開始,在過去的 211天,美國中文網記者親自見證了第45任舊金山市長誕生的每一個重要時刻。

在美國,一座大型城市市長究竟是如何誕生的? 這篇文章將為你梳理答案。

1. 舊金山市長如何選?

通常來說,舊金山市長每四年選舉一次,每一任市長最多連任兩屆。如果在任市長因

登對價值\$180億中國進口產品 加征關稅 各方如何看? 特殊情況無法繼續履行職務時,可由其提名委任,並由議會投票通過產生過渡市長, 代其完成遺留任期。如市長在任期內因故離世,則按照舊金山市憲章規定,由市議會 主席直接接替擔任代理市長,並在隨後由議會商議產生過渡市長。

以上兩種特殊情況均發生在了舊金山曆史上首位華裔市長李孟賢 (Ed Lee) 身上。 2011年年初,因前市長紐森出任加州副州長,受其提名,並經由舊金山市議會投票通 過,李孟賢首次擔任舊金山市過渡市長,並於2011年8月選舉中獲勝,成為舊金山曆 史上首位民選華裔市長。2017年12月12日,李孟賢在第二屆任期內因突發心髒病離 世,留下一年多任期未滿。因此,舊金山市議會決定舉辦一場特別選舉,產生新任市 長。

與絕大多數美國城市的市長選舉機製不同,舊金山采取"優先選擇投票"(也被稱作"即時複選"),也就是一次定勝負。據舊金山選務處處長John Artnc向美國中文網記者介紹,在這種計票機製下選民可依序填寫最多三個候選人,第一輪計票將對獲得第一選擇的侯選人進行計票,如果有候選人獲得超過半數選票,則直接勝出;如果沒有候選人獲得過半計票,那麽排名最後的候選人被剔除,但他獲得的選票將算在這些選民選擇的第二候選人身上,這個計票方式一直繼續,直到有候選人得到超過50%的選票。

這種選舉機製意味著不同於絕大多數的選舉有"二選一"的局麵,在舊金山,排名前三的候選人都是主力候選人,均有可能在選舉中獲勝,且三人之間的合縱連橫由為關鍵,這也是本次舊金山市長特別選舉雖然稍顯冷清,卻又格外"刺激"的原因之一。 (點擊複習《24小時三次反轉!舊金山市長選舉現罕見逆襲竟是因為它》)

2. 誰有資格參選?

"凡是年滿18周歲、居住在舊金山市的美國公民,在繳納6500美元以後,基本都有資格參與市長角逐",參與本次競選的一位候選人給出了這樣的答案。參考舊金山市超過87萬的總人口(2016年數據),可見市長競選的門檻並不高。

看上去6500美元的入門費並不高,但是報名參選的人並不會太多,用上述候選人的話來說,因為"沒人喜歡看錢打水漂"。不過,這不妨礙還是有不少人想要"任性一把"。 參與本次競選的候選人李愛晨告訴美國中文網記者,勝選當然是好事,但即便落敗, 對於反大麻群體來說,花6500美元在盡可能公開的場合,麵對盡可能多的民眾,充分 表達反大麻的立場,"罵夠政府半年"(從1月初報名截止到6月決選剛好半年)也是值 得的。不僅如此,他們還要物盡其用,保證這6500美元的當中的每一分都用夠本。

除了反大麻群體外,此次參選的還有推動無家可歸者權益保護的社會活動人士。不論因為何種原因選擇參選,在下定決定繳納費用,並獲得舊金山選務處批準後,舊金山選務處就將會將這些人聚起來上課,充分講解競選當中的所有注意事項。"在一個小時的課程之後,他們會給我們發一些小冊子,讓我們回家後仔細閱讀",一位候選人告訴美國中文網記者,這些材料廣泛而細致,比如,會明確規定在投票當日候選人支持者打出的手牌或橫幅需要和投票箱保持的距離。

3. 在職人員是否更有優勢?

理論上講,具備參選市長資格的名額不計其數,但真正勝出的名額有且隻有一個。曆 史上,不論是地方、還是州或聯邦級競選中非"職業選手"勝出的例子並不少見。比 如,裏根、施瓦辛格和川普。現在,競選中的"黑馬"越來越常出現,不過,在絕大多 數的情況下,競選依然是"種子選手"們的角逐。

在曆屆舊金山市長競選中,絕大多數的勝出者都有共同的經驗背景,曾在舊金山議會 擔任議員或其它市府公職,如果參選人處於在職參選狀態,那麽所謂的"在職優勢"就 會體現得更為明顯。類似的曆史在舊金山不斷重現:

1978年11月,由於時任市長莫斯科尼(George Moscone)遭政敵刺殺身故,擔任議長職位的範士丹(Dianne Feinstein)接替擔任臨時市長,在隨後舉行的市長競選中,曾經兩次衝擊市長寶座未果的她,憑借在職優勢一舉奪魁,成為舊金山曆史上首位女性市長。以舊金山市長為跳板,範士丹隨後的政治之路可謂青雲平步,現在,她是聯邦參議員中年紀最長的一位。

2011年,類似的情景再次上演。時任舊金山市長紐森(Gavin Newson)在據任期結束 還剩一年時升任加州副州長,時任行政官的李孟賢被推舉接替出任市長,當時,他曾 經口頭承諾不會參與市長競選。不過,2011年8月打破承諾,宣布競選舊金山市長, 並成功勝選,舊金山也由此迎來了曆史上第一位華裔市長。

正是因為有範士丹和李孟賢的先例,在這一次的選舉中,當布裏德以代理市長身份決定參選舊金山市市長時,舊金山議會內部就是否免除布裏德的代理市長之位以免對其他候選人造成不公平競爭優勢展開討論並投票,結果,她在當晚失去代理市長之位,轉由不參與競選的議員麥法恩(Mark Farrell)出任過渡市長。

SAHITANC SO FILT: 2024 JUNIO PM 2: 17 不過,一個多月的代理市長生涯還是為布裏德製造了不少優勢,她有更多機會出現在公眾麵前,能提前熟悉市長工作,並在競選經費的前期籌集中獲得領先優勢。就連她本人在麵對媒體時也表示,正是因為代理市長期間的工作讓她最終做出了參選的決定。

最近,舊金山議會已經提出考慮修改市憲章,要求接受代理市長/過渡市長職位的公職 人員不得參與隨後舉行的市長選舉,以完全消除"在職優勢"對於選舉結果的影響。

4. 錢有多重要?

幾乎所有人都知道,美國選舉很耗錢。據舊金山選務處工作人員透露,一場全市範圍內的選舉耗資約為300萬美元。但這還隻是政府公費開支,競選中真正的金錢比拚是籌款能力。不誇張的說,一場選舉中,錢倉就是候選人的彈藥庫,有了錢,也就有了打勝仗的底氣。一旦有競選人在籌款上與其它候選人拉開了差距,幾乎就相當於勝券在握。當然,這隻是"一般而言",希拉裏與川普的總統大戰就作出了"二般詮釋",在籌款額的對抗中贏了川普的希拉裏卻最終沒有贏下整個選舉。

為什麼籌款如此重要? 首先,不得不承認的是,籌款在一定程度上體現出民意,籌款額多的候選人的勝選信心也更為強烈。其次,選舉當中的各項支出,包括各式各樣的競選廣告、助選人力和物力都需要金錢鋪路。如果在選情焦灼時到舊金山華埠一趟,便能直觀感受到候選人團隊財力的不同。

在籌款經費上遙遙領先的布裏德的海報幾乎遍布華埠的大街小巷,在數量和製作的精良度上明顯領先於其它候選人。而在選舉前的每一場辯論會上,便又是一個直觀比拚的機會。在場外,各種舉手牌、發傳單的工作人員隨處可見。除了這些必要的宣傳工作外,選前的上門或電話拜票也需要不少人員。一般來說,這些人當中主要以誌願者構成,不過,在一些財力相對雄厚的競選團隊中,花錢雇人也並不少見。

在6月5日的決選日當天的最後衝刺階段,布裏德團隊直接包了輛電車巡遊,並向華埠民眾贈送外形神似紅包的小禮物,豪氣可見一斑。

理論上,參選花不了多少錢,但競選就是另一回事了。按照舊金山的選舉規定,在先期階段,以每個個體捐款人不超過500美元為上限,候選人如果能籌集到5萬美元,便可獲得公共競選經費的同等匹配,直至達到某個上限。5萬美元看似不多,但在這場選舉中,隻有三名候選人——布裏德、裏諾和金貞妍——拿到了公共競選經費的支持,他們也成了這場競選中最受關注的真正的實力角逐者。

不過,拿錢也有講究。在美國範圍內,因競選經費獲取環節出問題惹出麻煩甚至身陷囹圄的案例也並不鮮見。錢來自哪裏,該不該拿,也是候選人團隊需要仔細掂量的問題。畢竟,所謂拿人手短,獲得直接資金支持也就往往意味著候選人需要對資金來源方作出一定承諾。在舊金山,市長候選人資金來源也往往成為競爭對手詬病的對象。一些候選人認為現在的競選經費條例仍有缺陷,比如對於個體捐款有明確要求,但對於團體資金支持則相對寬泛,這使得有些候選人得以接受在舊金山外的團體支持,這些資金往往數額相對較大。

如果說選民是做"選擇",在絕大多數的選舉中,金主則多像是下"賭注"。在總統大選中,著名風投人彼得·泰爾(Peter Thiel)一反眾多矽穀大佬的風向,押注川普獲勝,被視作是眼光獨到的一次成功投資。在舊金山的市長選舉中,除了候選人的基本主張外,部分金主也會看風使舵,在前期觀望,後期再亮明傾向,甚至前後更改支持者的例子也時有發生。

5. 候選人如何爭取選票?

在任何級別的競選中,無論數量多少,口頭上的空頭支票是任何一位候選人都難免要 發出的。有經驗的競選團隊會不斷對競選綱領作出微調,也會因不同選民群體而區別 性作出不同承諾。必要的掃街和拜票自然必不可少,不過,相比於口頭承諾對未來的 期許,候選人的過往似乎更擲地有聲地告訴選民,他/她是否是一位理想的候選人。

每一個候選人背後都清晰地站著他/她的過往:出身、經曆、言論、行動,一路走來的每一步都將被置於大庭廣眾之下被嚴格清算。這些過往構成候選人一幅擺脫不掉的影子,並以此為基礎,為選民塑造一個關於他/她的未來形象。

兩位為金貞妍團隊做誌願者的年輕學生告訴美國中文網記者,她們之所以選擇為金貞妍吶喊,是因為兩人是舊金山市立大學的學生,而金貞妍推動舊金山市立大學免費,在全美首開先例,這兩位誌願者便是這一政策的受益者。與此同時,金貞妍曾力主為科技公司免稅則成為她身上極具標識性的舉動。因此,在金貞妍的支持力,年輕學生和科技人士是主要代表。裏諾曾為LGBT群體權利奔走呼號,自然獲得了絕大多數的該群體票倉。

如果說,過去塑造了一位候選人,那麽時代將成就一位候選人。每個人都有屬於他/她的曆史時代,被視作LGBT權益先驅的裏諾似乎稍微錯過了屬於他的黃金時代,高學曆重教育的亞裔移民後代金貞妍似乎又還沒到屬於她的最佳時機,布裏德的綱領則真正切中了這個時代舊金山民眾最渴求的改革。在美國中文網記者的隨機采訪中,關於住房、遊民、治安和環境衛生問題的痛恨排在極為靠前的位置。一位民眾告訴美國中文網,布裏德出身底層,成長在公屋,對暴力和藥物問題有切身體會,並擁有必要的知識和經驗,他堅信布裏德可以在住房、無家可歸者、治安和街道環境方麵給舊金山提出。這當然隻是對於未來的想象,但這種想象足以支撐一張投票。

在候選人核心理念的基礎上,黨派和族裔也極為重要,但在舊金山的政黨單一又文化多元的環境中,似乎就沒有那麽要害突出了。

6. 參選的意義在哪裏?

拋開候選人的個人政治前途,每一次競選,候選人總是帶著個人奮鬥故事,並帶著一部分團體的使命,這些形成了整個社會的公共財富。

在7月11日的宣誓就職典禮結束後,一位非裔民眾向美國中文網坦誠,最打動她的是布裏德的個人故事,另一位則直言,布裏德帶給舊金山、美國、甚至全世界以希望。"我小時候在公屋長大,距離這裏(指市府大樓)隻有幾個街區之隔",在演講中,布裏德坦言自己出身底層,但憑借教育得以改變命運,她希望今後有更多舊金山的年輕人有機會從公屋奮鬥到市長辦公室。

金貞妍的Party上年輕人格外多。金貞妍在台上動容地說,年輕人的參與和支持非常重要,因為十幾年前,有一個和他們年紀相仿的年輕女孩兒也曾經參與了一位市長的競選活動,"十幾年過去後,那個年輕的女孩兒現在站到了這裏"。在金貞妍看來,如果不是當年以誌願者的身份參與選舉而種下了一顆種子,她或許並不會走上從政之路。

當晚,相隔不遠處的候選人裏諾的Party也同樣熱鬧。這位候選人是加州史上首位公開同性戀身份的參議員,曾在擔任舊金山市議會時大力推動舊金山同性婚姻合法。裏諾在這次的競選中獲得了LGBT團體的鼎力支持,他的競選辦公室是一處漂亮的藝術展室,裏麵掛著不少LGBT相關的藝術作品,辦公室由他的競選支持者捐贈使用。當天晚上,就是在這裏,一群人輪流舉起彩虹旗快樂地舞蹈,對他們而言,不論結果如何,有人代表這個群體發聲,要求更廣泛且深入地平權是值得驕傲的,而他們每一個人,都為此盡過一份力。

For your reference, the relevant provisions of Elections Code section 13107 are reproduced below:

- (a) With the exception of candidates for Justice of the State Supreme Court or court of appeal, immediately under the name of each candidate, and not separated from the name by any line, unless the designation made by the candidate pursuant to Section 8002.5 must be listed immediately below the name of the candidate pursuant to Section 13105, and in that case immediately under the designation, may appear at the option of the candidate only one of the following designations:
- (1) Words designating the elective city, county, district, state, or federal office which the candidate holds at the time of filing the nomination documents to which the candidate was elected by vote of the people.
- (2) The word "incumbent" if the candidate is a candidate for the same office which the candidate holds at the time of filing the nomination papers, and was elected to that office by a vote of the people. A candidate shall not use the word "incumbent" if the candidate was elected to their office in an at-large election and is a candidate in a district-based election.
- (3) No more than three words designating either the current principal professions, vocations, or occupations of the candidate, or the principal professions, vocations, or occupations of the candidate during the calendar year immediately preceding the filing of nomination documents.
- (4) The phrase "appointed incumbent" if the candidate holds an office by virtue of appointment, and the candidate is a candidate for election to the same office, or, if the candidate is a candidate for election to the same office or to some other office, the word "appointed" and the title of the office. In either instance, the candidate may not use the unmodified word "incumbent" or any words designating the office unmodified by the word "appointed." However, the phrase "appointed incumbent" shall not be required of a candidate who seeks reelection to an office which the candidate holds and to which the candidate was appointed, as a nominated candidate, in lieu of an election, pursuant to Sections 5326 and 5328 of the Education Code or Section 7228, 7423, 7673, 10229, or 10515 of this code.
- (b) (1) Except as specified in paragraph (2), for candidates for judicial office, immediately under the name of each candidate, and not separated from the name by any line, only one of the following designations may appear at the option of the candidate:
- (A) Words designating the city, county, district, state, or federal office held by the candidate at the time of filing the nomination documents.
- (B) The word "incumbent" if the candidate is a candidate for the same office that the candidate holds at the time of filing the nomination papers.
- (C) No more than three words designating either the current principal professions, vocations, or occupations of the candidate, or the principal professions, vocations, or occupations of the candidate during the calendar year immediately preceding the filing of nomination documents.
- (2) For a candidate for judicial office who is an active member of the State Bar employed by a city, county, district, state, or by the United States, the designation shall appear as one of the following:
- (A) Words designating the actual job title, as defined by statute, charter, or other governing instrument.
- (B) One of the following ballot designations: "Attorney," "Attorney at Law," "Lawyer," or "Counselor at Law." The designations "Attorney" and "Lawyer" may be used in combination with one other current principal profession, vocation, or occupation of the candidate, or the principal profession, vocation, or occupation of the candidate during the calendar year immediately preceding the filing of nomination documents.
- (3) A designation made pursuant to subparagraph (A) of paragraph (1) or paragraph (2) shall also contain relevant qualifiers, as follows:
- (A) If the candidate is an official or employee of a city, the name of the city shall appear preceded by the words "City of."
- (B) If the candidate is an official or employee of a county, the name of the county shall appear preceded by the words "County of."
- (C) If the candidate is an official or employee of a city and county, the name of the city and county shall appear preceded by the words "City and County."
- (D) If the candidate performs quasi-judicial functions for a governmental agency, the full name of the agency shall be included.
- (c) A candidate for superior court judge who is an active member of the State Bar and practices law as one of the candidate's principal professions shall use one of the following ballot designations as the candidate's ballot designation: "Attorney," "Attorney at Law," "Lawyer," or "Counselor at Law." The designations "Attorney" and "Lawyer" may be used in combination with one other current principal profession, vocation, or occupation of the candidate, or the principal profession, vocation, or occupation of the candidate during the calendar year immediately preceding the filing of nomination documents.
- (d) For purposes of this section, all California geographical names shall be considered to be one word. Hyphenated words that appear in any generally available standard reference dictionary, published in the United States at any time within the 10 calendar years immediately preceding the election for which the words are counted, including a generally available standard reference dictionary published online, shall be considered as one word. Each part of all other hyphenated words shall be counted as a separate word.
- (e) The Secretary of State and any other elections official shall not accept a designation of which any of the following would be true:

- (1) It would mislead the voter.
- (2) It would suggest an evaluation of a candidate, such as outstanding, leading, expert, virtuous, or eminent.
- (3) It abbreviates the word "retired" or places it following any word or words which it modifies.
- (4) It uses a word or prefix, such as "former" or "ex-," which means a prior status. The only exception is the use of the word "retired."
- (5) It uses the name of any political party, whether or not it has qualified for the ballot.
- (6) It uses a word or words referring to a racial, religious, or ethnic group.
- (7) It refers to any activity prohibited by law.
- (f) If, upon checking the nomination documents and the ballot designation worksheet described in Section 13107.3, the elections official finds the designation to be in violation of any of the restrictions set forth in this section, the elections official shall notify the candidate by registered or certified mail return receipt requested, addressed to the mailing address provided on the candidate's ballot designation worksheet.
- (1) The candidate shall, within three days, excluding Saturday, Sunday, and state holidays, from the date the candidate receives notice by registered or certified mail, or from the date the candidate receives actual notice of the violation, whichever occurs first, appear before the elections official or, in the case of the Secretary of State, notify the Secretary of State by telephone, and provide a designation that complies with subdivision (a) or (b).
- (2) If a candidate fails to provide a designation that complies with subdivision (a) or (b) within the three-day period specified in paragraph (1), a designation shall not appear after the candidate's name.
- (g) A designation given by a candidate shall not be changed by the candidate after the final date for filing nomination documents, except as specifically requested by the elections official as specified in subdivision (f) or as provided in subdivision (h). The elections official shall maintain a copy of the ballot designation worksheet for each candidate that appears on the ballot in the county for the same period of time as applied to nomination documents pursuant to Section 17100.
- (h) The designation shall remain the same for all purposes of both primary and general elections, unless the candidate, at least 98 days before the general election, requests in writing a different designation which the candidate is entitled to use at the time of the request.
- (i) In all cases, the words so used shall be printed in a manner consistent with the space requirements of Sections 13207 and 13211.
- (j) If a foreign language translation of a candidate's designation is required under the federal Voting Rights Act of 1965 (52 U.S.C. Sec. 10101 et seq.), as amended, to appear on the ballot in addition to the English language version, it shall be as short as possible, as consistent as is practicable with this section, and shall employ abbreviations and initials wherever possible in order to avoid undue length.

For your reference, Elections Code section 13107.3 is reproduced below:

- (a) A candidate who submits a ballot designation pursuant to subdivision (a) of Section 13107 shall file a ballot designation worksheet that supports the use of that ballot designation by the candidate, in a format prescribed by the Secretary of State.
- (b) The ballot designation worksheet shall be filed with the elections official at the same time that the candidate files his or her declaration of candidacy.
- (c) In the event that a candidate fails to file a ballot designation worksheet in accordance with subdivision (a), no designation shall appear under the candidate's name on the ballot.

For your reference, Elections Code section 13107.5 is reproduced below:

- (a) A candidate's ballot designation as "community volunteer" shall constitute a valid principal vocation or occupation for purposes of subdivision (a) of Section 13107, if not otherwise in violation of any of the restrictions set forth in that section, and subject to the following conditions:
- (1) A candidate's community volunteer activities constitute his or her principal profession, vocation, or occupation.
- (2) A candidate is not engaged concurrently in another principal profession, vocation, or occupation.
- (3) A candidate may not use the designation of "community volunteer" in combination with any other principal profession, vocation, or occupation designation.
- (b) The Secretary of State shall by regulation define what constitutes a community volunteer for purposes of this section.

For your reference, California Code of Regulations section 20711 is reproduced below:

- (a) In order to facilitate review of a candidate's proposed ballot designation by the Secretary of State pursuant to Elections Code § 13107, the candidate shall submit, at the time of filing his or her proposed ballot designation on the Declaration of Candidacy, a completed Ballot Designation Worksheet on a form provided by the Secretary of State.
- (b) All Ballot Designation Worksheets filed with the Office of the Secretary of State or the county elections officials pursuant to this section shall be public records and shall be available for inspection and copying at the public counter of the Elections Division of the Office of the Secretary of State, Fifth Floor, 1500 11th Street, Sacramento, California 95814, or at the office of the applicable county elections official.
- (c) The Secretary of State shall provide a master copy or copies of the Ballot Designation Worksheet to all elections officials responsible for providing and accepting the nomination documents for candidates in elections for offices certified by the Secretary of State. The Ballot Designation Worksheet shall request that the candidate proposing the ballot designation provide the following information:
- (1) The candidate's name, home, business and mailing addresses, telephone numbers, e-mail address, if available, and fax number;
- (2) A designation of the office for which the candidate is seeking election;
- (3) The name, home, business and mailing addresses, telephone numbers, e-mail address, if available, and fax number of the attorney representing the candidate or for any other person to be contacted in the event the Secretary of State requires further information regarding the proposed ballot designation;
- (4) The proposed ballot designation submitted by the candidate;
- (5) The candidate may submit one or more proposed alternate ballot designations ranked in order of the candidate's preference;
- (6) A brief statement identifying the factual basis upon which the candidate claims the proposed ballot designation and each proposed alternate ballot designation, including the following:
- (A) If the candidate holds elected office and is submitting his or her proposed ballot designation pursuant to Elections Code § 13107, subdivisions (a)(1) or (a)(2), the candidate shall indicate the elective office he or she currently occupies and may attach a copy of his or her Certificate of Election;
- (B) If the candidate is a judicial officer and is submitting his or her proposed ballot designation pursuant to Elections Code § 13107, subdivisions (a)(1) or (a)(2), the candidate shall indicate the elective office he or she currently holds and may attach either (A) a copy of his or her Certificate of Election or (B) a copy of his or her commission or certificate of appointment, issued at the time the candidate was appointed to the judicial office which he or she currently occupies;
- (C) If the candidate submits a ballot designation pursuant to Elections Code § 13107, subdivision (a)(3), the candidate shall indicate:
- (i) The title of the position or positions which he or she claims supports the proposed ballot designation;
- (ii) The dates during which the candidate held such position;
- (iii) A description of the work he or she performs in the position;
- (iv) The name of the candidate's business or employer;
- (v) The name and telephone number of a person or persons who could verify such information; and
- (vi) A statement that the professions, vocations or occupations relied upon to support the proposed ballot designation constitute the primary, main or leading professions, vocations or occupations of the candidate, in accordance with the definition of the term "principal" as set forth at § 20714, subdivision (b).
- (D) If the candidate submits a ballot designation pursuant to Elections Code § 13107, subdivision (a)(4), the candidate shall indicate the date on which he or she was appointed to the office for which he or she is an appointed incumbent.
- (d) The candidate may attach or append any supporting documents or other exhibits to his or her Ballot Designation Worksheet which he or she believes support his or her proposed ballot designation. Such attached documents or other exhibits shall be deemed to be incorporated by reference as part of the candidate's Ballot Designation Worksheet and shall be considered as such by the Secretary of State.
- (e) If a candidate requests a change of his or her ballot designation pursuant to Elections Code § 13107(e), that request shall be accompanied by a Ballot Designation Worksheet.
