



## **REGULAR MEETING MINUTES**

### CALL TO ORDER AND WELCOME / President Jason Chittavong

Meeting called to order at 6:00PM.

## PRESENTATIONS

- Introduction to the Bayanihan Equity Center (a San Francisco based non-profit formerly known as Veterans Equity Center). Included in PPT presentation was an overview of HRC 6121 – The Filipino Veterans Fairness Act of 2023. [PPT slides posted to VAC website.]

Presenters: Luisa M. Antonio, Executive Director & Mary Roque, Operations Manager, Bayanihan Equity Center.

At the presentation's conclusion, commissioners thanked Ms. Antonio and Ms. Roque for the Center's work in support of veterans. Especially noted was the effort, on behalf of WWII Filipino veterans, to gather support for HR 6121. Actionable comments included:

- Commissioner Rusanoff asked how VAC can support H.R. 6121. Ms. Antonio replied that presently there are 43 co-sponsors for the bill. She said letters from the Commission to the chair and to the ranking member of The House Committee on Veterans' Affairs would be a helpful action.
- Commissioner Chan commented he can reach out to Congressman Mark Takano. He said he would follow up with Ms. Antonio after the meeting.

President Chittavong thanked presenters. The commission secretary noted an action item for HR6121 would be addressed later in the meeting under, "New Business."

As requested at start of meeting, Commissioner Chan's discussion topic was the next agenda item:

- California State Commanders Veterans Council Legislative Report. [Discussion]

Commissioner Chan shared a brief overview of CA State Commanders Veterans Council. He noted he serves as the Council's elected secretary, and recommended VAC meetings include a report from the Council. President Chittavong asked how reports would continue if Commissioner Chan's role with the Council ended. Commissioner Chan responded that even if he gave up his position with the state, he could invite members of the Council to speak at VAC meetings. President Chittavong commented it sounded like a great idea. The commission secretary will follow up with Commissioner Chan.

(Meeting returned to second item under Presentations.)



- Memorial Day Planning Update

Speaker: Ronnie Campbell, Administrative Officer Golden Gate National Cemetery

Mr. Campbell gave a planning update about the Memorial Day ceremony that will be held at the San Francisco Presidio on Monday, May 27. He noted several commissioners are already participating in the event. He said there are still opportunities for others to participate and shared his contact information. - District 4, Supervisor Engardio: In Commissioner Barnickel's absence, the commission secretary shared an update on his behalf: The commissioner met with Supervisor Engardio and the Supervisor will plan to include a veteran interview (Hanley Chan) in the May newsletter. Along with the interview will be an article about how veterans in the Sunset can qualify for VA benefits.



## **APPROVAL OF MEETING MINUTES**

(Commission secretary noted one revision: The March 12 meeting minutes were edited to list Commissioner Rusanoff as absent.)

Call for motion to approve March 12, 2024 regular meeting minutes.

Motion passed. Minutes approved.

## **NEW BUSINESS**

Commission Support of HRC 6121 (link to text emailed to commissioners prior to meeting) and recommendation to BOS to support legislation. [Action]

- Motion called to draft a letter of support for HRC 6121.

Motion / Second / All in Favor.

Motion passed. A draft letter of support will be reviewed/finalized during next month's meeting.

Commission support of CA SB 1012: The Regulated Psychedelic Facilitators Act and the Regulated Psychedelic-Assisted Therapy Act. Bill introduced by Senator Wiener on January 24, 2024. A link to legislative summary was emailed to commissioners prior to the meeting. A draft resolution submitted by Commissioners Chan and Kutovaya was also emailed to commissioners for their review. [Discussion / Action]

- It was noted CA SB 1012 was amended on March 20. The draft resolution does not reflect the amended bill. It was recommended that the resolution be updated and re-submitted during next month's meeting. After discussion, public comment was called for:

Speaker 1: Mitch Weller spoke in support of CA SB 1012. Comments included that delay of passage of bill until it is in perfect order will delay help to veterans in need. Acknowledged members of the commission do not have medical expertise, but doctors were involved in



drafting this legislation. Further noted individual personal experience does not override statistics.

Speaker 2: Christopher Kline. He said when dealing with drugs or psychedelics, HSA uses surveillance systems. That, in combination with surveillance used by the police department and Sheriff's department can lead to overdoses and suicides. He concluded by saying he would elaborate further during general public comment.

Motion called for draft resolution to be re-written to match the amended text of CA SB 1012. Commissioner Kutovaya volunteered to re-write resolution.

Motion / Second / All in Favor.

Motion passed. Revised resolution will be submitted during next month's meeting.

## **ANNOUNCEMENTS**

- Commissioner Dacumos shared the Bataan Death March Commemoration will take place on April 13. (Event details posted to VAC website.)
- Commissioner Jordan said that on April 17 the San Mateo County Veterans Affairs Commission will host a veterans community fair. Everyone is invited to attend.

## **GENERAL PUBLIC COMMENT**

- Speaker 1: Christopher Kline, a Marine Corps. Veteran. He shared a copy of an e-mail about a surveillance system called Sherlock. He said he is contacting several other San Francisco City & County commissions and departments with concerns about this surveillance system.
- Speaker 2: Andrew Dugard shared comments about ways to help improve mental health of veterans. Comments included establishing a "nutritional market" – a combination of a farmers' market and a flea market which can be a more visible platform to share information about veterans benefits. May also lead to employment opportunities for veterans. Working with animal shelters is also a good option. Canine companionship can be very beneficial to mental health.



- Speaker 3: Mitch Weller, comments included that there is still a lack of awareness of the benefit programs available to veterans. Noted a full-service dashboard was recently launched to help veterans onboard for a complicated tax credit program. These technologies can be applied to get veterans into housing, get disability benefits, etc. Improved outreach and making better use of the San Francisco War Memorial Building will help.

## **HONOR REPORT AND MOMENT OF SILENCE**

In memory of American service members in all wars and conflicts who made the ultimate sacrifice. We also remember the passing of homeless veterans, veterans who died while awaiting approval of benefits, and suicides within the veteran and armed service communities.

- It was noted, today, April 9, commemorates the 80<sup>th</sup> year of the Bataan Death March. Commissioner Rusanoff asked for a moment of silence in memory of the lives lost during the march.
