DEPUTY MARRIAGE COMMISSIONER ONE TIME DEPUTIZATION POLICY

If you are interested in becoming a Deputy Marriage Commissioner for a day, please see the restrictions below for this process:

Deputization will <u>only</u> be granted on a San Francisco County issued marriage license.

A photocopy of the marriage license must be presented at time of deputization.

- 1. Must appear in person at the Office of the County Clerk with valid legal photo identification.
- 2. Must be at least 18 years old.
- 3. California residency is not a requirement.
- 4. Must be fluent in the English language.
- 5. Applicant will be required to take the oath of office swearing/affirming to support and defend the Constitution of the United States and the Constitution of the State of California.
- 6. Marriage ceremony must be performed in California for the specific couple and date listed on the oath.
- 7. Deputy Marriage Commissioners for a Day are not City officials and do not speak for the City. They must adhere to statutory requirements concerning the solemnization of marriages, but the City does not otherwise control the content of marriage ceremonies they perform.
- 8. Deputization service is offered on a walk-in basis Monday Thursday, 8:00 a.m. 11:00 a.m. Deputizations are not offered on Fridays.
- 9. Fee is \$177.00* payable to SF County Clerk.
- 10. Process takes approximately 30 minutes.

The Office of the County Clerk has a right to refuse deputization of a person should the office feel that the person is unable to complete the paperwork correctly.

The deputization process is an optional service granted by some counties. Counties are <u>not</u> required to provide this service. Should you not meet the requirements above, you should try contacting other counties to inquire about their policies.

INSTRUCTION PACKET FOR DEPUTY MARRIAGE COMMISSIONER Sworn-in for One Ceremony Only

Congratulations on becoming a Deputy Marriage Commissioner. <u>Your commission is valid for ONE</u> civil ceremony only as stated on your oath of office to be performed in the State of California.

Deputy Marriage Commissioners cannot accept money or anything of value for performing a marriage on a day other than a legal holiday or weekend, or will be in violation of Penal Code 70.5. Solemnizing a marriage without first being presented with a California marriage license, willfully making a false statement on a marriage license to the County Clerk, or failing to file a license within 10 days of marriage, is a misdemeanor under Penal Code 360.

On the day of the ceremony, prior to officiating, the couple <u>must</u> provide you with a valid San Francisco County issued marriage license.

Attached are instructions for completing the License and Certificate of Marriage (VS-117) and the Confidential License and Certificate of Marriage (VS-123), whichever is applicable.

After the marriage, it is your responsibility to return the license to the proper agency:

Also, for your convenience, we have included copies of standard civil ceremony vows used by the San Francisco County Clerk's Office. If you use other ceremony vows, both parties must declare in your presence when solemnizing the marriage that they take each other as husband/wife and husband/wife or spouses for life. You are required to end the ceremony with the declaration "by virtue of the authority vested in me by the State of California, I now pronounce you husband/wife and husband/wife [spouses for life]."

AFFIDAVIT RE: DUPLICATE MARRIAGE LICENSE (CA Family Code 360 and 510)

Pursuant to CA Family Code 360 and 510, if the marriage license is lost, damaged, or destroyed after the marriage ceremony, but prior to registration, or deemed unacceptable for registration as presented due to erasure(s), whiteout(s), and/or alteration(s), an affidavit and fee are required for a duplicate marriage license. The duplicate license may not be issued later than one year after the date of the marriage and shall be returned by the person solemnizing the marriage to the county recorder/clerk within one year of the date of the marriage. This form must be completed by the officiant/person who performed the ceremony and must be submitted in person or by mail; original/wet signature required, electronic signatures are not acceptable.
